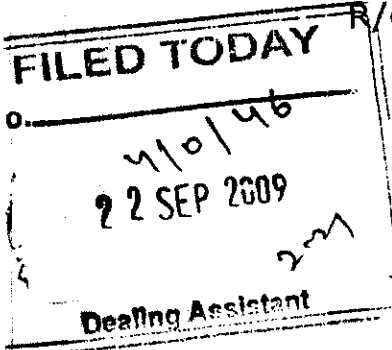

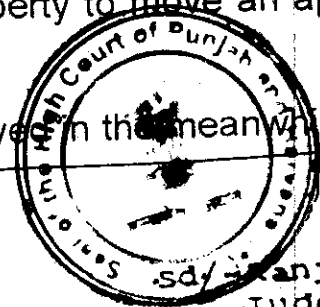
On the asking of Court, Mr.Harish Rathee, Sr.DAG,
