"Petitioner's challenge is to the Family Pension Scheme wherein parents were excluded from the definition of family.

This writ petition was admitted on **26.3.2004** and ordered to be heard along with CWP No. 4258 of 2003. That writ petition titled as <u>Parkash Devi vs. State of Haryana and others</u> regarding the same **issue dismissed** in terms of judgment of the Supreme Court in <u>State of Punjab v. Devinder Kaur</u>, J.T. 1999(10) S.C. 549. Issue involved in this case is the same. Accordingly this writ petition is also **dismissed** in terms of order passed in <u>Parkash Devi's case</u> (supra)"

P.V Pos 15/4/14 The refereeing judgement dated **05.07.2004** passed in CWP no. **4258 of 2003** - Parkash Devi vs. State of Haryana & others, quoted in the judgement dated **06.12.2013** is also reproduced as under:-

"Since the judgment of the Division Bench of this Court in Kharak Singh Kang's case (supra) vide which the order passed by the learned Single Judge striking down the definition of family excluding the parents from the ambit of Family Pension Scheme has been reversed by the Supreme Court, the petitioner's prayer for striking down the impugned Family Pension Scheme cannot be accepted and the consequential relief claimed by her for direction the respondents to pay family pension w.e.f 14.11.1998 cannot be entertained. Consequently, the writ petition is dismissed."

You are requested to take further necessary action in all such similar cases in light of the above stated judgment passed by the Hon'ble High Court.
