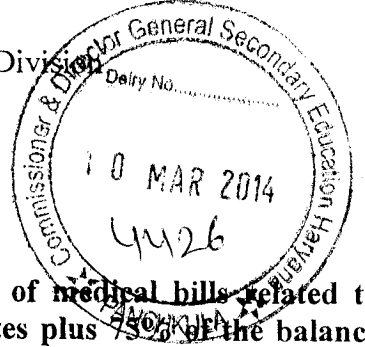

Subject: Regarding amendment in the rate of reimbursement of medical bills related to Drishti Eye Hospital, Sector-11, Panchkula at PGI rates plus 75% of the balance amount.

Sir

In continuation of the State Government, Health Department letter No.2/26/13-1HBIII dated 24-6-2013, according to which the Government had empanelled Drishti Eye Hospital, Sector-11, Panchkula subject to the condition that the medical bills related to the treatment of the Haryana Govt. employees/ Officers/ Pensioner and their dependants from this hospital will be reimbursed at PGI Chandigarh/AIIMS New Delhi rates only. Now the Government has decided to amend the instructions issued dated 24-06-2013 to the extent that now the medical bills related to the treatment of the Haryana Govt. employees/ Officers/ Pensioners and their dependants from this Hospital will be reimbursed at the rate of PGI Chandigarh/AIIMS New Delhi Plus 75% of the balance amount.

This Hospital will have to follow the following conditions:-

1. This hospital will remain empanelled for a period of 2 years at a time which can be renewed further by the Government keeping in view the performance and track record of the hospital. The period of 2 years will be determined from the date 24-06-2013
2. Health Department reserves the right to call for record of treatment of any patient from any empanelled hospital to ensure that no mal-practice takes place.
3. This empanelled hospital shall provide treatment to the employees in the event of a life threatening emergency without asking for deposition of the cost of treatment in advance. The patient shall pay the dues before discharge from the hospital. The hospital, however, shall verify the identity of the employee or his/her dependent to avoid impersonation.
4. This empanelled hospital shall maintain a record of the treatment of the patients under this policy in the format to be prescribed by the Health Department.
5. This Hospital will have to follow the package rates for procedures, implants, room rents etc. as prescribed by Government from time to time.
6. These rates of reimbursement as explained in this letter will be affective from the date of issue of this letter.
