

I am directed to invite your attention to the instructions issued by the General Administration Department vide its letter No. 22/10/2013-1GS-III dated 28.02.2013 on the subject noted above and to intimate that at page No. 4 of the above said instructions it has been mentioned "in the case of posts to be filled up by way of promotion the benefit of reservation should be given where the basis of promotion is seniority-cum-merit and the benefit of reservation should not be made available where promotion is to be given on the basis of seniority-cum-fitness".

It is observed that the above provision was withdrawn vide Government letter No. 22/2/87-3GS-III, dated 11.08.1988 and the same was referred in the letter No. 22/10/2013-1GS-III dated 28.02.2013, inadvertently. Thus, the above provision mentioned in the letter No. 22/10/2013-1GS-III dated 28.02.2013 at page no. 4 be treated as withdrawn.
