Relaxation of 5 years in upper age limit to Special Backward Classes and Economically Backward Persons in General Castes Category for entry in jobs under Government/ Government Undertakings and Local Bodies.

Sir,

I am directed to refer to the subject noted above. Keeping in view, the recommendations of the Haryana Backward Classes Commission set up by the Haryana Government, Jat, Jat Sikh, Tyagi, Ror, Bishnoi and Mulla Jats/Muslim Jat had been notified as Special Backward Classes and 10% reservation to these communities had been provided in exclusion to the communities already notified as Backward Classes. It was also decided that the said communities shall not be included in the 27 % reservation being provided to the Backward Classes. Further, it had also been notified that the Economically Backward persons in General Caste category be provided 10% reservation.

The State Government has decided that Special Backward Classes and Economically Backward Persons in General Castes Category may be given relaxation of 5 years in upper age limit for entry into jobs under Government/ Government Undertakings and Local Bodies.

It is requested that these instructions may be noted carefully for immediate compliance and amendment in the relevant service rules, wherever considered necessary, should also be made in accordance with the circumstances/conditions prevailing in each service under your control.

This decision shall come into force with immediate effect and shall have prospective effect only.

These instructions should be brought to the notice of all concerned for being adhered to strictly.
