



Whereas, Petitioners have filed the CWP No. 15906 of 2020 titled as Anju and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure -P5) qua the petitioners.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 5.10.2020 and the same was disposed of with following orders:-

“Accordingly, the present petition is disposed of in terms of the judgment passed by this Court in CWP No.13907 of 2020 titled as Rahul Sharma and another Versus State of Haryana and others. The petitioners are permitted to submit their respective representations against their transfers, if they are so aggrieved, within one week from today and in the event of receipt of such representation(s) by the respondents within the aforesaid period, the Grievance Redressal Forum of the department shall consider the case of the petitioners on their merits and in accordance with the guidelines/policy so formulated in the State of Haryana.

Meanwhile, status quo as on date as regard the posting shall remain in force for a period of one month from today.

Disposed of.”

In compliance of the abovementioned orders of the Hon'ble High Court the department has received various representations of different dates of the petitioner. Thereafter the case records of the petitioners were minutely examined and it was found that all the petitioners have common grievance like posting in anywhere category, contravention of Right to education Act and blockage of seats. It is pertinent to mention here that the petitioners were transferred in accordance with the Policy. All the petitioners opted stations according to their suitability and choices and have obtained score of 45.2356, 26.9351, 35.7123, 26.0384, 24.7288, 32.5671, 25.8274, 30.9151, 26.0411, 33.3205, 28.9671, 28.5342, 33.7836, 44.5616, 45.9644, 37.3504, 39.9863, 44.1643, 38.9342, 37.0274, 27.4685, 49.5233 and 27.5863 points respectively as per transfer policy. The petitioner no. 17 and 23 was allocated his preferred station at serial no 5 and 51 rest of the petitioners were transferred to the anywhere in the state Category. Thus the stations preferred by the petitioners were allocated to the them as per their merit and all the choices prior to the allocated choices of the petitioners were given to the employees higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department, due to the process of rationalization. The same was done for the purpose of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.as far as

the contention with regard to the applicability of the Right to Education Act is concerned the same is not applicable on the post of clerks and no teacher was forced to do the clerical work till date.

Whereas, the contention with regard to the personal problems of the petitioners are concerned, it is worth to mention here that there is no provision in the policy to provide additional marks to an employee who has some sort of family problems. As far the contention with regard to transfers in Corona period is concerned, the department has initiated the process of transfer only when the administrative work of the Government offices resumes.

Therefore, the petitioners have been rightly transferred by the department in strict compliance to the transfer policy. Hence, the representations given by the petitioners are hereby rejected, being devoid of merits

Whereas, Shri Shiv Charan [003988] the then Principal, Government Senior Secondary School, Khadalwa [2148], Kaithal now posted as Principal, Government Senior Secondary School, Salehpur [193] Yamuna Nagar was charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 25.11.2019/04.12.2019 and the following allegations were leveled against him:-

1. That Food items i.e. flour, rice and refined oil which were to be purchased were orally got approved from by him i.e. the school Management Committee Members but no guidelines for such procurement were made available by him i.e. Shri Shiv Charan to the Enquiry Officer. Demand for supply of food items such as flour, rice and refined oil, was submitted by hostel warden on 01.07.2017 which were allowed by him i.e. Shri Shiv Charan being Headmaster, Kasturba Gandhi Balika Vidyalaya (KGBV), Mataur, Kaithal on the same day but approval of the School Management committee was not obtained. The bill of the aforesaid items was prepared on 30.06.2017 before the demand submitted by Hostel Warden on 01.07.2017. Further, he i.e. Sh. Shiv Charan got prepared and passed the bill of procurement of food items from M/s Goyal Kariyana Store, Kalayat amounting to Rs. 24325/- and a cheque no. 647652 dated 11.07.2017 of Rs. 24325/- was issued for payment but the same was cancelled by him i.e. Sh. Shiv Charan when Smt Meenakshi, Accountant brought into the notice that aforesaid matter to higher authorities that payment of Rs 24325/- was being made to M/s Goyal Kariyana Store, Kalayat against the bogus bills of procurement and no such items were received in the school physically. As such, he i.e. Sh. Shiv Charan got prepared and obtained bogus bill from M/s Goyal Kariyana Store, Kalayat which proved from the fact that Bill No. 8 and 10 bearing dates 29.06.2017 and 09.07.2017 respectively although Bills No. 6 and 11 were issued on 30.06.2017 i.e. in back date which proved that bogus bills were prepared by him i.e. Shiv Charan in connivance of M/s Goyal Kariyana Store, Kalayat.
2. That Sh. Shiv Charan made payment of Rs 21370/- through cheque no 647655 dated 11.8.2017 to M/s Goyal Kariyana Store, Kalayat against different bills dated 30.06.2017, 09.07.2017 and 29.07.2017 i.e. (Rs 7445 + Rs 5255 + Rs 8670) against the quotations received on 29.07.2017 against aforesaid bills. Further, these quotations were signed by only two members, instead of all the four members of committee or majority of the members. Thus, Sh. Shiv Charan violated the provisions of financial Rules".

The delinquent submitted his reply dated 20.02.2020 to the charge sheet and denied the allegation leveled against him. It was submitted in the reply that he had cheque no. 647652 dated 11.07.2017 was signed by him in good faith but the same was cancelled by him being not found in order. Apart from this, he leveled serious allegation of demanding bribe amounting to Rs 10,000/- on Shri Sunil Dutt, AO, SSA/Kaithal.

The reply of the delinquent was not found satisfactory. Resultantly, Shri O P Langyan, IAS (Retd) was appointed as Inquiry officer vide order dated 07.07.2020/15.07.2020 to conduct regular departmental enquiry and report dated 22.06.2020 was submitted by him wherein charges leveled against her were not found proved.

Keeping in view the above said facts and finding of Inquiry Officer, The Governor of Haryana is pleased to file the present charge sheet against Shri Shiv Charan [003988], Principal.
