ORDER No. 5/128-2011 HRG-I (1)

Dated, Chandigarh, the 10/11/2020

Whereas, Shri Satyavir Singh [065934] the then Principal, Government Senior Secondary School, Bassai [3860] (Mahendergarh) was charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 repealed in 2016 on 29.02.2012 and the following allegations were leveled against him:-

- "1. Sports material has been purchased manifold at the rates prevalent in the market. Volleyball has been purchased at the rate of Rs. 1000/- per ball whereas the print rate was Rs. 395/-. Further, a cricket mat measuring 66 ft. x 8' ft. length was purchased in GSSS Pali, Mahendergarh @ Rs. 9,700/- from the same firm. In addition, the said amount has not been shown in the cashbook.*
- 2. No demand was sought from PTI and DPE. In addition, no purchased committee was formed and no quotations were sought after the financial sanction was issued on 28.03.2011 and 30.03.2011 and comparative statement was prepared on the basis of quotation sought on 24.03.2011. Hence, the same appears to be bogus."*

The delinquent submitted his reply dated 21.05.2012 to the charge sheet and denied the allegations leveled against him. He did not perform anything except that he took the supplied material into custody and received a cheque of Rs 1,08,258/- from the then District Education Officer, Mewat which was issued in the favor of supplier as per directions of District Education Officer, Mewat

The reply of the delinquent was not found satisfactory. Resultantly, Shri R P Bajaj, District & Session Judge (Retd) had appointed as Inquiry officer vide order dated 18.05.2015 to conduct regular departmental enquiry. The Inquiry Officer submitted his report dated 04.10.2015 wherein charges leveled against him were not found proved. The operative part of finding of Inquiry officer is reproduced as under:-


" In the result this enquiry is concluded with the findings that the delinquent had not made the purchases of sports material and the irregularities, if any, were not committed by him. He simply signed the cheque in favor of the supplier under pressure of his immediate superior, the then DEO Mewat. The delinquent is thus exonerated of the charge".

Thereafter, being unsatisfied with report of Inquiry Officer, a dissenting note dated 21.11.2016 was served to the delinquent by the competent authority as the Inquiry Officer had not examined the matter properly and comments of the delinquent were sought. The delinquent has submitted reply to the dissenting note on 28.11.2016 and reiterated that he had not made any procurement and all action taken by Smt. Suman Nain the then DEO Mewat. It has been fairly mentioned in reply by the delinquent that the cheque he issued was got bounced, as sufficient funds were not available and DEO Mewat deposited the funds from her account for the clearance of the cheque.

Keeping in view the above facts, finding of Inquiry Officer and reply to dissenting note, it is found that the delinquent had only received the sports material on the direction of the then District Education Officer, Mewat i.e. Smt.

Suman Nain. Moreover, the cheque issued by the delinquent was bounced and thereafter, the final payment was made by the then DEO, Mewat by depositing amount in the above said cheque. Therefore, the Governor of Haryana is pleased to file the present charge-sheet against Sh. Satyavir Singh, the then Principal (Retd.) GSSS, Bassai (Mahendergarh).

It is ordered accordingly.

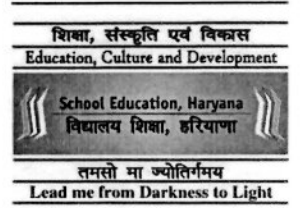

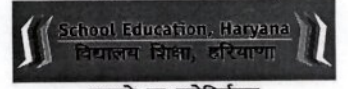

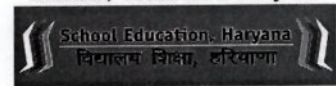

That Smt. Sunita Goswami, PGT Lecturer Home Science has filed the present CWP No. 12293 of 2020 before the Hon'ble High Court for issuance of a writ in the nature of Mandamus for directing the respondents to allow the petitioner to proceed on Child care Leave.

That the above mentioned writ petition was disposed of on 20.08.2020 by the Hon'ble High Court and the operative part of the order is reproduced here as under:

"This civil writ petition under Articles 226/227 of the Constitution of India has been filed by petitioner - Sunita Goswami, aged about 28 years, wife of Suresh Kumar, working as PGT (Home Science) at Government Girls Senior Secondary School, Mangali, Hisar against State of Haryana through its Addl. Chief Secretary to Government of Haryana, Department of School Education, Haryana Civil Secretariat, Chandigarh, Department of Secondary Education Haryana, District Education Officer, Hisar, Block Education Officer, Hisar and Principal, Government Girls Senior Secondary School, Mangali, Hisar, craving for issuance of a writ in the nature of mandamus for issuing directions to respondents to allow the petitioner to proceed on child

care leave since her daughter needs intensive care being 19 months old.

Learned counsel for the petitioner has contended that the petitioner had submitted a representation Annexure P1 to the Principal, Government Girls Senior Secondary School, Mangali (Hisar) in that regard, without eliciting any response. Learned counsel for the petitioner has referred to the orders passed by this Court in CWP-2689-2020 and in CWP-14141-2019 under similar circumstances.

Notice of motion.

Mr. Rajiv Sidhu, DAG, Haryana, accepts notice on behalf of respondent - State.

Learned counsel for the petitioner has contended that the petitioner would be satisfied if a direction is issued to respondents to consider her request as contained in her representation Annexure P-1 and more comprehensively detailed in the present writ petition within a fixed time frame.

Learned State counsel submits that the respondents would do so as per the directions issued by this Court.

In view of such request of learned counsel for the petitioner and response given by the State counsel and further to avoid any unnecessary litigation between the parties, the present petition is disposed of directing the respondents to consider the request/claim of the petitioner as contained in her representation Annexure P-1, more comprehensively detailed in the writ petition

along with annexures, which be also considered as a representation and to decide the same in accordance with law, by way of a speaking order within a period of four weeks from today.

However, if the petitioner still feels aggrieved even after passing of the order, she may seek her legal remedy including approaching this Court as per law.”

That in compliance of order dated 20.08.2020, the representation/record of the petitioner has examined and after examining the record and keeping in view the age of petitioner's child, petitioner has been granted Child Care Leave for 184 days i.e from 02.07.2020 to 01.01.2021 in furtherance of Finance Department Instructions dated 05.02.2010 and 05.11.2012 vide order no. 20/191-2019 PGT-II (3) dated 24.08.2020. However, the petitioner cannot claim Child Care leave as a matter of right as it is an administrative matter to allow or to deny Child Care leave after considering all facts and circumstances of the case.
