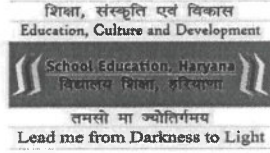

Whereas, Shri Jitender Gaur [042098], Principal, GSSS Nindana [2669], Rohtak was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 09.03.2020/19.03.2020 and the following allegation was leveled against him:-

*"That Shri Jitender Gaur was very much aware of the gravity of the court case matter as the Director Elementary Education, Haryana, Panchkula had appeared in CM NO. 10632 of 2019 in CWP No. 3490 of 2016 titled as Phoolwati versus State of Haryana on the last date of hearing i.e. 19.09.2019 before Hon'ble Punjab and Haryana High Court and said case was listed for hearing on 27.09.2019 at Serial Number 101 in the Hon'ble Court room number 28. Further, Shri Jitender Gaur had to handover the affidavit to the Additional Advocate General, Haryana at 9.30 AM but he reached at 12.30 PM and the Hon'ble Court took serious view of the matter which could result into personal appearance of the Principal Secretary, Government of Haryana, School Education Department Chandigarh as well as the Director Elementary Education, Haryana, Panchkula along with any adverse orders. As such, Shri Jitender Gaur, took very casual approach in the matter by reaching the Hon'ble Punjab and Haryana High Court late by more than 3 hours and failed to attend the phone calls of Shri Jasvinder Singh Gill, Deputy District Attorney Office of Director Elementary Education, Haryana, Panchkula".*


The delinquent submitted his reply dated 01.02.2020 to the said charge sheet and denied the allegation leveled against him. He stated in his reply that he boarded the bus from Rohtak at about 4.20 am to reach Chandigarh and the bus was expected to reach Chandigarh at about 9.00 am as usually it takes about 4 hours and 30 minutes in the morning to reach Chandigarh by bus. However on the way, it started raining very fast and became difficult for the bus driver to drive. Apart this, there was a big traffic jam and bus reached at bus-stand Sector-17, Chandigarh at about 10.30 am. It was further stated in the reply that he was never asked to be present in the Hon'ble Court at 9.30 AM but he tried his best to be present in the Court at right time.

The reply of the delinquent was not found satisfactory. Resultantly, Shri R.P.Bhasin, District & Session Judge (Retd) was appointed as Inquiry officer vide order dated 13.03.2020/19.03.2020 to conduct regular departmental enquiry and report dated 07.07.2020 was submitted by him wherein charges leveled against him were proved. Subsequently, the findings dated 07.07.2020 of the Inquiry officer were conveyed to the charged officer on 24.07.2020/10.08.2020 under rule 7(C)(I) awarding opportunity of 30 days to

make representation on the findings of Inquiry Officer . The charged officer made his representation dated 02.09.2020 and denied the findings of the Inquiry Officer. On perusal of enquiry report and reply of the delinquent, it is found that Sh. Jitender Gaur took the court case in very casual manner and did not attend the Hon'ble Court on time and also failed to handover the affidavit to concerned Assistant Advocate General on the date of hearing i.e. 19.09.2019. Further, defense of the delinquent is not tenable and seems to be after thought.

Keeping in view the above said facts, report of Inquiry Officer and reply of the delinquent, the Governor of Haryana is pleased to convert the present charge sheet to rule -8 of Haryana Civil Services (Punishment & Appeal), Rules, 2016. Since the charges have been proved against the delinquent officer, a punishment of stoppage of two increments without cumulative effect is inflicted upon him

**Order No. 13/38-2020 PGT-IV (1)      Dated, Panchkula, the 13-11-2020**

Whereas, Sh. Dinesh Kumar has filed the present CWP No. 29854 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of certiorari for quashing of transfer orders dated 22.08.2019 and 13.09.2019 (Annexures P-5 and P-6). Wherein the petitioner has been transferred from Block Siwani, District Bhiwani to Block Rania, District Sirsa and then Block Rania District Sirsa to Block Sirsa, District Sirsa. Further to issue any other writ, order or direction which this Hon'ble court may deem fit in the facts and circumstances of the case.

The petition was disposed of by the Hon'ble High Court on 17.10.2019, the operative part of the order dated 17.10.2019 is reproduced here as under:-

***“Prayer in the present writ petition is for quashing of impugned transfer orders dated 22.08.2019 and 13.09.2019 (Annexures P-5 and P-6).***

***Petitioner has been transferred from Block Siwani, District Bhiwani to Block Rania, District Sirsa and then Block Rania District Sirsa to Block Sirsa, District Sirsa. The impugned orders are dated 22.08.2019 and 13.09.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt***

*of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.*

*With aforesaid direction, the writ petition stands disposed of.”*

Whereas, the Government of Haryana has framed the **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of Teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy, all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the districts in the State. He/She is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek his/her transfer to some other station and on the other hand the following categories of teachers have been asked to participate in the transfer drive compulsorily:-

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in the present zone of posting, shall be taken as a deemed vacancy and such teacher shall participate compulsorily in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also participate compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or

technical problem or compulsion of administrative or litigational nature.

That in compliance of the orders passed by the Hon'ble High Court an opportunity of personal hearing was accorded to the petitioner on 15.10.2020 through video conferencing due to Covid-19 situation and the petitioner had stated his grievances regarding transfer. Whereas, the case of the petitioner has been examined as per the record and it was found that as per the MIS Portal of petitioner Sh. Dinesh Kumar (5015521), PGT Chemistry, he was compulsory participant for General Transfer Drive of PGTs in the year of 2019, as earlier he was adjusted on temporary basis on his fresh appointment with a condition that he has to take part in next transfer drive for his permanent posting. Therefore, he had participated in General Transfer Drive of PGT in year 2019 and had filled 58 preferences, but all of his preferences were allocated to other teachers obtaining higher points than him. He was transferred to GSSS, Chakkan, Block Rania in District Sirsa (2821) under 'Anywhere Category' with 32.4767 points. The 58<sup>th</sup> station was allocated to some other teacher namely Sh. Jitender Kumar having 56.6247 merit points. He also took part in Grievance Redressal Drive and got choice posting in 'Preferred School' i.e. GSSS, Suchan in District Sirsa. Hence, there is no violation of Teacher's Transfer Policy, 2016 in case of his transfer/posting. The petitioner further made a request for allowing him to participate in the incoming transfer drive, a general decision in this regard will be taken in accordance with the policy.

In view of the position explained above, it is clear that the petitioner has been transferred as per the provisions of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no



substance in the claim of the petitioner and the same is liable to be dismissed, being devoid of any merits.

I order accordingly.
