



Whereas, you namely, Sh. Bhushan Kumar (039612), has been promoted as Elementary School Head Master vide office order dated 24.08.2019. Presently, you are working as Elementary School Head Master at Government Senior Secondary School Matt Dadu, Sirsa (2871). It is brought into your notice that a civil writ petition No. 23598 of 2019-Sanjay Kumar V/s State of Haryana & Others was filed by Sh. Sanjay Kumar (031679) praying therein for quashing the impugned order no. 15/32-2019-HRM-III (1) dated 24.08.2019 (Annexure P-7) qua the promotion of candidates passed by Director Elementary Education, Haryana whereby persons junior to the petitioner have been ordered to be promoted on the post of Elementary School Head Master in HES-III School Cadre.

The said petition came up for hearing before the Hon'ble High Court on 24.11.2020 and the Hon'ble High Court passed an interim order, the operative part is as under:

*"Matter has been taken up through Video Conferencing via Webex facility in the light of the COVID-19 situation and as per instructions.*

*Petitioner, who is serving as a Punjabi Teacher (C&V Cadre) under the Department of Education, State of Haryana, is aggrieved of the action of the respondent authorities in not having granted to him benefit of promotion to the post of Elementary School Head Master even though his juniors namely, Bhushan Kumar and Kuljeet Kaur, both Punjabi Teachers (C&V Cadre), have been so promoted vide order dated 24.08.2019 (Annexure P-7).*

*In the written statement filed on behalf of the State the factual premise as regards the juniors have been promoted stands conceded. A stand has been taken that only such Punjabi Teachers have been considered for promotion whose regular date of appointment was upto 22.04.1998.*

*The appointment letter of the petitioner along with other candidates has been placed on record at Annexure P-1. The appointment order was issued on 22.04.1998 and it clearly recites that the appointments have been made upon the recommendation of the Haryana Staff Selection Commission and in compliance with the Director of Secondary Education Haryana Chandigarh letter dated 10.04.1998. Name of the petitioner figures at Sr.No.8 in such appointment order. The contents of letter dated 22.04.1998 (Annexure P-1) are not disputed on behalf of the State.*

*"Prima facie the stand being taken on behalf of the State to deny the petitioner promotion to the post of Elementary School Head Master w.e.f. 24.08.2019 at par with his juniors namely, Bhushan Kumar and Kuljeet Kaur cannot sustain.*



***At this stage, Mr.Saurabh Mohunta, learned Deputy Advocate General, Haryana seeks time to complete instructions as also for the respondent authorities to reconsider the entire issue and take necessary remedial steps.***


***List on 21.12.2020."***

That after receiving the said order of the Hon'ble High Court, your promotion case has been re-examined carefully in the light of court directions and it has been found that as per record your name was recommended by Haryana Staff Selection Commission as Punjabi Teacher in C&V cadre on 10.04.1998. Thereafter, you were offered appointment by District Education Officer, Sirsa on 16.05.1998 (attached with promotion case). The department had promoted yourself to the post of Elementary School Head Master keeping in view of your date of recommendation i.e. 10.04.1998 instead of date appointment i.e. 16.05.1998 inadvertently. However, the department had promoted Punjabi Teacher to the post of ESHM upto 22.04.1998 taking into consideration their date of appointment & length of continuity in service. Whereas, your date of initial appointment is 16.05.1998 which is later than 22.04.1998. Hence, you are not found suitable for promotion to the post of Elementary School Head Master. It is specifically mentioned in your promotion order under condition 1 and 2 at page No. 80 which is as under:-

1. That these promotions are subject to review/cancellation, in case of any discrepancy regarding eligibility is found at later stage.
2. That these promotion orders are without prejudice to the right of the seniors, if any whose promotion cases may be decided at a later stage.

Keeping the above mentioned facts in view, an opportunity for representation is being provided to you through this Show Cause Notice. This Show Cause Notice is hereby issued to explain/show cause as to why you may not be reverted from the post of Elementary School Head Master to your feeder post in the light of above mentioned facts. You are requested to submit your representation, if any, within 15 days after receiving this order. Otherwise, final order shall be passed accordingly, as, it was clearly mentioned in your promotion order dated 24.08.2019 at condition No. 5 on page No. 81 "that these officials should fulfill the conditions of education qualification/experience as per the service rules. In case it transpires at a later state that they are ineligible for the above promotion, the department would be competent to revert the concerned officials to their original post without any notice".

- [1] Learned counsel for the petitioner states that the two-fold prayer in the writ petition is for the issuance of a writ of Mandamus for directing the respondents to promote the petitioner as a Social Studies Teacher w.e.f. 01.12.2010 along with all consequential benefits as also follow up promotion as PGT (English) and secondly, for the issuance of a writ of Mandamus for directing the respondent to promote the petitioner as Elementary School Headmaster w.e.f. 03.05.2016 along with all consequential benefits.*
- [2] Learned counsel for the petitioner states that although the respondents have filed reply admitting the claim of the petitioner for promotion as Social Studies Teacher w.e.f. 01.12.2010 and have promoted the petitioner as such along with all consequential benefits, however, further claim for promotion of the petitioner as PGT (English) as follow up and for promotion to the post of Elementary School Headmaster w.e.f. 03.05.2016 along with all consequential benefits has not been considered and decided till date.*
- [3] Learned counsel states that in the circumstances, the petitioner would be satisfied if the writ petition is disposed of at this stage by directing the respondents to consider and decide the claim of the petitioner for promotion to the post of PGT (English) as also to the post of Elementary School Headmaster with effect from the due date in accordance with law.*
- [4] Learned Sr. DAG states that he has no objection to the aforementioned directions being issued.*
- [5] In view of the statement of learned counsel for the parties, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim of the petitioner for promotion to the post of PGT*

***(English) and Elementary School Headmaster with effect from the date claimed by the petitioner as also consequential benefits thereto in accordance with the rules and regulations applicable as expeditiously as possible, preferably within a period of four months from the date of receipt of certified copy of this order".***


That after receiving the said court direction from the Hon'ble High Court, the matter of Sh. Suman Kumar has been examined carefully and it has been found that the he was initially appointed as Drawing Teacher (C&V) on Government Middle School, Khilila, Pahladpur District Panipat vide order dated 30.10.2000. Thereafter, he was promoted as SS Master vide order No. E-4/17/1804-08 dated 08.08.2017 and he had joined as TGT/Master Social Studies in Government Middle School, Rasina, District Kaithal on 08.08.2017.

It is pertinent to mention here that the promotion case of TGTs has been considered upto seniority No. 2700 for general category and upto seniority 10,000 for reserve category by the Directorate as per seniority stood on 01.01.2017. The promotion cases of TGT/Master cadre are considered upto seniority No. 2700 for general category on the basis of seniority-cum-merit basis of the respective employees whereas the seniority No. of Sh. Suman Kumar in this cadre has been mentioned as 10296.

Besides above, the case of Sh. Suman Kumar has been examined by the competent authority. It has been found that, the promotion case of Sh. Suman Kumar will be considered on his turn as per his respective seniority.

Keeping in view the matter explained above, Sh. Suman Kumar cannot be promoted as Elementary School Head Master and his claim is rejected in above term and in compliance of the Hon'ble High Court direction.
