The case of the petitioner has been examined and it was found that the applicant himself voluntarily participated in the Teachers Transfer Drive, 2019 and was transferred as per the marks given to him as per the criteria prescribed in the policy, apart from that as per his contention with regard to non-availability of the seats is concerned, it is pertinent to mention here that the same were blocked by the department through the process of rationization/ normalization for the benefit of the maximum number of students in the state of Haryana and has been done as per the policy. Further it is pertinent to mention here that the petitioner participated in the General Transfer Drive, 2019 duly within purview of the Teacher Transfer Policy, 2019 as amended on 01.06.2017.

That as per the MIS record he had obtained a score of 50.5918 and was allotted 25th preferred station i.e. GSSS, Patli Station, Gurugram and the last preferred station was allotted to other teacher namely Sh. Hirender Singh who had obtained score of 52.3507 which was higher than the petitioner. Thus, the petitioner was allocated station under 'Preferred School Category'. Moreover, the applicant cannot blow hot and cold at the same time, on the one hand he has voluntarily participated in the teachers transfer drive and on the other hand he claims the same to be wrong.

In view of the position stated *Supra*, it is clear that the petitioner has been transferred as per the provisions of the Teachers Transfer Policy, 2016 (as amended from time to time) and there is no substance in the representation dated 30.09.2019 of the petitioner and as such the same is liable to be rejected.

I order accordingly.
