Whereas, the petitioners namely Sunita and others have filed the CWP No. 14150 of 2020 titled as Sunita and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for quashing the impugned transfer order dated 14.08.2020 qua the petitioners

The above said CWP came up for adjudication before the Hon'ble High Court on 08.10.2020. The operative part of the same is reproduced as follows:

***“Be so as it may, the present petition stands disposed off with the directions to the petitioner to first make representation to the respondents within week from today regarding relief being claimed in this petition and upon doing so, the respondents will consider and dispose off the same, by a speaking order preferably, within the period of one month upon receipt of copy of the said representation, in accordance with law and which would be conveyed to the petitioner.***

***Till the disposal of the representation, the transfer order shall not be implemented.***


***Disposed of.”***

In compliance of the order passed by the Hon'ble High Court the representation dated 15.10.2020 of the petitioner was minutely examined and it has been found that at the time of participation in

the transfer drive all the petitioners were opted the stations according to their suitability and choices and opted for 68, 294, 208, 195, 109, 159, 154, 89 & 115 stations respectively. The petitioner no. 1-10 have got the merit points of 40.8137, 30.8027, 28.9288, 30.0493, 32.7534, 28.4021, 26.9096, 34.1681, 34.4137 and 36.0848 points respectively. But due to less merit points, nine out of 10 petitioners were transferred in '**Anywhere in the State**' category. Whereas Hem Chander got his 38<sup>th</sup> preferred station and in case of other nine, the preferred stations of the petitioners were given to the employees higher in merit than the petitioners in strict compliance of the policy. Thus the petitioner has got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas, the contention with regard to the blockage of seats is concerned the same has been done due to the process of rationalization. Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department. The same was done for the purpose of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, the contention with regard to the Right of Education is concerned the same is not applicable to the post of clerks. Moreover, no teacher was forced to do the clerical work till date & the petitioners have no cause of action to challenge the same. As far as the contention with regard to transfers in the present condition



due to covid-19 is concerned, the same has been done after resuming the work in the government offices.

Whereas, the contention with regard to the personal problems of the petitioners is concerned, there is no provision in the policy to provide additional marks to the persons having such kind of problems.

Therefore, the petitioners have been transferred through online mode by the department in strict compliance to the transfer policy. Hence, the representation made by petitioners is hereby rejected, being devoid of merits



Whereas, Petitioners have filed the CWP No. 14614 of 2020 titled as Dharamender and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure -P1) qua the petitioners.

The above said Civil Writ Petition came up for adjudication on 17.09.2020 and the Hon'ble Court disposed of the same vide order dated 17.09.2020. The operative part of the order is reproduced as under:

***“ 7. The petitioners have already submitted representation Annexure P/4 (collectively) qua their grievance to the competent authority in terms of Clause 6(vii) of the Transfer Policy, Annexure P/2.***

***8. Accordingly, without commenting upon the merits of the controversy or the entitlement of the petitioners to the relief claimed, the writ petition is disposed of by directing the competent authority to decide the representation Annexure P/4 (collectively) in terms of Clause 6 (vii) of the Transfer Policy, Annexure P/2, within ten days of date of receipt of***

***certified copy of order after taking into account all aspects of the matter.”***

In compliance of the abovementioned orders of the Hon'ble High Court the case records of the petitioners were minutely examined and it was found that all the petitioners were transferred in accordance with the Policy. All the petitioners opted stations according to their suitability and choices and have obtained score of 31.9973, 28.9836, 31.0027, & 34.9671 respectively as per transfer policy. The petitioners have successfully allocated their preferred choices/station numbered at 137, 249, 258 & 45 respectively. Thus the preferred stations by the petitioners were allocated to the them as per their merit and all the choices prior to the allocated choices of the petitioners were given to the employees higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, Chief Secretary to Government of Haryana, has made amendments in the online transfer Policy on 07.08.2020. But the transfer for the clerks was started before the issuance of this letter dated 07.08.2020 and even then the general principals of the letter dated 07.08.2020 were adopted by the department in the interest of justice.

Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper

utilization of the manpower available with the department, due to the process of rationalization. The same was done for the purpose of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Therefore, the petitioners have been rightly transferred by the department in strict compliance to the transfer policy. Hence, the representation annexed by the petitioners in the Civil Writ Petition is hereby rejected, being devoid of merits

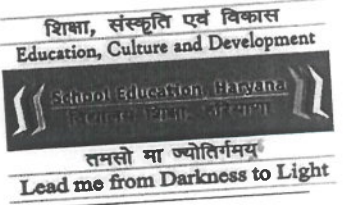
