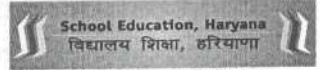

ORDER

On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No.HSSC/Confid./Recomm/2019/731 dated 08.11.2019, the Governor of Haryana is pleased to appoint the following candidates as Post Graduate Teacher Computer Science (HES-II) (Rest of Haryana cadre) in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600 – 1,51,100/- plus usual allowances as admissible from time to time. She is directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. He/She shall have to take an oath of allegiance to the Constitution of India.
3. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
4. He/She shall not be allowed to apply for any post outside the department for a period of at least five years.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostats self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.
15. The appointment will be subject to the final outcome of CWP No. 18514 of 2016 & connected petitions pending for adjudication in the Hon'ble High Court and SLP No 25184-25214 of 2018 titled as

Haryana Staff Selection Commission etc V/S Priyanka & Others pending for adjudication in the Hon'ble Supreme Court of India.

16. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
17. They are directed to join their place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.

Terms & Conditions:

1. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is found pending subsequently, the said incumbents(s) shall be reverted without issuing any notice.
2. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
3. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.
4. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.5.2006.
5. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
6. This promotion order is based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT (English)** provided those seniors are found eligible for the post.
7. In case the degree of a teacher is found not to be from a recognized University having no statutory authority/ jurisdiction in regard to award of such degree,

the promotion shall be cancelled forthwith and the teachers so promoted shall be liable for strict disciplinary action.

8. The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and, posts have been reserved for them pending determination of their eligibility at a later date.
9. Inter se seniority based on the feeder cadre shall be the determining factor in the PGT cadre. In other words if a senior employee in the C&V cadre is found eligible at a later date and vacancy in respect of her is occupied by a junior employee then the Junior employee shall have to be reverted back so that such senior employee may get her due promotion.
10. She will remain on probation for a period of one year which can be extended in terms of Service Rules, in case her work and conduct is not found satisfactory.
11. The promotion is subject to final outcome of decision(s) of CWP No. 9675 of 2016 titled as Sumer Singh V/s State of Haryana.
