हरियाणा सरकार ने वित्त विभाग के अशा0 क्रमांक 14/01/2020-1 बी0एण्ड0सी0 दिनांक 07.04.2020 की पालना में प्रशासकीय विभाग के यादी क्रमांक 2/62-2020 Works (1) दिनांक 18.09.2020 के प्रसंग के अर्न्तगत व्यवस्थित 18000.00 लाख रुपये की राशि खर्च करने की प्रशासकीय स्वीकृति जारी की गई है। इस स्वीकृत राशि से निम्नलिखित विद्यालयों को उनके समक्ष अंकित कार्य हेतु प्रस्तावित राशि सरकारी खजाने से निकलवाकर खर्च करने की अनुमति प्रदान की जाती है:-

स्कीम मे यह राशि खजाने से निकलवाकर निर्माण/मुरम्मत/अलटरेशन इत्यादि के कार्य के लिये गठित कमेटी एवं जिला शिक्षा अधिकारी की देखरेख में करवाया जाए। राशि खर्च करने की अनुमति निम्नलिखित शर्तों पर प्रदान की जाती है:-

- 1 सभी प्रकार का खर्च सरकार की हिदायतों/नार्म तथा नियमानुसार सक्षम प्राधिकारी के अनुमोदन से ही करना होगा।
- 2 निर्माण का कार्य लोक निर्माण विभाग के स्पैशिकेशन के आधार पर करना होगा।
- 3 सरकार की हिदायतों यादी क्रमांक 23/42/91 शि-III(2) दिनांक 19.12.91 तथा यादी क्रमांक 2/43-2006 दिनांक 31.01.2007 की दृढता से पालना करनी होगी तथा इन्ही हिदायतों के अनुसार कमेटी गठित करके तथा कमेटी की देख रेख में निर्माण कार्य करवाना होगा।
- 4 विद्यालयों के भवनो के निर्माण/मुरम्मत/अलटरेशन इत्यादि कार्य शीघ्र करवाकर उपयोगिता प्रमाण पत्र संबंधित मुखिया/प्रधानाचार्य व एस0एम0सी0 कमेटी के हस्ताक्षर करवाने उपरान्त गये कार्य की फोटो सहित जिला शिक्षा अधिकारी के प्रतिहस्ताक्षर प्राप्त करके तत्काल निदेशालय को भेजना होगा। कार्य करवाने उपरान्त शेष उपलब्ध राशि यदि हो तो उसे तुरन्त खजाने में चलान द्वारा जमा करवा कर निदेशालय को उपयोगिता प्रमाण पत्र के साथ भेजे।
- 5 जब तक इस राशि का उपयोगिता प्रमाण पत्र निदेशालय में प्राप्त नहीं होता है तो भविष्य में उस विद्यालय को अगली राशि की स्वीकृति प्रदान नहीं की जायेगी।



**Order No. 13/149-2020 HRME- I(4)Dated, Panchkula, the 5.10.2020**

Whereas, the petitioner namely Mrs. Nitin has filed the CWP No. 13707 of 2020 titled as Nitin Vs. State of Haryana & Other before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature of certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure P-1) passed by respondent no. 2, whereby the petitioner has been transferred from Sonapat to Yamuna Nagar (more than 150 Kms), in the interest of justice.

The above said CWP came up for adjudication before the Hon'ble High Court on 07.09.2020 which was disposed of with the following order:

***"In view of the fact that the petitioner has already joined the post to which she was transferred, therefore it would be just and appropriate to direct respondent No.2 to treat this writ petition as a representation and take final view on the matter, in accordance with law and also in view of facts and circumstances of the case.***

***It would be appreciated, if the decision is taken in the matter by respondent No.2 within a period of three weeks from the date of receipt of certified copy of this order along with copy of writ petition.***

***The writ petition is disposed of accordingly."***

In compliance of the order dated 07.09.2020 passed by the Hon'ble High Court of the petitioner was minutely examined and it has been found that the petitioner has compulsory participated in the online transfer drive and petitioner has opted for 34 stations and has obtained the age score of 29.5205 points and she got additional 10 points for the female candidate as well as 5 additional points for couple case as such her total considered points are 44.5205, as per transfer policy. The 34<sup>th</sup> preferred station i.e. the last preferred station by the petitioner was allocated to namely Sanjay who obtained score of 46.5549 Points. The petitioner was transferred to ***Anywhere in the State*** category due to non-availability of preferred stations as the same were allotted to the employees higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, Chief Secretary to Government of Haryana, was made amendments in the online transfer Policy on 07.08.2020. But the transfer for the clerks was started before the issuance of this letter dated 07.08.2020. as such the same is not applicable on the online transfer drive for clerks, even then the general principals of the letter dated 07.08.2020 were adopted by the department in the interest of justice.


Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department, due to the process of rationalization. The same was done for the purpose

of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Therefore, the petitioner has been rightly transferred by the department in strict compliance to the transfer policy. Hence, the representation made by petitioner is hereby rejected, being devoid of merits.

Whereas, Director Secondary Education, Haryana is on long leave, keeping in view the urgency of the matter and non availability of Director Secondary Education. I, being the appointing authority of the Clerks substitute the speaking order bearing same number and date accordingly.

I order accordingly.


