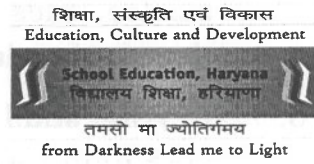

ORDER

In compliance of order dated 23.01.2020 passed by the Hon'ble High Court in COCP No. 1893 of 2020 in CWP No. 40483 of 2018 titled as Sombir V/s State of Haryana and others, on the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Confid./Recomm/Court Case/2020/517 dated 12.10.2020, in pursuant to advt. No. 4/2015, Category No. 03, the Governor of Haryana is pleased to appoint Sh. Sombir as Post Graduate Teacher **Commerce** (HES-II) (Rest of Haryana cadre) in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time. He is directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. He/She is appointed purely on temporary basis.
2. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant

service rules and instructions of the State Government issued from time to time later on.

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.

15. The appointment will be subject to the final outcome of CWP No. 18514 of 2016 & connected petitions pending for adjudication in the Hon'ble High Court and SLP No 25184-25214 of 2018 titled as Haryana Staff Selection Commission etc V/S Priyanka & Others pending for adjudication in the Hon'ble Supreme Court of India.
16. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
17. They are directed to join their place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.

Statement of allegations against Shri Ram Phal Dhankar [065935] the then District Elementary Education Officer (now under suspension).

While being posted as District Elementary Education Officer, Sonapat from 08.02.2020 to 09.03.2020, Shri Ram Phal Dhankar committed following acts of omission and commission:-

That the Superintendent of Police, State Vigilance Bureau, Rohtak, intimated through email dated 11.03.2020 that a FIR NO. 3 dated 09.03.2020 under sections 7 Prevention of Corruption Act, 1988, Police Station, State Vigilance Bureau, Rohtak against him i.e. Shri Ram Phal Dhankar and his clerk i.e. Shri Pawan Kumar, was registered and as such following irregularities were found to be committed on his part i.e. Shri Ram Phal Dhankar:-

1. That he i.e. Ram Phal Dhankar forced the complainant Smt. Meena Kumari Wife of Shri Narender, Village and Post Office Kathura, Tehsil Gohana (Sonapat), to pay the bribe of Rs 3,00,000/- through his subordinate i.e. Shri Pawan Kumar, Clerk for the sake of forwarding the case for inspection of permanent recognition upto 8th class of her school i.e. Kids Valley Convent School of the complainant. Further, he i.e. Shri Ram Phal Dhankar failed to pay any heed to the requests of the complainant to forwarded her file i.e. the complainant to next level with malafide intention and kept pressurizing the complainant to meet Shri Pawan Kumar, Clerk. Apart from this, he i.e. Shri Ram Phal Dhankar fled away from the office on 09.03.2020 knowingly when the Vigilance Team conducted the raid and also failed to join the investigation. Resultantly, a FIR NO. 3 dated 09.03.2020 under section 7 Prevention of Corruption Act, 1988, Police Station, State Vigilance Bureau, Rohtak, was registered against him i.e. Shri Ram Phal Dhankar. Thus, he i.e. Shri Ram Phal Dhankar dented the dignity of the department by his acts and conduct.
2. That he i.e. Shri Ram Phal Dhankar remained willful absent from duty from 09.03.2020 to 22.05.2020 without any intimation to the competent authority.

In this way, he i.e. Shri Ram Phal Dhankar committed an act unbecoming of a Government officer by performing his duty with malafide intention in a negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Shri Ram Phal Dhankar the then District Education Officer, Sonapat [now under suspension] rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016.

Whereas, Smt. Parmeshwari Hooda [037069], District Education Officer, Rohtak (now retired on 31.05.2020) was charge-sheeted under rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/179-2019 HRG-I (2) dated 10.01.2020/20.01.2020 and the following allegations were leveled against her:-

"That she made the internal adjustment vide letter No. E-1/19/891-96 dated 30.09.2019 of Smt. Richa Mohan, PGT Biology, GSSS Nindana (Rohtak) to GSSS Ismaila (Rohtak) till further order on the recommendation of Block Education Officer, Sampla and Principal, GSSS Ismaila (Rohtak) without taking prior approval of the competent authority ignoring the fact that Model Code of Conduct was in operation due to Haryana Vidhan Sabha Election, 2019."

The delinquent submitted her reply to said charge sheet on 23.01.2020 and denied the charge leveled against her. It was mentioned in her reply that transfer of Smt. Richa Mohan PGT Biology was made at her own level due to compelling circumstances on 30.09.2019. However, the same was cancelled on very next day i.e. 01.10.2019. The delinquent further submitted that the said PGT registered an FIR of sexual harassment against Sh. Jitender Gaur, Principal and due to tense situation emerged in the school. Consequently, the said PGT was adjusted internally from GSSS Nindana to GSSS Ismaila (Rohtak) to keep cordial atmosphere in the school.

Thereafter, due to outbreak of Novel COVID-19, Smt. Parmeshwari Hooda, DEO Rohtak has been heard through Video Conference on 01.12.2020. During the course of hearing the delinquent reiterated the contents as submitted in her reply. Further, delinquent pleaded that information regarding internal adjustment of Smt. Richa Mohan PGT Biology was duly sent to the Directorate for approval on very same day i.e. 30.09.2019 but she failed to submit documents in this regard.

Keeping in view the above said facts and circumstances, it is found that as the allegations against Smt. Parmeshwari Hooda, DEO Rohtak are of administrative nature and not financial. Moreover, the delinquent has already been retired from service on 31.05.2020. Therefore, taking lenient view, the Governor of Haryana is pleased to file the present charge sheet against Smt. Parmeshwari Hooda, DEO Rohtak (Retd.).

It is ordered accordingly.
