Whereas Balbir Singh and others approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 13139 of 2020 – Balbir Singh and others V/s State of Haryana & others praying for the issuance of a writ in the nature of certiorari to quashing the impugned order/letter dated 11.08.2020 (Annexure P-3), passed by respondent No. 2, vide which the respondent has declined to promote/adjust the petitioners on the post of Elementary School Headmaster, similar to the other employees, who have been promoted/adjusted by ignoring eligibility and experience of the petitioners, which is unjust, unfair and is against the principal of natural justice. Further prayed to direct the respondent No. 2 to consider and promote the petitioners to the post of Elementary School Headmaster, by considering the representation dated 16.08.2020 (Annexure P-4) and the operation of impugned order/letter dated 11.08.2020 (Annexure P-3) passed by respondent No. 2 may kindly be stayed during the pendency of the present writ petition and the post of Elementary School Headmaster may kindly be reserved for the promotion of the petitioners.

The said petition was disposed of by the Hon'ble High Court on 31.08.2020 and the operative part is reproduced as under:

***"It has been stated by learned counsel for the petitioners that at the earlier instance, the petitioners were promoted in terms of the order dated 17.2.2020/20.2.2020. Subsequently, promotions have been withheld on account of non-availability of vacancies. The petitioners have issued legal notice dated 12.8.2020, Annexure P-4 to respondent No.2.***

***Notice of motion.***

***On the asking of the Court, Mr. Pankaj Middha, Addl. AG Haryana accepts notice on behalf of the State. He states that appropriate decision on the legal notice, Annexure P-4 shall be taken within a period of two months.***

***Without commenting on the merits of the legal notice, the instant petition is disposed of with a direction to respondent No.2 to look into the grievance of the petitioners and take appropriate decision on the legal notice in accordance with law, within a period of two months".***

In compliance of the direction issued by the Hon'ble High Court, the case of the petitioners has been examined and it has been found that in the instant writ petition the petitioners are working as TGTs/Masters. The answering department had called for promotion cases in SC category for the post of Elementary School Head Master vide order


dated 25.11.2019 upto serial No. 10000 as per seniority on 01.01.2017. Thereafter the answering respondent had issued the promotion order on 17.02.2020 upto serial No. 10000. However, the promotion order of reserved category TGTs who were promoted vide order No. 15/32-2019 HRM-III (1) dated 17.02.2020/20.02.2020 whose seniority No. falls from 7501 to 10000 as per seniority list on 01.01.2017 has been decided to withhold due to non availability of vacancies of reserved category.

It is worthwhile to mention here that the promotion order No. 15/32-2019 HRM-III (1) dated 17.02.2020 has been issued on the basis of essential qualification as per Haryana Service Rule-2012 and seniority. The promotion order of the petitioners has been withheld by the competent authority temporarily as there is shortage of vacancies for promotion on the post of Elementary School Head Master in Master Cadre (SC category). Further, it has been found that the answering department has already promoted sufficient SC quota candidates of master cadre to the post of Elementary School Head Master. As and when the vacancies of said cadre are available with respondent department order of promotion of the petitioners for the post of ESHM may be released on the basis of seniority list.

The petitioners are falling in seniority No. 7501 to 10000 and no junior of the petitioners has been promoted yet, the cases of said petitioners shall be considered after availability of posts. It is pertinent to mention here that the petitioner no. 1 falls at seniority no. 9389, petitioner no. 2 at 8861, petitioner no. 3 at 8986 and petitioner no. 4 at 9380 in seniority list as on 01.01.2017. Out of the petitioners in the present writ petition no one has seniority less than 7900.

Besides above, the case of petitioners has been examined by the competent authority and it has been found that the petitioners are not reverted/demoted from their respective post, the promotion of petitioners is just withheld by the department due to lack of vacancy in SC quota. As and when the vacancy in said quota will be available the promotion order of the petitioners may issue by the answering department on the basis of seniority list. Therefore, in view of the above background and factual position of the case, the claim of the petitioners are rejected/declined at present.
