Whereas Balraj & others approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 11083 of 2020 – Balraj & Others Vs. State of Haryana & Others praying therein inter alia for issue a writ in the nature of mandamus for directing the respondents to grant the Dearness Allowance/Honorarium @ 12% instead of 3% w.e.f. 01.01.2019 as is being granted a regular employees as per section 4 of The Haryana Guest Teachers Services Act, 2019.

The said petition came up for hearing before the Hon'ble High Court on 31.07.2020 and was disposed of with the following directions:-

“Notice of motion.

Mr. Rajesh Gaur, Deputy Advocate General, Haryana accepts notice on behalf of the respondents and submits that the concerned authorities being respondent No.2 will pass a reasoned order on the petitioners' representation, if so, directed.


In such circumstances, the present writ petition is disposed off with a direction upon respondent No.2 to pass a speaking order on the petitioners' representation dated 18.02.2020 (Annexure P-10) within 3 weeks from the date of communication of this order.”

In compliance of this order dated 31.07.2020, the case of petitioners has been examined and it has been found that vide memo no. 8/1-2019 CO (4) Dated 11.09.2019 a letter was issued by Director Secondary Education Haryana, Panchkula as Annexed by petitioners in CWP(Annexure P-7), it has been clearly mentioned that the Government has decided to give 3% Dearness Allowance to the Guest Faculty Teachers working in the Govt. School in the State w.e.f. 01.01.2019. This Dearness Allowances shall be given on the present fixed monthly remuneration paid to the guest faculty teachers. This issues with the concurrence of the Finance Department conveyed vide their U.O. No. 78/16/2016-3FD-II/28504 dated 11.09.2019.

Besides above, the case of petitioners has been examined by undersigned. At this juncture, it is pertinent to mention here that undersigned department cannot take the decision at its own level regarding increasing of dearness allowance from 3% to 12%. The undersigned department grants the benefit only on recommendation of Finance department. Also, it has been found that the petitioners are not entitled for the above said claim because they have to be granted dearness allowance at 3% as per Memo No. 8/1-2019 CO (4) DATED 11.09.2019. Therefore, in view

of the above background and factual position of the case, the claim of the petitioners claimed in representation is declined/rejected.
