

Whereas, the petitioner i.e. Smt Santosh Kumari has filed the civil writ petition no. 14187 of 2020 titled as Santosh Kumari V/s State of Haryana praying therein to quash the transfer order dated 03/07.09.2020 (Annexure P-4) vide which the petitioner has been transferred 'out of cadre' from GSSS Sampla (Rohtak) to GSSS Nizampur (Mewat) and further prayed that during the pendency of the present writ petitioner operation of the impugned order dated 03/7.09.2020 may be stayed.

That, the present case came up for the hearing on 16.09.2020. On this day, the Hon'ble High Court has pass order dated 16.09.2020 which is reproduced as under:-

Heard through video conferencing.

After arguing for some time, learned counsel for the petitioner contends that he may be permitted to withdraw this petition with liberty to file representation before respondent No.2 which may be considered in terms of the transfer policy.

Dismissed as withdrawn.

In the event of the petitioner preferring a representation to respondent No.2, the same shall be considered and decided in accordance with the transfer policy within a period of two weeks on its receipt.

In compliance of the order dated 16.09.2020 passed by the Hon'ble High Court, the petitioner has filed her representation dated 17.09.2020 and an opportunity of personal hearing was granted to the petitioner on 01.10.2020 which was held through Video Conferencing. The petitioner appeared for the hearing and pleaded for cancellation of transfer order.

On examination of record, it is found Smt. Santosh Kumari, Principal, GSSS Sampla (Rohtak) was transferred in GSSS Nizampur (Mewat) on administrative ground vide order dated 03/07.09.2020 on the recommendation of District Level Committee letter dated 04.03.2020. It is also found that the petitioner was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no 5/51-2019 HRG-I(1) dated 28.07.2020 wherein allegations of dispute with school staff were leveled against her. It is relevant to mention here that any official/officer can be transfer on administrative grounds by exercising rule 9(xi) of Teacher Transfer Policy, 2016 amended in 2017 which is reproduced as under:-

"In grave administrative exigency, the department shall be at liberty to post any teacher at any station across the state"

On examination of the facts of the case and representation dated 17.09.2020 in the light of Teacher Transfer Policy, 2016 it has been found that the petitioner has already completed more than 5 years of service in Zone-I & Zone-2 and the petitioner cannot serve further in

these zones. Accordingly, transfer order dated 03.09.2020/07.09.2020 is hereby modified and the petitioner i.e. Smt Santosh Kumari [054226], Principal is adjusted in Zone-3 at Government Senior Secondary School, Chhachharauli [205], Yamuna Nagar on administrative ground where the student strength is 964. Thus, the representation dated 17.09.2020 stand decided accordingly.

Whereas the petitioner namely Sh. Jagraj filed the CWP No 10998 of 2020 titled as Jagraj V/s State of Haryana & others praying therein for issuance of a writ in the nature of certiorari for quashing the impugned order dated 06.07.2020 passed by the respondent No 3; Annexure P-3, to the extent it is mentioned that the petitioner would be retired from service on 31.07.2020 i.e. at the age of 58 years instead of 60 years i.e. 31.07.2022, which is applicable in the case person suffering from 70% disability and issue directions to the respondents allow him to continue till the date of superannuation i.e. 60 years with all consequential service benefits; and/or to pass any other appropriate writ, order or direction which this Hon'ble Court may deem just and proper in the facts and circumstances of the present case.

The abovesaid case is came up for adjudication before the Hon'ble High Court on 30.07.2020 and the Hon'ble High Court disposed of the same vide order dated 30.07.2020. The operative portion is reproduced as under:-

“Considering this overall situation, and that he is disabled to the extent of 70%, the Writ Petition is disposed off with a direction upon the Respondent's Authorities to pass a speaking order on the letter of the DEO sent to respondent No.2 at Annexure P-3, within three weeks from the date of communication of this order. The proposed retirement of the petitioner from service shall be subject to such decision of the Competent Authority.”

In compliance of the order dated 30.07.2020 passed by the Hon'ble High Court, the letter of DEO, Sirsa dated 06.07.2020 (Annexure P-3) alongwith the service record of the Sh. Jagraj was minutely examined and it has been found that Sh. Jagraj, Clerk, GSSS, Bharonkha, Sirsa has applied for the extension of two years

additional service beyond the age of 58 years in lieu of his 70% physical disability. The service record of Sh. Jagraj is as under:-

It is submitted here that Sh. Jagraj, Clerk had applied for his extension of 2 years in service only one month prior before attaining the age of 58 years. In his extension application he attached a medical certificate issued by Orthopedic Surgeon, General Hospital, Sirsa. However, for the extension in service to the physically disabled employees beyond the age of 58 years, the medical board of PGIMS, Rohtak is designated as Medical Board for the State as per instructions of State Government dated 21.04.2008. But in the present case, Sh. Jagraj, Clerk, not examined himself from such constituted Medical Board. Despite of examining himself from constituted Medical Board, he produced the Medical Certificate issued by the Orthopedic Surgeon, General Hospital, Sirsa, which is unconsiderable for the settlement of extension case of him.

Moreover, in Rule-143 of Haryana Civil Services (General) Rules, 2016, it has been clearly mentioned that the employee concerned (*differently-abled employee having minimum disability of 70% and above*) shall bring to the notice of his Head of Department minimum 3 months before attaining the age of 58 years for the purpose of his extension. Further, he shall be got examined himself from the Medical Board of PGIMS, Rohtak to be headed by its director. On receipt of medical report from the Board, the competent authority shall take a final decision to grant or not to grant the extension in service to such physically disabled employee.

Keeping in view of the abovesaid facts and Government instructions the claim of the petitioner namely Sh. Jagraj, Clerk, GSSS, Bharonkha, Sirsa is not tenable and considerable as he not applied for his extension 3 month prior from the date of his retirement. Further, he did not submitted the requisite Medical Examination certificate issued by Medical Board of PGIMS, Rohtak, alongwith his application for extension beyond the age of 58 years. Therefore, the claim of the petitioner is hereby rejected.

I order accordingly.
