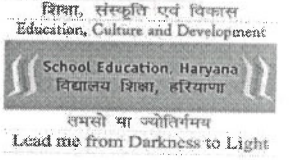

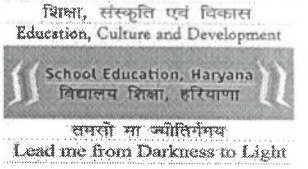

**TERMS & CONDITIONS:-**

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage he desires to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.
3. He will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case he is married, he will produce the following certificate to his Head of office:-  
 "That he is not having more than one living spouse." In case he is unmarried, he shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case he is married, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.

6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. He will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
9. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
10. If He/she have not been vaccinated within last twelve months they should have get it done before reporting themselves for duty.
11. No TA/DA and joining time will be paid to them for joining this post.
12. He will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
13. His appointment is subject to have passed matriculation or its equivalent examination with Hindi/Sanskrit as a subject and 10+2.
14. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" as amended from time to time.
15. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
16. The merit of the selected candidates in their respective categories will be further subject to the final outcome of CWP No. 7/2020,124/2020,631/2020,795/2020,597/2020,3883/2020 and 738/2020 and any other writ petitions pending in the Hon'ble Punjab and Haryana High Court or any other court of law.
17. That the appointment is being issued provisionally subject to the conditions laid down in Chief Secretary letter No. 52/18/2018-3GSIH dated 18.08.2020.
18. The DESM/ESM category candidates will have to furnish a fresh eligibility certificate duly issued by Zila Sainik Board to the effect that he/she has not availed of the benefit of dependent of Ex-serviceman and has not availed any other benefit in any manner.



19.
