That the writ petition came up for hearing before the Hon'ble Court on 17.10.2019 and this Hon'ble Court was pleased to dispose of the same with the directions to respondents as under:

"Prayer in the present writ petition is for quashing of impugned transfer orders dated 22.08.2019 (Annexure P-7, Colly).

Petitioner No.1 has been transferred from Government High School, Charnia, Block Pinjore, District Panchkula to Government Senior Secondary School, Sardaheri, Block Barara, District Ambala, whereas petitioner No.2, from Government Girls Senior Secondary School, Kharkhoda, District Sonipat, to Government Senior Secondary School, Muana, Block Safidon, District Jind.

The impugned orders are dated 22.08.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioners are aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. - c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of administrative or litigational nature.

That the case of the petitioner namely Karamjit kaur has been examined and it is found that she was rightly transferred vide order dated 22.08.2019 as she had herself voluntarily participated in the General Transfer drive, 2019 she had obtained a score of 37.9699 and had preferred 12 stations of her choice as the last preferred station was allotted to another teacher namely Renu Bala who had obtained score of 61.6904 which is higher than the petitioner and thus, the petitioner was allocated station under 'Ánywhere in the State Category'. Moreover, the petitioner was accorded an opportunity of personal hearing on 24.07.2020 but the petitioner could not justify that she was wrongly transferred vide order dated 22.08.2019 in contravention of Teachers Transfer Policy, 2016 (as amended on 01.06.2017).

That the case of the petitioner namely Urvashi Vatshas been examined and it is found that she was rightly transferred vide order dated 22.08.2019 as the post of the petitioner was declared surplus for the purpose of Rationalization so as to maintain optimum studentteacher ratio across the schools in the state of Haryana and the petitioner was having longest stay amongst the PGTs (Mathematics) at Government girls Senior School, Kharkhoda, Sonipat (3469) and thus the petitioner participated in the General Transfer Drive, 2019 duly within purview of the Teacher Transfer Policy, 2019 as amended on 01.06.2017. she had obtained a score of 46.7616 and had preferred 32 stations as choices but the petitioner was not allotted a station of her choice as the last preferred station was allotted to another teacher namely Satish Kumar who had obtained score of 52.0986 which is higher than the

petitioner and thus, the petitioner was allocated station under 'Anywhere in the State Category'. Moreover, the petitioner was also accorded an opportunity of personal hearing on 24.07.2020 but the petitioner could not justify that she was wrongly transferred vide order dated 22.08.2019 in contravention of Teachers Transfer Policy, 2016 (as amended on 01.06.2017).
