In compliance of order dated 29.10.2019 passed by the Hon'ble High Court in CWP No. 10627 of 2017 titled as Sunita Devi V/s State of Haryana and others, the Haryana Staff Selection Commission, Panchkula has recommended the names of following candidates for appointment to the post of PGT Hindi vide their Memo No. HSSC/Conf./Recomm/Court Case/2020/369 dated 10.08.2020, the Governor of Haryana is pleased to appoint them as Post Graduate Teacher **Hindi** (HES-II) (Rest of Haryana cadre) in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time. They are directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. He/She is appointed purely on temporary basis.
2. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. The benefit of ante-date appointment w.e.f. 26.11.2015 will be admissible to his/her only for notional pay fixation and seniority and actual financial benefits will be admissible to his/her from the date he/she joins duty as **PGT Hindi**.
4. He/She shall have to take an oath of allegiance to the Constitution of India. Further, in case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.

5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
 6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
 7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
 8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
 9. Candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
 10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
 11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
 12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc for one month or for the period by which the notice falls short of one month. Such a notice will be given to him/her by the Government also in the case it is proposed to terminate his/her services in lieu thereof the Government will be liable to pay his/her salary, including allowances for one month or for the period by which the notice falls short of one month.

13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information / facts which are detected later on, he/she would be liable for termination of service without any prior notice.
15. These appointments will be subject to the final outcome of CWP No(s). 15992, 16154, 16493, 16289, 16412, 16413, 16414, 16465, 16228, 16300, 20103, 20058, 21557, 21563, 21874 of 2015 or any other CWP of similar matter pending for adjudication in the Hon'ble High Court.
16. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
17. **He/She is directed to join his/her place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.**
18. The said appointments are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within a period of two months. 
