



Whereas, the petitioners have filed the CWP No. 18420 of 2019 titled as Shashtri Devi and others Vs State of Haryana and others, praying therein for the issuance of a writ in the nature of Mandamus commanding the respondents to consider the case of present petitioners and decide the legal notice dated 05.03.2019 (P-5) by passing a speaking order within a stipulated period.

The above mentioned Civil Writ Petition came up for hearing on 10.07.2019 and the Hon'ble High Court was pleased to dispose of the same. The operative part of order dated 10.07.2019 is as under:-

"Without going into merit of case or commenting thereon, I deem it appropriate to dispose of present writ petition with a direction to respondent No.2 to decide the legal notice dated 06.03.2019 (Annexure P-5) considering the case of petitioners at par with the persons reflected in order dated 18.07.2017, Annexure P-4 by passing a speaking order after affording opportunity of hearing to the petitioners within a period of four months from the date of receipt of certified copy of this order.

In case the petitioners are found successful, benefit as per the order Annexure P-4 should be given in order to avoid any further litigation.

It is made clear that in case the aforementioned legal notice is not decided within the specified time, there shall be costs of 50,000/- to be paid by the concerned officer to the petitioners".

In compliance of the orders of Hon'ble High Court dated 10.07.2019, the legal notice dated 5.3.2019 served by the petitioners has been examined by the competent authority/committee headed by District Education Officer, Bhiwani. As per the report received from the O/o District Education Officer, Bhiwani, it has been found that the



- 2.)Sh. Rajpal:- It is also quite necessary to clear here in the instant matter that Sh. Rajpal was appointed as part-time class for employee in the year of 1997, thereafter his services had been regularized on 31st May 2002 as he had possessed the essential qualification of the post of class IV employee against the vacant sanctioned post in the institute in which he had been working earlier at that time.
- 3.) Ram Kishan:- Sh. Ram Kishan was appointed as part time class-IV employee on 30th July 1997, thereafter he was adjusted against vacant sanctioned post. He had possessed the essential qualification that is middle pass for the post of class IV employee so according to the regularization policy 30th December 1998 and 23 February 1999 the service of Sh. Ram Kishan had been regularized after as he fulfills the required conditions. Now more than 17 years have lapsed after the regularization of the service of the Ram Kishan. Thus the claim of the petitioners is liable to be dismissed on the ground of delay alone.
- 4.) Krishan Kumar:- That matter of Sh. Krishan Kumar is also very similar to the example of Sh. Sunil Kumar and Rajpal. As Sh. Krishan Kumar also possessed the essential qualification for the post of class IV employee and his service had been regularized in view of earlier regularization policy dated 30th December 1998/25th February 1999. At this belated stage the claim of the petitioners has no value and not maintainable on the ground of delay also.

Petitioners were not having minimum qualification for the post of class IV employee required as per regularization policy dated 30.12.1999. Later-on the essential conditions have been abolished/exempted in new regularization Policy dated 11.11.2003. Thereafter, the services of the petitioners had been regularized as per regularization policy dated 11.11.2003, on the basis of seniority list of part-time class - IV employee as well as on the basis of vacant sanctioned post in District Bhiwani.



respectively as per the availability of sanctioned vacant post as well as the seniority of the petitioners.

The petitioners are claiming their regularization w.e.f. 1.4.2011 by quoting the examples of those employees who belong to other districts i.e. Sonipat, Panipat & Hisar which is not tenable as seniority is maintained district wise. No junior to the petitioners was regularized prior to them in the Bhiwani district.

At the prevalent period, the services of part-time employee was to be regularize, in case he/she had the essential qualification for the post of class IV employee (i.e. Middle Pass) and rendered six years as part-time employee in that very institution. Further it is stated here that there was no sanctioned post in any primary school. Resultantly, the services of the petitioners could not be regularized at that time due to the reason mentioned above. So, to avoid discrimination, regularization policy dated 11.11.2003 has been issued.

It is significant to mention here that the petitioner have also cited the example of other part time employees whose name are hereby mentioned below:-

1.) Sunil Kumar:- It is necessary to mention here that originally Shri Sunil Kumar was appointed as part-time class IV employee on the 10.08.98 while the petitioners had wrongly mentioned the date of appointment as 20.08. 2002 instead of the 10.08.1998. Further the said employee was appointed as part-time against non sanctioned post but he had possessed the essential qualification that is middle pass, thereafter the school had been upgraded and a new post has been created on account of up gradation of the school. Resultantly the service of Sh. Sunil Kumar had been regularized 2.9.2002 according to earlier regularization policy dated 30.12.1998/25.02.99 being eligible.



petitioners namely Rambir Singh, Shashtri Devi, Kirori Devi and Ram Kishan were engaged as Class-IV employees on part-time basis. Details are mentioned below:-

In the year of 2002, various civil writ petitions have been filed by the number of class-IV employees to regularize their services. All the civil writ petitions have been clubbed and decided by the Hon'ble High Court by way of giving directions to the State of Haryana in the case of Vidya Devi. As per the direction given by the Hon'ble High Court, a combine seniority list of the part-time class-IV employees was prepared at District level by mentioning the seniority number and other related record of the concerned employees.

On the basis of seniority list as well as availability of sanctioned posts, the service of the petitioner was regularized w.e.f. 28.5.2012, 19.8.2014, 19.8.2014 and 21.4.2017 respectively according to the regularization policy 11.11.2003. The service of senior most part-time employee had been regularized on the basis of sanctioned vacant post of class-IV employee. However prior to the regularization policy dated 11.11.2003, the process of regularization was not uniform rather the same was different one.

The seniority list was prepared at District level in the year of 2003 and petitioners stand in the seniority list of 2003 at Sr. no. 243, 381, 383 & 652 respectively. It is further stated that the petitioners were regularized as per regularization policy 2003 w.e.f. 28.5.2012, 11.8.2017, 1.11.2016, and 22.4.2017



Keeping in view the aforesaid facts, claim is demanded through legal notice dated 5.3.2019 is not tenable. Hence, the claim of the petitioners is hereby rejected being devoid of any merits.




