ORDER No. 13/163-2020 HRME- I (4)

Whereas, the petitioner Sh. Pankaj has filed the CWP No. 14426 of 2020 titled as Pankaj Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature of certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure P-1) qua the petitioners.

The above said CWP came up for adjudication on 15.09.2020 before the Hon'ble Court and the same was disposed of with the following order:

"It is settled principle that this Court would not interfere in the transfer orders till the mala fides or violation of statutory Rules of policy are made out. Since the petitioner has already filed representation dated 25.08.2020 (Annexure P-4) pointing out the difficulties that he would face on account of his transfer and the representation can be acted upon by respondent No.2 within a period of two weeks.

It is open to the petitioner to attach the necessary documents in support of this representation before the said respondent expeditiously.

Accordingly, let the said respondent take a decision on the said representation within a period of 3 weeks from the receipt of the supporting documents.

Writ petition stands disposed of in the above terms."

In compliance of the aforesaid order passed by the Hon'ble High Court the representation of the petitioners already appended by the petitioners in the writ dated 25.08.2020 was minutely examined and it has been found that the petitioners have challenged the transfer order dated 14.08.2020 on the ground that the clause 4(b) of the transfer process as per Transfer Policy is required to be completed by 31st March every year. While the impugned order has been issued on 14.08.2020 which is not tenable as since 22 March, 2020 all the administrative functions across the country were at halt due to outbreak of Covid-19 pandemic and thereupon as and when the functioning could be resumed, the transfer process was initiated.

Moreover, it has been further stated in the representation dated 25.08.2020 that numerous stations were "kept" which is again not a sustainable grievance, as by the department 'kept' certain stations by following the proper criteria i.e. the schools in which the student strength is less than 125, were blocked for the purpose of proper utilization of the manpower available with the department. The same was done due to the process of rationalization and for the purpose of even distribution of clerks in the State as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020. As far as, the contention with regard to the posting at far-away place is concerned, the petitioner has scored 46.9178 out of total composite score of 80 as per the online Transfer Policy and the petitioner has been allocated station of his choice which he had opted at Sr. No. 23 i.e. Government Girls Senior Secondary School Dinod [353], Bhiwani.

Moreover, the 22nd station preferred by the petitioner i.e. Government

Senior Secondary School Nathuwas [430], Bhiwani was allocated to the employee namely Ms. Suman Devi who obtained a score of 47.8548 points which is clearly higher score as compared to the petitioner's score.

Therefore, the petitioner has been rightly transferred by the department in strict compliance to the transfer policy. Hence, the representation made by petitioner is hereby rejected.

I order accordingly.


