Subject:- Recognition Certificate for the School under sub-rule (4) of rule 12 of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of right of Children to Free and Compulsory Education Act, 2009.

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to **Era International School, Dumerkha, Jind** class 1st to 8th with effect from 01.04.2020 run by Managing Committee **Kamla Devi Education Society, Dumerkha Kalan, Distt. Jind.**

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion;
Provided, that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.
 - (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
 - (v) inclusion of students with disabilities/special needs as per provision of the Act;
 - (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualification within a period of 5 years;
 - (vii) the teacher performs its duties specified under section 24(1) of the Act; and
 - (viii) the teachers shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act.

The facilities reported at the time of last inspection are as given under :-

- (i) Area of school campus total built up area.
- (ii) Area of play ground
- (iii) Number of class rooms
- (iv) Room for Head master-cum-Office-cum-Store room
- (v) Separate toilet for boys and girls

- (ix) Availability of Teaching Learning Material /Play Sports Equipments/Library.
10. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
 11. The school buildings or other structures or the grounds are used only for the purposes education and skill development.
 12. The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
 13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.
 14. The recognition code Number allotted to your school is 4635/JND/8th/BOSE/2020. This may please be noted and quoted for any correspondence with this office.
 15. The school furnishes such reports and information as may be required by the Director of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfilment of the condition or recognition or the deficiencies in working of the school.

Whereas Smt. Sunita Rani approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 10065 of 2020-Sunita Rani Vs. State of Haryana and others praying therein for issuance of a writ petition in the nature of certiorari to quash the order dated 01.07.2020 (**Annexure P-8**), whereby the petitioner has been ordered to be transferred wrongly and illegally. Further issue a writ of certiorari to quash the order dated 04.03.2020 (**Annexure P-4**), order being wrong and illegal and against the principles of natural justice. During the pendency of the present petition, the petitioner may not be relieved from her present place of posting at GHS Mashad (3635) Sonipat.

The said petition disposed of by the Hon'ble High Court on dated 30.07.2020 and the operative part is reproduced as under:

"It has been stated by learned counsel for the petitioner that due to typographical error, the date of retirement of the petitioner has been mentioned as 28.02.2020 instead of 20.02.2021.

For the reasons stated in the application, the same is allowed. The date of retirement of the petitioner in the petition shall be read as 28.02.2021.

CM-6828-CWP-2020

For the reasons stated in the application, prayer for impleadment of District Elementary Education Officer, Sonipat as respondent No.4 is allowed, subject to all just exceptions.

Amended Memo of Parties is taken on record.

CWP-10065-2020

The petitioner is aggrieved by her transfer alleging that the same is in violation of the transfer policy.

Learned counsel for the petitioner contends that the petitioner has already submitted a representation 08.06.2020 (Annexure P-6).

Notice of motion to official respondents only.

Mr. Pawan Kumar Longia, Deputy Advocate General, Haryana, accepts notice on behalf of the respondents No. 1, 2 and 4 and states that an appropriate order on the aforesaid representation will be passed within a period of two weeks.

Without commenting anything on the merits of the case, the present petition is disposed of with a direction to the concerned

respondent(s) to look into the grievance of the petitioner, as projected in the aforesaid representation and decide the same within a period of two weeks."

In the compliance of order dated 30.07.2020 issued by the Hon'ble High Court, the case of petitioner has been examined and it has been found that in the instant writ petition the petitioner will retire on 28.02.2021. The petitioner had participated in the Transfer Drive on 06.09.2019 and she was successfully transferred at Government High School Sonipat Mashad (3635), Sonipat (Zone-1). It is pertinent to mention here that respondent No. 3 approached this Hon'ble High Court by a Civil Writ Petition No. 27895 of 2019 titled as Narender Singh and others Vs. State of Haryana and others in which the Hon'ble High Court granted stay on the impugned order dated 06.09.2019. Accordingly a stay order was issued in respect of respondent No.3/petitioner i.e. Balbir Singh who was sent back previous school i.e. Government High School Sonipat Mashad (3635), Sonipat (Zone-1) on 04.03.2020 in compliance of the order issued by the Hon'ble High Court.

Thereafter, the petitioner has been adjusted on the proposed place of posting i.e. GMS Mandi (3682), Sonipat vide order No. E-1-2020/405-10 dated 01.07.2020 by the District Elementary Education Officer, Sonipat. The petitioner had filed present writ petition in grievance of said posting order on the basis that the retirement of her is due on 28.02.2021 i.e. about 7 months on the date of adjustment and prayed for quashing the said order on the point that teacher who are to retire within one year shall not be transferred as per direction issued vide letter dated 25.08.2019 (Annexure P-1).

That rule 9(iii) of the Teacher Transfer Policy 2016 (amended as on 01.06.2017) states that:-


"Teacher having twelve months or less in retirement shall not be transferred if they are not willing to participate in the transfer drive."

Hence, as the petitioner had willingly participated in the Transfer Drive on 06.09.2019 and was to retire after 17 months from the date of Transfer i.e. 06.09.2019, she cannot claim the benefit of rule 9(iii) of the Teacher Transfer Policy 2016 (amended as on 01.06.2017). It is worthwhile to note that the petitioner has been adjusted and not transferred. At this juncture it is pertinent to note that there is a thin line difference between adjustment and transfer. Future, from the date of transfer to 01.07.2020 the petitioner was working in the school, she had been transferred to through the Transfer Drive and it is due to

the reason mentioned in Para 3 she had to be adjusted. Further, the date of retirement is to be seen from the date of transfer and not from the date of adjustment as per the rule 9(iii) of the Teacher Transfer Policy 2016 (amended as on 01.06.2017).

In the context of position explained above, the case of the petitioner has been examined by the competent authority and it has been found that the petitioner is not entitled for the above said claim. Therefore, in view of the above background and factual position of the case, the claim of the petitioner is declined/rejected as per the provision of the policy.

Order accordingly.




