Whereas, Anil Kumar has filed the CWP No. 35944 of 2019 in the Hon'ble High Court of Punjab & Haryana, Chandigarh and prayed under Article 226/227 of the Constitution of India for issuance of writ in the nature of Certiorari to remove the adverse entry made by the respondent no. 5 the then DEO (Accepting Authority) in A.P.A.R.(Annual Performance Appraisal Report) of year 2015-2016.

The said Writ Petition was disposed of by the the Hon'ble High Court vide order dated 16.12.2019. The operative part of the order is as under :-

“Without commenting on the merits of the claim or entitlement of the petitioner to the relief claimed, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim as made in representation Annexure P/8 dated 29.08.2019, after taking into account all aspects of the matter, within three months from the date of receipt of certified copy of this order.”

In view of the above said order, the representation of the petitioner is to be decided by the undersigned. But, the representation (Annexure P-8) has already been moved by the petitioner to the Secretary, Haryana Board of Secondary Education. Therefore, vide letter D.O. No. 6/13-2020 HRG-1(2) dated 13.07.2020, the Secretary, Board of School Education, Haryana, Bhiwani, was intimated by this department to decide the representation.

The Secretary, Board of School Education Haryana, Bhiwani examined the representation and intimated to this department vide letter no. 54575 dated 28.07.2020 that no merits are found in the representation.

However, it is worth to mention here that after examination of the representation (Annexure P-8) by the Secretary, Board of School Education Haryana, this department has also examined the Annexure P-8 and found that there was no version regarding adverse entry in A.P.A.R. of reducing grade A+(outstanding) to B(average) by the then DEO rather there was a version of “Appeal for the review and reconsideration of the suppressed complaint against erstwhile DEO

Sonipat Mrs. Parmeshwari Hooda & members of flying squad by the Board Authorities" in the Annexure P-8. Further, in regard to adverse entry in A.P.A.R, District Education Officer, Sonapat vide letter E-6-20/649-50 dated 30.09.2020 has intimated that the APAR of the petitioner has been reviewed and the remarks given by the then DEO has been withdrawn. Therefore, the claim of the petitioner has been settled.

Accordingly, keeping in view of the above observation the Annexure P-8 is decided.

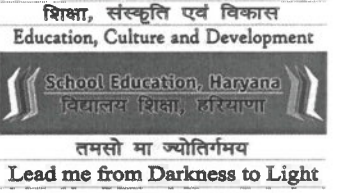

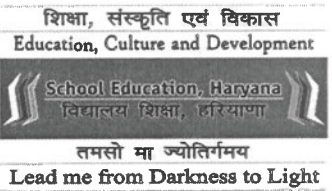

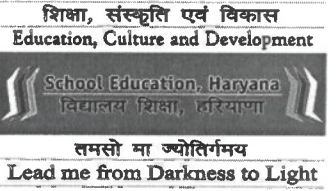

Whereas, the petitioner namely Sh. Rahul Kumar & another have filed the CWP No. 13907 of 2020 titled as Rahul Sharma & another Vs. State of Haryana & Other before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature of certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure -P1) qua the petitioners.

The above said CWP came up for adjudication before the Hon'ble High Court on 11.09.2020 which was disposed of with the following order:

"In that view of the matter, the writ petition is disposed of permitting the petitioners to make their representation against their transfers, if they so choose, within one week from today. In the event such representations are received, the grievance redressal Forum constituted by the department shall consider the same on their own merits and in accordance with the policy expeditiously and, in any event not later than three weeks from the date of receipt of such representation.

No order as to costs."

In compliance of the order passed by the Hon'ble High Court the representation of the petitioner dated 17.08.2020 was minutely examined and it has been found that both the petitioners have voluntarily participated in the online transfer drive and
petitioner 1 has opted for 168 stations and has obtained score of

25.7452 points, as per transfer policy. The 168th preferred station i.e. the last preferred station by the petitioner number 1, was allocated to one namely Manoj Kumar who obtained score of 51.6164 Points. The petitioner number 2 has opted for 227 stations and has obtained score of 27.4959, as per transfer policy. The 227th preferred station i.e the last preferred station by the petitioner number 2 was allocated to one namely Bimla Devi who obtained Score of 65.8411 Points. The petitioners were transferred to **Anywhere in the State** category due to non-availability of preferred stations as the same were allotted to the employees higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, Chief Secretary to Government of Haryana, issued instructions regarding online transfer Policy on dated 07.08.2020. But process of the transfer for the clerks was started before the issuance of this letter dated 07.08.2020. As such the same is not applicable on the online transfer drive for clerks, even then the general principals of the letter dated 07.08.2020 were adopted by the department in the interest of justice.

Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department, due to the process of rationalization. The same was done for the purpose of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Therefore, the petitioners have been rightly transferred through online mode by the department in strict compliance to the transfer policy. Hence, the representation made by petitioners is hereby rejected, being devoid of merits

I order accordingly.
