ORDER

No. 6/50-2020 HRG-I(2)

Dated, Panchkula, the 29-09-2020

Whereas, Smt. Anita Rani has filed CWP No. 13774 of 2020 titled as Anita Rani Vs State of Haryana in the Hon'ble Punjab & Haryana High Court, Chandigarh with the prayer to look into grievance/representation dated 25.07.2020 (Annexure P-3) of petitioner i.e. the GSSS Darbaripur [753] where petitioner remain posted from 27 April 2012 to 29 October 2015 and GSSS Caterpuri [750] where she remain posted from 29.10.2015 to 07.09.2017 was falling under Zone-1 as per zone list dated 03.06.2016 [P-2] as per teacher transfer policy of state of Haryana in Gurugram District. However, now the same above schools where she was earlier posted these schools are now shown in Zone 2 in the year 2020 list. Under the new transfer policy a teacher can remain for maximum period of 5 year in a Zone 1 after that she would become ineligible to opt station in that Zone 1. Effect of change of Zone in the years 2020 is that now petitioner even cannot opt station in Zone 2 also. In this regard her representation dated 25.07.2020 (Annexure P-3) for correction in her MIS Portal drive for transfer is pending.

The present case was listed on 07.09.2020 before the Hon'ble Punjab & Haryana Court, Chandigarh. The Hon'ble High Court has disposed off on 07.09.2020. The operative part of the order is as under:-

"Having heard learned counsel for the petitioner and while refraining from making any expression as regards merits of the case, the petition is disposed of with a direction to respondent No.2-Director of Secondary Education Haryana Shiksha Sadan, Sector-5, Panchkula to look into the matter and to dispose of representation dated 25.7.2020 (Annexure P-3) in accordance with law expeditiously preferably within a period of 15 days from receipt of copy of this order."

In compliance of the above said orders, the grievance of the petitioner, mentioned in her representation dated 25.07.2020, has been examined at length and found that the MIS profile of the petitioner was approved on 03.07.2019. On examination her profile, it is found that presently the petitioner has been working as Principal, GGSSS Pataudi [863] (Gurugram) since 08.09.2017 and she has also served in various Zones, which is tabulated as under:-

7.	Zone 7	Not served yet

In this way, the petitioner had already been served for more than five years of service in Zone-1 prior to notification dated 23.06.2017. An official/officer can serve for maximum five years in a specific zone. Thus, the petitioner has options to serve in Zones 4 to 7 also.


There is provision in para 4(4) of Teachers Transfer Policy, 2016 amended as on May, 2017, which is reproduced as under:-

"If the operational necessity demands the boundaries of a zone can be redefined by a specific order passed by the competent authority once in a year, before the transfer drive is initiated".

That the policy decision was taken for change of zones of schools and the tenure of the employees who have already served in such schools, prior to notification dated 23.06.2017, counted in the previous zones. Thus, the impact of such transformation of zones are applicable on all the officials/officers, including petitioner, across the state. It is found that the petitioner served in Zone 1 from 27.04.2012 to 07.09.2017 in two schools which are now mapped in Zone-2. Further, the petitioner got her profile approved on 03.07.2019 after revised notification dated 23.06.2017. Consequently, the service rendered by her in Zone 1 was counted in Zone-2. Had the petitioner got her profile approved prior to notification dated 23.06.2017, the service rendered in Zone 2 shall not be affected. In this way, she committed lapse getting her MIS profile approved well in time leading to the present situation.

Keeping in view of the above, there is no merits in the representation dated 25.07.2020 of the petitioner and the same is hereby rejected.

It is ordered accordingly.




