ORDER

NO. 13/58-2020 HRME-II (2) DATED, PANCHKULA, THE 05-10-2020

Whereas the petitioner namely Sh. Mahesh Kumar had filed the CWP No 6375 of 2020 titled as Mahesh Kumar V/s State of Haryana and others before the Hon'ble Punjab and Haryana High Court praying therein for issuance of a writ in the nature of mandamus directing the respondents to grant the pay scale alongwith consequential benefits of the posts of Superintendent on which petitioner worked from 30.11.2012 against the vacant post and thereafter on Current Duty Charge from 15.08.2014 till his retirement in February 2015.

The aforesaid CWP was came up for adjudication on 06.03.2020 and after completion of its hearing, Hon'ble Court disposed of the same with direction to the respondents to decide the representation on 07.02.2020 (Annexure P-5). The operative portion of the order dated 06.03.2020 is reproduced as under:-

"Prayer in the present petition is to grant the pay scale alongwith consequential benefits of the post of Superintendent on which the petitioner worked from 30.11.2012 against the vacant post and thereafter on current duty charge from 15.8.2014 till his retirement.

The petitioner duly represented for the said relief vide his representation dated 7.2.2020 (Annexure P-5).

In view of the above, the present petition is disposed of with a direction to the concerned respondent to decide the representation dated 7.2.2020 (Annexure P-5) as expeditiously as possible preferably within two months from the receipt of certified copy of this order."

In compliance of above direction dated 06.03.2020 passed by the Hon'ble High Court, the representation of the

petitioner dated 07.02.2020 has been considered. The service record of the petitioner is as under:-

As per the aforesaid service record of the petitioner, it has been found that petitioner was promoted to the post of Deputy Superintendent on 26.09.2012 and was assigned the Current Duty Charge of Superintendent vide order dated 11.08.2014 on his own pay scale and grade on provisional basis in District Institute of Education and Training, Birhikalan, Bhiwani due to exigencies of work for smooth functioning of administrative work. The petitioner was granted the Current Duty Charge as he did not fulfill the essential eligibility conditions for the promotion of Superintendent.

As per service rules, the Deputy Superintendent must have the experience of three years for the promotion to the post of Superintendent. But, in the case of petitioner, he does not have the requisite experience of three years as Deputy Superintendent, as he served only for 02 years 05 months as Deputy Superintendent.

The citations quoted by the petitioner was perused but these are not applicable to the case of petitioner. Hon'ble court in the cited judgments clearly upheld that if the person is eligible and is entitled for clear vacancy then promotion is given instead of Current Duty Charge. But the petitioner is not having

requisite experience therefore not considered for promotion and given Current Duty Charge.

Further, the petitioner quoted the example of CWP No 2305 of 2015 titled as Ramesh Chand Bhardwaj V/s State of Haryana & others, wherein the department has filed SLP before the Hon'ble Apex Court vide diary No. 16545/2020 titled as the State of Haryana V/s Ramesh Chand Bhardwaj on the advice of Ld Advocate General, Haryana which is pending adjudication before Hon'ble Apex Court.

In the CDC order dated 11.08.2014, it has been clearly mentioned in term No 7 that -**"they will not claim any benefits to the post of Superintendent"**.

Considering the representation and claim made therein under Statutory Provisions and Instructions issued by the Government of Haryana from time to time, I'm of the considered view that the petitioner was not entitled to be granted promotion on the post of Superintendent as he does not fulfill the essential experience of three years as Deputy Superintendent. In the circumstances relief claimed in the representation is not tenable, hence not acceptable and is hereby rejected.

I Order accordingly.






