Whereas, the petitioners namely Sh. Paveen Kumar and Sh. Arvind Kumar have filed the CWP No. 13727 of 2020 titled as Paveen Kumar and another Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature of certiorari for quashing the impugned transfer orders dated 14.08.2020 (Annexure P-11 &P-12) respectively for transferring the petitioners from one district to another district to a faraway place in the category of anywhere in the State instead of transferring them to the stations of their choices or nearby stations. Further, the petitioners prayed for issuance of a writ in the nature of mandamus, directing the respondents to send back the petitioner no. 1 in Government Senior Secondary School, Saragthal, District Sonapat in view of no objection certificate of Arvind Kumar (Petitioner No. 2) and the petitioner no. 2 may also be sent back to Government Middle School, Jail Road, District Rohtak, as nobody has been transferred against him on said post till date and post is lying vacant, by modifying the impugned order dated 14.08.2020 (Annexure P-11 & 12).

The above said CWP came up for hearing on 07.09.2020 and the Hon'ble Court passed the following orders:

"In the meanwhile, let representations (Annexure P-14 and P-15) of the petitioners be considered by the respondents for

being posted at place of their choice, which were not made available to them online as per the transfer policy.”

In compliance of the aforesaid order passed by the Hon'ble High Court the representation/ prayers of the petitioners in the writ are minutely examined and it has been found that petitioner No. 1 namely Sh. Parveen Kumar has voluntarily participated in the online transfer drive. He opted for 110 stations and obtained merit score of 41.9342 points, as per transfer policy. 
