Whereas, Randhir Singh and Another, filed C.W.P. No. 5329 of 2020 titled as Randhir Singh and Another Vs State of Haryana & Others praying therein for issuance of a writ in the nature of certiorari quashing order dated 24.05.2018(Annexure P-5) vide which cases of the petitioners for promotion to the post of TGT English have been rejected by stating that the petitioners are not possessing the qualifications of B.Ed. with teaching subject English, which action is in violation of the Statutory Rules Haryana School Education (Group-C) State Cadre Service Rules 2012. The petitioners has further prayed for direction to be given to the respondent No. 2 to consider and promote the petitioners to the post of TGT English w.e.f. the date juniors have been promoted i.e. 30.07.2018(Annexure P-9 Colly) with all consequential benefits and further direction be given to the respondents to consider and decide the legal notice dated 16.12.2019 (Annexure P-7) in lieu of the judgment dated 12.09.2018 (Annexure P-8 Colly) and promotion order dated 30.07.2018 (Annexure P-9 Colly).

The Hon'ble High Court vide order dated 27.02.2020 disposed of the said writ petition with the following orders:

"Both the petitioners are aggrieved of the action of the respondent authorities in having declined their claim for promotion as TGT (English) on the ground that they did not have English as a teaching subject in B.Ed.

Counsel has adverted to the Haryana School Education (GroupC) State Cadre Service Rules 2012 and whereunder for promotion to the post of TGT (English) the requirement is for a JBT Teacher to have BA with at least 50 per cent marks in English as an elective subject and two years diploma in Elementary Education.

The precise contention raised is that the petitioners

fulfill the essential qualifications to be considered for promotion to the post of TGT English as laid down under the statutory rules whereas the respondent authorities have rejected their claim by imposing a condition which is alien to the rules.

Further contends that in similar circumstances, other JBT Teachers had approached this Court and in such writ petitions directions had been issued to take a final decision on a representation and pursuant thereto promotion orders have been issued. By way of instance counsel has referred to an order dated 05.02.2020 passed by the Coordinate Bench in CWP No.3137 of 2020 (Deepak Kumar Vs. State of Haryana and others).

Counsel states that he would be satisfied if the writ petition were to be disposed of with a direction to the concerned authority to examine the claim of the petitioners.

Submission made by counsel is found to be just and reasonable.

In view of the above and without even ascertaining the correctness of the averments made in the petition, I deem it appropriate to dispose of the instant writ petition with a direction to respondent No.2 i.e.the Director, Elementary Education, Haryana, to examine the claim of the petitioners against the backdrop of a legal notice dated 16.12.2019 (Annexure P-7) and to take a final decision thereupon expeditiously and in any case within a period of two months from the date of receipt of certified copy of this order.

Disposed of".

In compliance of order dated 27.02.2020 of the Hon'ble High Court, legal notice

dated16.12.2019 of the petitioners has been considered. As such in pursuance of

the memo dated 24.05.2018, all the petitioners who are possessing the qualification

of Matric with Hindi and 2 years Diploma in Education as well as qualification of B.A

and B.Ed. and as such are eligible for promotion from the post of JBT teachers to the

post of TGT (English) approached the DEEO Fatehabad to send their cases in the

year 2018 for promotion to the post of TGT (English) to the Directorate Elementary

Education Haryana.

It is mentioned that vide memo dated 27.04.2018 directed all the DEEOs to send

the cases of the JBT and C&V teachers for promotion to the post of TGT English,

Science, Home Science, Music, Urdu and as per this memo cases to be submitted up

to 24.05.2018. It is pertinent to mention here that the cases of the petitioners has

been received in the department.

It is submitted that petitioners are appointed in the year of 2011 and it is pertinent

to mention that the respondent department did not pass any order of promotion in the

year 2011. It is pertinent to mention here that the no junior is promoted to the post of

TGT English being appointee of 2011. The Respondent department has given an

opportunity of personal hearing to the Petitioners as on 30.06.2020 and the

petitioners are being heard.

Accordingly they have been rejected for promotion as per Statutory Service

Rules 2012. Resultantly, their names were not detailed in the order of promotion to

the post of TGT (English).

Considering all facts and circumstances of the case, it is found that the

Petitioner's claim for promotion to post of TGT (English) is not made out and

therefore Petitioners/Applicants are not entitled to have any relief and as such their

representation being devoid of merits is rejected.
