**ORDER No. 13/32-2020 PGT II (5) DATED, PANCHKULA, THE**

Whereas, Rakesh Kumar (ID No.: 095562) has filed a CWP No. 29315 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of certiorari for quashing the impugned order of transfer dated 22.08.2019 (Annexure P-3), vide which the petitioner have been transferred from Government Senior Secondary School, Saina, Block Kanina, District Mahendergarh to Government Senior Secondary School, Kari Dharni, Block Badhra, District Charkhi Dadri.

Whereas the above mentioned writ petition was disposed of on 14.10.2019 by Hon'ble Punjab and Haryana High Court and the operative part of the order dated 14.10.2019 is reproduced here as under:

**"Prayer in the present writ petition is for quashing of impugned transfer order dated 22.08.2019 (Annexure P-3).**

**Learned counsel for petitioner submits that no person has joined in place of petitioner and the post is still lying vacant.**

**The impugned order is dated 22.08.2019, thus, transfers of PGT have already undertaken and therefore, it would not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, he is at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order.**

**With aforesaid direction, the writ petition stands disposed of."**

That whereas, the Government of Haryana has framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect

academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and a teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year service in a particular zone may seek transfer to some other station voluntarily, on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

That in compliance of the directions of the Hon'ble High Court issued vide order dated 14.10.2019, the grievance of the petitioner in his writ petition was considered and petitioner was accorded an opportunity of personal hearing and after hearing the petitioner, it was found that the petitioner has been rightly transferred vide order dated 22.08.2019 as the posts of PGT History at GSSS, Saina Mahendragarh was blocked under rationalization/ normalization process in accordance with the transfer policy. As the post of PGT History in GSSS, Saina Mahendragarh was marked as " to be kept vacant" due to number of students History in both classes 11<sup>th</sup> and 12<sup>th</sup> being as low as 20, the petitioner being surplus had to compulsory participate in the General Transfer Drive, 2019. Also, in transfer

drive he has got 47<sup>th</sup> choice of his preference i.e GSSS Kari Darni, Charkhi Dadri where 45 students of History were enrolled.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no substance in the claim of the petitioner and hence, the same is liable to be dismissed, being devoid of any merits in the interest of justice.

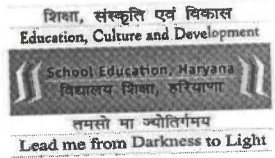

Whereas, Sh. Vikash has filed the CWP No. 14283 of 2020 titled as Vikash Vs. State of Haryana & Other before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure -P5) for transferring the petitioner from Govt. High School, Dhani Bhakra, Block Siwani, District Bhiwani to District Education Office, Fatehabad.

The above said CWP came up for adjudication on 14.09.2020 and the Hon'ble Court disposed of the same vide order dated 14.09.2020. The operative part of the order is reproduced as under:

**"Accordingly, the instant petition stands disposed of with a direction to competent authority of the respondents to take appropriate decision, treating the present petition as representation, in accordance with law, within a period of two Weeks from the date of receipt of the order by passing a speaking and reasoned order."**

In compliance of the order passed by the Hon'ble High Court the case record of the petitioner was minutely examined and it has been found that petitioner has voluntarily participated in the online transfer drive and has opted for 73 stations and has



obtained merit score of 24.6932 points, as per transfer policy. The 73<sup>rd</sup> preferred station was allocated to the employee namely Kiran Bala (101304) who obtained 56.2849 scores. The petitioner was transferred to Anywhere in the State category due to non-availability of preferred stations as the same were allotted to the persons higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, Chief Secretary to Government of Haryana, issued instructions regarding online transfer Policy on dated 07.08.2020. But process of the transfer for the clerks was started before the issuance of this letter dated 07.08.2020. As such the same is not applicable on the online transfer drive for clerks, even then the general principals of the letter dated 07.08.2020 were adopted by the department in the interest of justice.

Moreover, the seats were blocked by the department by following the proper criteria i.e. the schools in which the student strength is less than 125 were blocked for the purpose of proper utilization of the manpower available with the department, due to the process of rationalization. The same was done for the purpose of even distribution of clerks in the State, as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Therefore, the petitioner has been rightly transferred by the department in strict compliance to the transfer policy. Hence,

the representation made by petitioner is hereby rejected, being devoid of merits

Whereas, Sh. Ashok Kumar and 3 others have filed the CWP No. 14559 of 2020 titled as Ashok Kumar and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure P-1) qua the petitioners.

The above said CWP came up for adjudication on 16.09.2020 before the Hon'ble Court and the same was disposed of with the following order:

***“Without expressing any opinion on the merits of the case, the petition is disposed of with a direction to respondent No.2 to consider and decide the representation of the petitioners dated 25.08.2020 (Annexure P-4) in accordance with law within a period of three weeks from the date of receipt of certified copy of the order.”***

In compliance of the aforesaid order passed by the Hon'ble High Court the representation of the petitioners dated 25.08.2020 (Annexure P-4) was minutely examined and it has been found that the petitioners have challenged the transfer order dated 14.08.2020 on the ground that the clause 4(b) of the transfer process as per Transfer Policy is required to be completed by 31<sup>st</sup> March every year while the impugned order has been issued on 14.08.2020 which is not tenable as since 22 March, 2020 all the

administrative functions across the country were at halt due to outbreak of Covid-19 pandemic and thereupon as and when the functioning could be resumed, the transfer process was initiated.

Moreover, it has been further stated in the representation dated 25.08.2020 that numerous stations were "kept vacant" which is again not a sustainable grievance as department 'kept vacant' certain stations by following the proper criteria i.e. the schools in which the student strength is less than 125, were blocked for the purpose of proper utilization of the manpower available with the department. The same was done due to the process of rationalization and for the purpose of even distribution of clerks in the State as per mandate of Clause 4 (IV) of Online Transfer Policy of Ministerial Staff dated 06.03.2020. As far as, the contention with regard to the posting at far-away places is concerned, the petitioners have scored less merit points out of total composite score of 80 as per the online Transfer Policy. The details of the score obtained by the petitioners along with the reasons of their transfer is described as under:

In compliance of the order dated 07.09.2020 passed by the Hon'ble High Court representation dated 08.09.2020 of the petitioner was minutely examined and it has been found that the petitioner has voluntarily participated in the online transfer drive and petitioner 1 has opted for 34 stations and has obtained score of 29.5205 points, as per transfer policy. 

Whereas, the petitioner namely Sh. Pardeep Kumar has filed the CWP No. 15178 of 2020 titled as Pardeep Sharma Vs. State of Haryana & Other before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature of certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure-P5) transferring the petitioner from Government Middle School Ramu pura (4372) block Bawani khera, district Bhiwani to Block Education Office, Gurgaon (5060) block Gurgaon, district Gurugram.

The above said CWP came up for adjudication before the Hon'ble High Court on 25.09.2020 which was disposed of with the following order:

*"The transfer has been made in accordance with the online transfer policy dated 13.2.2020 (Annexure P-1). However, this Court finds that the policy itself provides in Clause No.6 (vi), that an aggrieved transferred employee can represent to the department within 15 days from the issuance of such order. Since the learned counsel for the petitioner has informed that he had in fact moved such representation dated 16.8.2020, the respondents are directed that in case any such representation has been received, the same be decided in accordance with the prevalent policy by taking into account the amendments as well, as has been made in the policy vide*

**letter dated 7.8.2020 (Annexure P-3). However, in case no such representation has been received, the petitioner would be at liberty to move fresh representation, which shall be duly examined by the respondent concerned in accordance with the policy, expeditiously**

**The petition stands disposed of accordingly”**

In compliance of the order passed by the Hon'ble High Court the representation of the petitioner dated 16.08.2020 was minutely examined and it has been found that the petitioner has voluntarily participated in the online transfer drive and petitioner has opted for 7<sup>th</sup> stations and has obtained score of 35.6027, as per transfer policy. The 7<sup>th</sup> preferred station i.e the last preferred station by the petitioner was allocated to the petitioner. Whereas, the petitioners Sh. Varun Dev and 3 others have filed the CWP No. 14464 of 2020 titled as Varun Dev and others Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, praying therein for the issuance of writ in the nature certiorari for quashing the impugned transfer order dated 14.08.2020 (Annexure P-1) qua the petitioners.

The above said CWP came up for adjudication on 15.09.2020 before the Hon'ble Court and the same was disposed of with the following order:

***“Keeping in view of the facts and circumstances as above, as well as limited prayer addressed at this stage, but without expressing any opinion on the merits of this case, this writ petition is disposed of with a direction that in case the petitioners submit a representation(s) before the Grievance Committee within one week, the same shall be decided in accordance with applicable provisions, within a period of two weeks thereafter, in terms of the statement made by learned counsel for the State today.”***

 In compliance of the aforesaid order passed by the Hon'ble High Court the representation of the petitioners already appended by the petitioners in the writ dated 25.08.2020 was minutely examined

and it has been found that the petitioners have challenged the transfer order dated 14.08.2020 on the ground that the clause 4(b) of the transfer process as per Transfer Policy is required to be completed by 31<sup>st</sup> March every year. while the impugned order has been issued on 14.08.2020 which is not tenable as since 22 March, 2020 all the administrative functions across the country were at halt due to outbreak of Covid-19 pandemic and thereupon as and when the functioning could be resumed, the transfer process was initiated.

Moreover, it has been further stated in the representation dated 25.08.2020 that numerous stations were "kept vacant" which is again not a sustainable grievance, as the department 'kept vacant' certain stations by following the proper criteria i.e. the schools in which the student strength is less than 125, were blocked for the purpose of proper utilization of the manpower available with the department. The same was done due to the process of rationalization and for the purpose of even distribution of clerks in the State as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020. As far as, the contention with regard to the posting at far-away places is concerned, the petitioners have scored less merit points out of total composite score of 80 as per the online Transfer Policy. The details of the score obtained by the petitioners along with the reasons of their transfer is described as under:
