SHOW CAUSE NOTICE

No. 6/35-2016 HRG-II (2)

Dated, Chandigarh the 28/8/2020

Whereas vide Order No. 04/09-2013 HRG-II(1) dated 10.02.2014, to granted promotion to 860 Elementary School Headmaster(s) was granted to post of Headmaster High School (HES-II) under the Haryana State Education School Cadre (Group B) Service Rules, 2012 but this promotion order was challenged before the Hon'ble Punjab & Haryana High Court Chandigarh by Smt. Anju Kumari Sharma & others by way of filing a **Civil Writ Petition i.e. No. 2884 of 2014** to quash the order qua Classical & Vernacular teachers e.g. Hindi Teacher, Punjabi Teacher & Sanskrit Teacher. The above said writ petition was heard with a bunch of writ petitions mainly in **CWP No. 4301 of 2013- Sartaj Singh Dhanda & others versus State of Haryana & others**. The writ petition was allowed on 22.12.2015. The operative part of order is reproduced herein as under:

“In view of the facts as well as law position as discussed above, the present petitions deserve to be allowed and the impugned orders dated 20.02.2013 (*in CWP No.4301, 23444, 8184, 8105, 6134 and 10223 of 2013*), 28.01.2014 (*in CWP No.2884 and 2872 of 2014*), 10.02.2014 (*in CWP No.10922 and 12949 of 2014*) are hereby quashed. A direction is also issued to the official respondents to consider the candidatures of all eligible candidates, who fulfil the requisite qualifications/experience as per amended Rules of 2012 within a period of three months from the date of receipt of certified copy of this order and pass necessary orders accordingly.”

The petitions are allowed accordingly.”

The operative and applicable extracts of statutory Service Rules 2012 are as under:

9. Method of Recruitment: (1) Recruitment in the Service shall be made:-

- b) in the case of Head Master of High School:-**
 - (i) 100% by promotion from amongst Elementary School Head Masters/TGTs;**
 - Or**
 - (ii) by transfer or deputation of an official already in service of any State Government or Government of India.**

The requisite academic qualifications as well as experience, if any, for appointment other than by direct recruitment i.e. promotion/transfer has been provided under Appendix-B to Rule-7 of these Service Rules, 2012 which says as under:

By Promotion:-

- (i) B.A./B.Sc./B.Com with B.Ed.;**

AND

- (ii) **8 years experience as Head Master of Elementary School/TGT in regular capacity;**

AND


- (iii) **At least 3 weeks in-service training in administrative and accounts module.**

Since you have neither been appointed on post of TGT nor you completed 8 years of service on post of Elementary School Headmaster, therefore, you were not found eligible to this promotion i.e. post of Headmaster High School and liable to be reverted.

But in the meantime, Hon'ble High Court has stayed the reversion order in **LPA No. 1208 of 2016 - Dalip Singh & others. Vs. State of Haryana & others.** However, this LPA came for hearing on 31.10.2019 and the Hon'ble High Court was pleased to allow the withdrawal of the same with liberty to file review application.

Now, the candidature of all 860 ESHMs who were earlier promoted to post of Headmaster High School vide order dated 10.02.2014 has been examined again and it has been found that you are not entitled for the promotion on the post of Headmaster High School under above-said Service Rules 2012. Accordingly, you are liable to be reverted in compliance of Hon'ble High Court orders dated 22.12.2015 passed in CWP No. 4301 of 2013.

But before issuing the order of reversion, you are, hereby, given a show cause notice to explain that why you should not be reverted. You are hereby advised to file your reply to this show cause notice within a period of 15 days, otherwise, it would be assumed that you have nothing to submit and further action/order be taken accordingly.




