**Dated, Chandigarh, the 9.9.2020**

Whereas, a compliant was made by Gram Panchayat Sherpur (Ambala) and others against Sh. Gulab Singh, the then Headmaster in Government High School Sherpur (Ambala) now Govt. Girls High School Mulana (Ambala) to Chief Election Commissioner of Haryana regarding his participation in the political activities and supporting the candidate of Bahujan Samaj Party. The complaint was forwarded to the Education Department by the Election Commission, Haryana and the same was inquired by the District Education Officer, Ambala, who submitted his fact and finding report on 03.10.2009 in the Directorate. On the basis of report of District Education Officer, Ambala, Sh. Gulab Singh was charge sheeted U/R-7 of Haryana Civil Services (Punishment and Appeal Rule), 1987 with the following allegations against him:-

1. That Sh. Gulab Singh, was absent without intimation from school on 02.12.2008, 03.12.2008, 16.10.2009 & 21.10.2009 and he is habitual absentee.
2. That Sh. Gulab Singh had participated in election rally organized by Sh. Maan Singh Manheda (Secretary of Bahujan Samaj Party) on 03.12.2008.
3. That Sh. Gulab Singh distributed the Scholarship amount of Rs. 1,69,930/- which was for the upliftment of students of scheduled castes after 57 days despite the fact that this amount was deposited in school's Bank Account on 10.08.2009. It is mandatory that the amount to be distributed within 15 days because timely distribution of scholarship amount is the main motive of any welfare scheme.

In view of the said allegations Sh. Gulab Singh was directed to file the reply to charge-sheet. The delinquent submitted his reply to chargesheet but the same was not found satisfactory. Therefore, a regular enquiry was conducted by Sh. Satbir Singh, HCS the then Additional Director (Administration). In the regular enquiry, allegations levelled against him, were found proved. The copy of the said enquiry report was sent to Sh. Gulab Singh for producing any evidence in his defense. He submitted the reply in that regard. The reply was duly examined and after considering all the facts, it was found that he did not produce any evidence in his defense. Thereafter, a show cause notice was given on 05.10.2015 to him to the effect that why his service not be dismissed with 15 day's time for submitting any evidence in his




defense. Sh. Gulab Singh had given the reply to show cause notice but he again failed to provide any evidence in his defense.

Thereafter, Sh. Gulab Singh instead of challenging the show cause notice before the Government by way of administrative appeal, approached the Hon'ble Civil Court wherein the said show cause notice was set aside by the Learned Civil Court vide order dated 14.10.2015 but the department challenged the order of Civil Court before the District Judge, Ambala wherein the order of Ld. Civil Court was set aside vide order of Learned Additional District Judge, Ambala dated 29.11.2018. Sh. Gulab Singh had also filed the Regular Second Appeal (RSA) against the order of Ld. District Judge but same was dismissed by the Hon'ble High Court vide order dated 24.01.2019 and thus, the final judgment was in the favor of department.

Now, after going through all facts of present matter, report of inquiry officer as well as judgment of Hon'ble High Court dated 24.01.2019, it is clear that Sh. Gulab Singh was given full opportunity as per law for producing evidence in his defense. But he failed to produce any evidence to prove his innocence.

Therefore, allegations against Sh. Gulab Singh were proved and he was found guilty of misconduct under Rule 7 of Haryana Civil Services (Punishment and Appeal), Rules 1987. Accordingly, the Governor of Haryana is pleased to confirm the show cause notice vide order dated 5/37-2009 HRG-II(2) dated 30.09.2015/ 05.10.2015 and dismiss him from the service with immediate effect.
