Whereas the petitioners namely Sh. Satyavir Singh Yadav & others filed CWP No. 34635 of 2019 titled as Satyavir Singh Yadav & Others Vs State of Haryana & Others praying therein for quashing the action of the respondents for not considering the cases of the petitioners for State Teachers Award for the year 2019 on the ground that petitioners are working in DIET and shall not be considered for State Teacher Award in terms of letter dated 01.08.2019 and to issue a writ in the nature of Mandamus directing the respondents to consider the names of the petitioners for State Teacher Award 2019 and further, to issue any other appropriate order/direction which this Hon'ble Court may deem fit.

The abovesaid case came up for hearing before the Hon'ble High Court on 28.11.2019 and the Hon'ble High Court disposed of the same vide order dated 28.11.2019. The operative part of the order is reproduced as under :-

*"----- [3] Without commenting upon the merits of the claim or the entitlement of the petitioners to the relief claimed, the writ petition is disposed of, by granting liberty to the petitioners to submit a representation to respondent No.2 within 03 weeks from date of receipt of certified copy of order. On receipt of the representation within the stipulated period of time, respondent No.2 shall consider and decide the same, in accordance with law within a period of 02 months thereafter ----"*

In compliance of the Hon'ble High Court order dated 28.11.2019, the representation of the petitioners was examined and in this regard, it is stated here that the State Govt. has issued instructions bearing No. 20/2-2016 CO(1) dated 01.8.2019 vide which the criteria for awarding State Teacher Award was circulated to all District Education Officers in the State

as well as other authorities related to Education Department in the State. It was asked to forward the recommendation from their relevant districts in terms of criteria framed by State Govt. From the perusal of the said criteria, it is clear that the marks to be given to PGTs were based on the results of Class 9th to 12th only and no other result had any relation with the awards.

It is pertinent to mention here that the petitioners are working in DIET Mahendergarh/Sonipat, thus, they are not directly involved in the teaching of school level students from Class 9th to 12th. The State Teachers Award is meant for those who are teaching at School Level (Elementary/ Secondary) whereas the DIETs are imparting Teacher Training to the incumbents pursuing to opt the teaching as service career. Although there are several other components of teaching in DIETs, however, none of them is related to the direct teaching of school cadre students.

Under the head "C. Procedure for Selection" mentioned in the Criteria circulated vide instructions bearing No. 20/2-2016 CO(1) dated 01.8.2019, it is clearly mentioned that the recommendation forwarded by the District Level Committee shall be examined by the State Level Committee constituted at Headquarter level, who will finally recommend the names of the teachers for State Award to the State Government.

The respective District Level Committees had forwarded the case of the petitioners to State Level Committee for State Teacher Award 2019, however, after examining the same, the State Level Committee found the petitioners ineligible since they are not involved in teaching of school cadre students. Therefore, their names were struck off by the State Level Committee.

Also, the petitioners were well aware with the fact that they were not teaching classes 9th to 12th and would have no weightage on the basis of results. If they were aggrieved from any provision of the State Teacher Award criteria, then instead of applying for the same, they had to bring

their grievances before the competent authority. However, they intentionally succeeded to get their names forwarded through relevant District Level Committees which were rightfully struck off by the State Level Committee while examining the same.

Therefore, the petitioners are not eligible for State Teachers Award 2019. Hence, their claim is liable to be rejected.

I order accordingly.

Whereas, Late. Shri Subhash Chander [045605] Principal, Government Senior Secondary School, Badwasani [3440] Sonapat was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 on 04.10.2013 and the following allegations were leveled against him:-

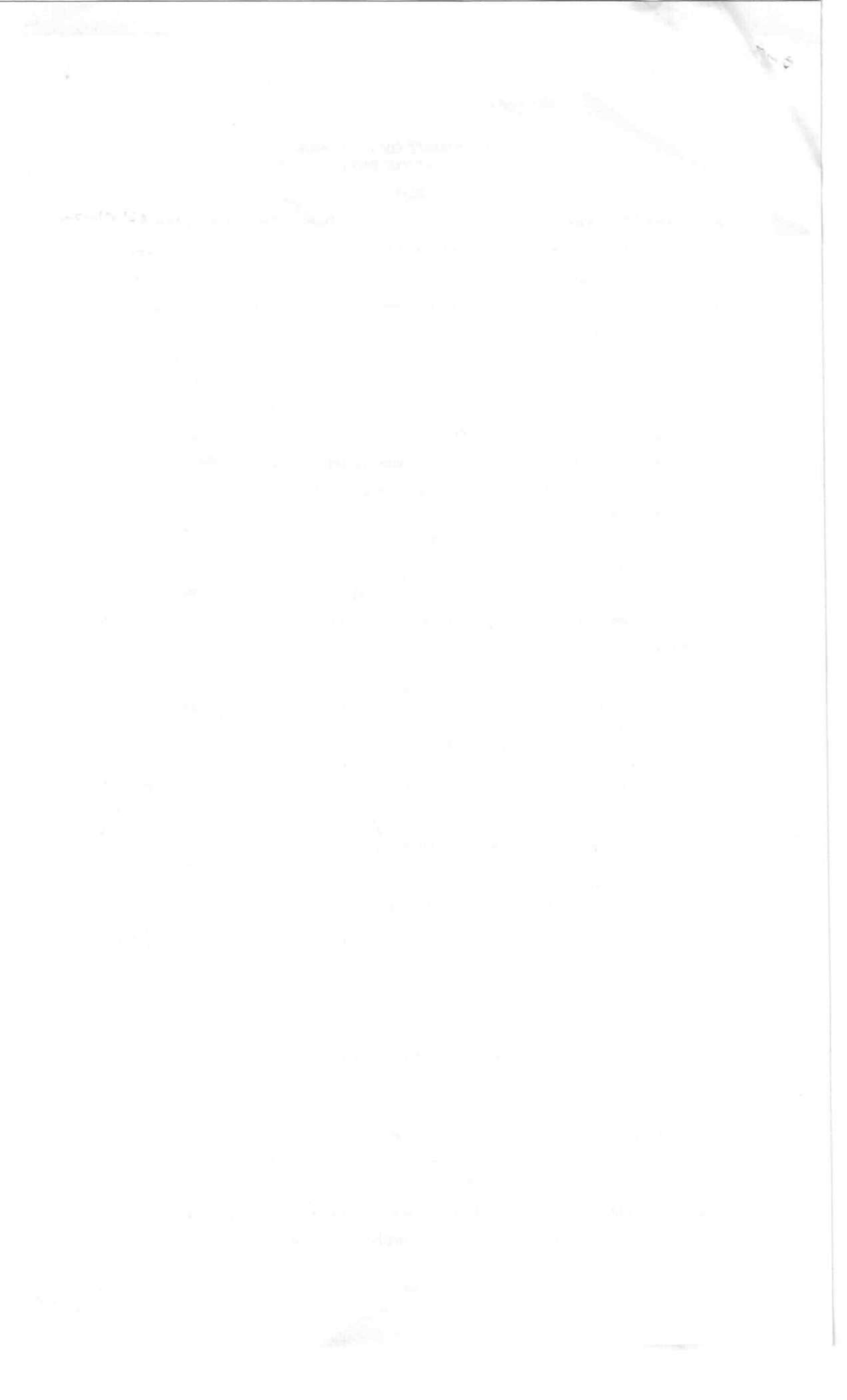
That he was caught red handed for accepting bribe from the stationery supplier. Consequently, FIR No. 22 dated 27.09.2012 u/s 7 and u/s 13 of prevention of Corruption Act 1988 (Act 49 of 1988) was registered against him in State Vigilance Bureau Rohtak. Apart from that, the delinquent was placed under suspension vide order dated 23.10.2012/05.1.2012 on the basis of report of District Education Office, Sonapat dated 01.10.2012. Thereafter, prosecution sanction was also issued by the Government on 16.01.2013.

The delinquent submitted his reply to charge-sheet dated 17.10.2013 and denied the allegations leveled against him but the same was not found satisfactory. Further, the Hon'ble Court of Shri Jagdeep Singh, Special Judge (Additional Session Judge), Sonapat passed the order dated 29.01.2015 and the operative part of order is reproduced as under:-

*"...convict Subhash Chander who has been convicted under section 7 and 13(I)(d) of the Prevention of Corruption Act, is directed to undergo rigorous imprisonment for a period of one year and pay fine of Rs 2000/- for the commission of offences punishable under section 7 of the Prevention of Corruption Act, 1998 and in default of payment of fine to undergo imprisonment for a period of two months in addition to substantive sentence so awarded. Convict is further directed to undergo rigorous imprisonment for a period of two years and pay fine of Rs 4000/- for the commission of offence punishable under section 13(I)(d) of the Prevention of Corruption Act, 1998 and in default of payment of fine to undergo imprisonment for a period of three months in addition to the substantive sentence so awarded".*

Thereafter, Shri V.P Batra, IAS (Retd) was appointed as an Inquiry Officer, vide order dated 24.11.2017/18.12.2017 to hold a regular departmental enquiry report. In the regular enquiry dated 15.03.2019, charges were proved against the delinquent.

Since, the charges were found proved against the delinquent, the findings of I.O dated 15.03.2019 were forwarded to the charged officer on 26.06.2019 as per provision of Rule 7 (C) (1) of HCS (P&A) Rules, 2016 but the charged officer did not respond to the findings of the I.O. Thereafter, the charged officer was granted opportunity of personal hearing by the competent authority and it was report by District Education Officer, Rohtak vide letter no.E-7/2019/1106 dated 23.12.2019 that charged officer i.e. Shri Subhash Chander has expired on 09.08.2019 and death certificate dated 03.09.2019 was also furnished. Consequently, the matter was




referred to Legal Remembrance, Haryana for seeking advice and operative part of opinion tendered by Legal Remembrance, Haryana is reproduced as under:-

*"...the pending disciplinary proceedings (not culminated into finality) after the death of the employee concerned stand abated if the employee died prior to conclusion of disciplinary/criminal proceedings as the mis-conduct is something absolutely personal to him".*

Keeping in view the above said facts of the case and opinion of Legal Remembrance, Haryana, the Governor of Haryana Government of Haryana is pleased to file the present charge sheet.
