Whereas Sh. Harish Bansal S/o Sh. Devi Chand Bansal aged 40 years approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.30313 of 2019- Harish Bansal Vs. State of Haryana & others praying therein for issuance of a writ in the nature of certiorari to get quashed the order of rationalization of post of TGT Science dated 27.08.2019 qua petitioner school only. The writ petition came for hearing before the Hon'ble High Court on 19.10.2019 wherein Hon'ble High Court pleased to dispose of the writ petition with following directions:-

***"Prayer in the present writ petition is for quashing of impugned transfer order dated 06.09.2019 (Annexure P-6).***

***The impugned order is dated 06.09.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.***

***With aforesaid direction, the writ petition stands disposed of."***

Considering the above said order, the petitioner failed to submit any representation against the rationalization of his post as well as his adjustment through online transfer still the Directorate waited for his representation, lastly issued a letter dated 06.07.2020 through which the petitioner has been granted an opportunity of personal hearing at 11:00 AM on 14.07.2020.

 The petitioner appeared in person and was heard. He submitted all his grievances. He submitted that he was rendering service at Govt. Middle School Fathupur (2356), Block- Thanesar, District- Kurukshetra and he has been transferred to Govt. Senior Secondary School Raison (1901), Block- Nilokheri, District- Karnal vide transfer order No.7/37-2019 HRM-II (3) dated 06.09.2019. The new place of posting is far away from his residence.


Having submissions on behalf of petitioner, the service record of the petitioner has been pursued. After due perusal, it has been observed that the petitioner had never submitted any representation against rationalization of his post prior to participate in the transfer drive. While taking part in transfer drive voluntarily and knowingly, the petitioner submitted more than 37 options for his next posting. He has been allocated Govt. Senior Secondary School Raison (1901), Block- Nilokheri, District- Karnal as per his own choice, therefore, after having transfer/adjustment order at a opted school, the petitioner has no locus standi to impugn the same now by way of filing a writ petition.



It has also been observed that the petitioner has nothing to say about any other TGT (Science) who has less composite marks but has been allocated a school of his first 36 choices. Hence, the allegations of discrimination and arbitrariness could not be got approved.

After considering all the submissions as well as other aspects of his service, the petitioner has also failed to establish his locus standi to have posting nearby his residence. Considering this fact, it is concluded that the present claim of the petitioner is baseless and meritless, accordingly, the relief claimed cannot be granted and the present representation against transfer order dated 06.09.2019 deserves to be rejected.
