





Rattan Singh. Leave to appeal against acquittal was also dismissed by the Hon'ble High Court vide order dated 24.07.2018. Departmental Inquiry was also conducted by Sh. D.D. Gautam IAS (Retd.) and it was found that charges leveled upon him do not stand proved.

Considering the above factual position, I being competent disciplinary authority is of the considered view that after being acquitted from Hon'ble Trial Court and dismissal of leave to appeal from Hon'ble High Court, the Charge Sheet under Rule-7 is hereby dropped and Suspension Period is to be treated as duty period for all intents and purposes under the relevant Statutory provisions and Rule 89 of Haryana Civil Services (General) Rules, 2016.
