- 3. Block level:- Name and mobile number of BEO/the person discharging duties of the post of BEO
- 4. Number of Blocks as shown in the list of Blocks herein is more than the actual educational blocks. In case of extra Block, name and mobile number of senior principal/DIET principal chosen by the DEO concerned may be given.

## 5. Urban Local Bodies:-

For urban local bodies (ULBs), the name of such person be given who is capable of working as coordinator of consulative meeting for that particular ULB and must be readily available for discussion etc. Such person may be Member of ULB or former educationist or eminent person from the locality etc. Respective DEO shall finalize the ULB list in consultation with concerned BEO.

## 6. Village:-

The seniormost Principal / School Head / School Incharge, in case of more than one school in the same village has been designated as the nodal officer for that particular village. He/she shall give the name and mobile number of a person resident of the village to work as co-ordinator of village level consultative meeting for NEP. The person may be a SMC member, retired teacher, ex service man or any other villager from the



- village but he/she should be capable and responsible to work as coordinator. Further, he/she should be readily accessible.
- 7. The list of villages is to be verified at the BEO level confirming that no village has left out of the list and the name of the leftout village, if any, must be brought into notice of DEO and HQ at <a href="mailto:nep2015hry@yahoo.in">nep2015hry@yahoo.in</a> immediately.
- 8. List of all the villages must be compiled at BEO level and subsequently at the DEO level absolutely in that order.
- 9. The list of entire villages and blocks must be sent only after verifying the entries. Please ensure that no field is left blank.
