

Whereas, Shri Satbir Singh Siroha, District Education Officer, Panipat (Retd.) office of Director Secondary Education Haryana, Panchkula was charge-sheeted under rule -7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide Order No. 5/116-2008 HRG-I(1)/2969 dated 03.03.2016, wherein the following allegation was leveled against him:-

*"...the pending disciplinary proceedings (not culminated into finality) after the death of the employee concerned stand abated if the employee died prior to conclusion of disciplinary/criminal proceedings as the mis-conduct is something absolutely personal to him".*

Keeping in view the facts and circumstances of said matter and opinion of L.R. Haryana tendered in similar situated matter, The Governor of Haryana is taking lenient view and pleased to file the present charge sheet.
