**ORDER**

**Terms and conditions:-**

1. He/She is appointed purely on temporary basis.
2. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.



6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned along with photostate self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.
15. The appointment will be subject to the final outcome of CWP No. 18514 of 2016 & connected petitions pending for adjudication in the Hon'ble High Court and SLP No 25184-25214 of 2018 titled as



Haryana Staff Selection Commission etc V/S Priyanka & Others pending for adjudication in the Hon'ble Supreme Court of India.

16. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.



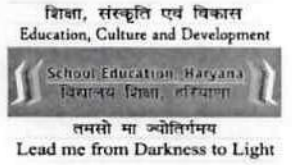



In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education, Rules, 2003, sanction is hereby accorded to grant permanent recognition to Shanti Niketan Public High School, Vill. Banchari, Distt. Palwal by Managing Committee, Shanti Niketan Shiksha Samiti, S.N.P. High School, Campus Prem Patti, Banchari, Tehsil Hodal, Distt. Palwal for classes 9<sup>th</sup> to 10<sup>th</sup> under **BOSE** pattern with effect from 01.04.2020 under following terms and conditions:-

**TERMS & CONDITIONS:-**

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

#### TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.

**Statement of allegation against Smt. Santosh Kumari [054226], Principal, Government Senior Secondary School, Sampla [2679], Rohtak.**

While posted as Principal at Government Senior Secondary School, Sampla [2679], Rohtak from 06.09.2017 to till date, Smt Santosh Kumari committed following acts of omission and commission:-

1. That the District Education Officer, Rohtak submitted report to the Deputy Commissioner, Rohtak vide letter no. E-2/20/3815-18 dated 04.03.2020 wherein it was concluded that board examination for classes 10<sup>th</sup> and 12<sup>th</sup> were being commencing from 03.03.2020 to be conducted by the Haryana Board of Secondary Education, Bhiwani for which four female Post Graduate Teachers (PGTs), were appointed as observer for conducting examination for which directions were given to her i.e. Smt Santosh Kumari on her mobile number and Smt Krishna Devi, PGT, History, was appointed with Special Task Force-I Flaying Squad as female employee but she i.e. Smt Santosh Kumari denied to relive the said Krishna Devi and Smt Krishna Devi was to be relived by Block Education Officer. Apart from this, she i.e. Smt Santosh Kumari polluted the environment of the school by calling the media at the examination centre on 03.03.2020 and video clip of the same viral on Janta TV as social media although outsiders were prohibited at the examination centre.
2. That, in addition to this, a committee was constituted by the Deputy Commissioner, Rohtak to enquire into complaint regarding withholding salary of the staff of the Government Senior Secondary School, Sampla, Rohtak wherein Tehsildar Sampla and District Education Officer, Rohtak were the members. In this context, the District Education Officer, Rohtak had submitted report vide letter no. E-2/2020/3926 dated 06.05.2020 wherein it was concluded that she i.e. Santosh Kumari failed to produce the relevant record of withholding of salary of staff before the committee and also failed to assist the Inquiry Committee by not appearing before the committee on 06.05.2020. She i.e. Smt Santosh Kumari also misused the Drawing and Disbursing Powers with malafide intentions.

In this way, she i.e. Smt Santosh Kumari committed an act unbecoming of a Government officer by withholding the salary of staff of school with malafide intention by misusing the drawing and disbursing powers. Thus, acted in a negligent and irresponsible manner and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services, (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Smt. While posted as Principal at Government Senior Secondary School, Sampla [2679], Rohtak from 06.09.2017 to till date, Smt Santosh Kumari committed certain acts of omission and commission for which she is charged as under.

1. That the District Education Officer, Rohtak submitted report to the Deputy Commissioner, Rohtak vide letter no. E-2/20/3815-18 dated 04.03.2020 wherein it was concluded that board examination for classes 10<sup>th</sup> and 12<sup>th</sup> were being commencing from 03.03.2020 to be conducted by the Haryana Board of Secondary Education, Bhiwani for which four female Post Graduate Teachers (PGTs), were appointed as observer for conducting examination for which directions were given to her i.e. Smt Santosh Kumari on her mobile number and Smt Krishna Devi, PGT, History, was appointed with Special Task Force-I Flaying Squad as female employee but she i.e. Smt Santosh Kumari denied to relive the said Krishna Devi and Smt Krishna Devi was to be relived by Block Education Officer. That, in addition to this, a committee was constituted by the Deputy Commissioner, Rohtak to enquire into complaint regarding withholding salary of the staff of the Government Senior Secondary School, Sampla, Rohtak wherein Tehsildar Sampla and District Education Officer, Rohtak were the members. In this context, the District Education Officer, Rohtak had submitted report vide letter no. E-2/2020/3926 dated 06.05.2020 wherein it was concluded that she i.e. Santosh Kumari failed to produce the relevant record of withholding of salary of staff before the committee and also failed to assist the Inquiry Committee by not appearing before the committee on 06.05.2020. She i.e. Smt Santosh Kumari also misused the Drawing and Disbursing Powers with malafide intentions.

In this way, she i.e. Smt Santosh Kumari committed an act unbecoming of a Government officer by withholding the salary of staff of school with malafide intention by misusing the drawing and disbursing powers.
