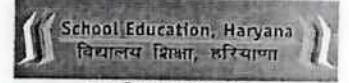

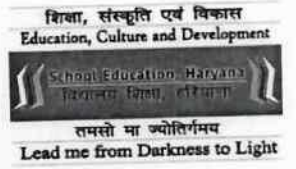

Sh. Dharambir Baldodiya [034087], District Education Officer, (now retired) is hereby informed that it is proposed by the Governor of Haryana to take action against him under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016, read with rule 12.2(b) of Haryana Civil Services (Pension) Rule, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

2 **Sh. Dharambir Baldodiya** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.

3 **Sh. Dharambir Baldodiya** is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, **Sh. Dharambir Baldodiya**, wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Sh. Dharambir Baldodiya** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

Statement of charges against Sh. Dharambir Baldodiya [034087], the then District Education Office, Rewari [now retired]

While being posted as District Education Officer, Rewari from 04.05.2015 to 28.02.2018, **Sh. Dharambir Baldodiya** committed certain acts of omission and commission for which he is charged as under :-

That he i.e. Sh. Dharambir Baldodiya was directed vide letter dated 11.05.2015 and 20.08.2015 to comply with the Hon'ble High Court order dated 22.09.2011 passed in CWP No. 5919 of 1990 titled as Vishnu Dutta Vs State of Haryana. But he i.e. Sh. Dharambir Baldodiya failed to comply with the said order dated 22.09.2011, as the benefits alongwith 6% interest on the arrears was not extended to the petitioners i.e. Sh. Puran Mal Sharma by him. As such he i.e. Dharambir Baldodiya acted in negligent manner and took the orders of Hon'ble High Court in very casual manner. Thus, he i.e. Dharambir Baldodiya failed to comply with said order dated 22.09.2011 completely due to his negligence, Hon'ble High Court vide order dated 15.10.2019 directed to Chief Secretary, Haryana to be present on the next date of hearing i.e. 11.11.2019. This was serious lapse on his part i.e. Dharambir Baldodiya.

In this way, he i.e. Sh. Dharambir Baldodiya committed an act unbecoming of a Government officer by performing his duty in a casual manner, and irresponsible manner and neglect of Hon'ble High Court by non compliance of the same completely and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services, (Government Employees Conduct) Rules, 2016

The lapses detailed above constitute grave misconduct on the part of Sh. Dharambir Baldodiya [034087], the then District Education Office, Rewari [now retired], rendering him liable for strict disciplinary action under rule-7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12 (2) (b) of the Haryana Civil Services (Pension) Rules, 2016.

Statement of allegations against Sh. Dharambir Baldodiya [034087], the then District Education Officer, Rewari (now retired).

While being posted as District Education Officer, Rewari from 04.05.2015 to 28.02.2018, Sh. Dharambir Baldodiya committed following acts of omission and commission :-

That CWP No. 5919 of 1990 ,titled as Vishnu Dutta & others versus State of Haryana and others, was filed by the petitioner i.e. Sh. Puran Mal Sharma with prayer for counting their previous service rendered in aided school towards pensionery benefits which was decided by the Hon'ble High Court on 22.09.2011 in terms of the order dated 22.09.2011 passed in similar situated Civil Writ Petition No. 15229 of 1989 whereby the claim of the petitioners was allowed by granting the benefit counting the service of privately aided school towards pensionery benefits alongwith 6% interest on the arrears. In compliance of said order dated 22.09.2011 passed by the Hon'ble High Court, the claim of the petitioner i.e. Sh. Puran Mal Sharma was partially settled and sanction of 6% interest on the arrears was not released to the petitioner. Feeling aggrieved, the petitioner i.e. Puran Mal Sharma filed COCP No. 917 of 2013 in CWP No. 5919 of 1990 titled as Puran Mal Sharma & others Vs Smt. Surina Rajan, IAS & anothers for non compliance of said order dated 22.09.2011 which was disposed of by the Hon'ble High Court on 12.01.2017 on the basis of statement of Shri Narender Rana, Assistant, office of the Director, Elementary Education, Haryana that the outstanding claims of Shri Yash Pal Kundu have since been released after adjustment. Thereafter, CM No. 17145-CII of 2019 was filed by the petitioners i.e. Sh. Puran Mal Sharma & others for granting the interest @6% on the arrears. Further, he i.e. Shri Dharambir Baldodiya was directed vide letter dated 11.05.2015 and 20.08.2015 to comply with the Hon'ble Court order dated 22.09.2011, but nothing fruitful had been done on his part i.e. Dharambir Baldodiya due to his negligence the Hon'ble High Court ordered on 15.10.2019 that let the Chief Secretary, Haryana remained present on next date of hearing i.e. 11.11.2019. This was a serious lapse on his part i.e. Sh. Dharambir Baldodiya being a senior officer, who took the Hon'ble High Court orders in a very casual manner without examining the record and said order dated 22.09.2011 passed by the Hon'ble High Court in CWP No. 5919 of 1990 as the benefits of 6% interest along with arrears was not extended to the petitioner i.e. Sh. Puran Mal Sharma.

In this way, he i.e. Sh. Dharambir Baldodiya committed an act unbecoming of a Government officer by performing his duty in a casual and irresponsible manner and neglect negligent the orders of Hon'ble High Court by non compliance of the same

completely and violated the provisions of rule 4(1)(i)(ii) and (iii) and (2) of the Haryana Civil Services, (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Dharambir Baldodiya [034087], the then District Education Office, Rewari [now retired], rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12 (2) (b) of the Haryana Civil Services (Pension) Rules, 2016.



Statement of allegations against Shri Kanwar Singh [051329] the then, Principal Government Senior Secondary School, Sihma (Mahendergarh) [3899] [now posted at Government Senior Secondary School, Deroli Ahir [3868], [Mahendergarh]

While being posted as Principal, Government Senior Secondary School, Sihma (Mahendergarh) from 08.09.2017 to 22.08.2019 and Drawing & Disbursing Officer of Government Senior Secondary School, Bhungaraka from 01.08.2015 to 28.03.2016, Shri Kanwar Singh committed following acts of omission and commission:-

That Shri Ram Niwas S/o Shri Brahm dutt, village Madalana, Post office Dharnsu, Mahendergarh, had made the complaint dated 22.10.2019 against him i.e. Shri Kanwar Singh alleging therein that he i.e. Shri Kanwar Singh the said principal had made misappropriation in utilizing the grant of Rs 17,87,000/-. In this regard, District Education Officer, Narnaul was directed on 04.07.2019 to get the matter enquired with the assistance of one expert from engineering wing and as such, report was submitted vide letter no. Steno/2019/231 dated 18.12.2019 by the District Education Officer, Narnaul wherein it was mentioned that a committee of Shri Vijendera Singh, Block Education Officer, Nangal Chaudhary, Inderpal, Junior Engineer, Shri Balwant Singh, Junior Engineer and Shri Jagbir Dagar Accountant was constituted and the said committee concluded in the report that the grant of amounting to Rs 17.87 Lacs, was released vide letter no. 2/31-2017 Works(1) dated 20.07.2019 for construction of three rooms, dismantling of 15 rooms, one girl toilet and one boys toilet and following financial irregularities were found to be committed on his part i.e. Shri Kanwar Singh:-

1. That he i.e. Shri Kanwar Singh got dismantled only three rooms although the grant was released for dismantling 15 rooms, one girl toilet and one boys toilet. Further, he i.e. Shri Kanwar Singh got constructed three rooms without constituting a committee and neither technical member was associated by him nor any utilization certificate was submitted. Further, three rooms were got dismantled by him instead of 15 rooms and neither the scrap material was got evaluated by him nor any tenders were invited for the sale this scrap material. In addition to this neither the approval of higher authorities was obtained by him nor any advertisement was given in newspapers.
2. That Shri Vijay Kumar, Clerk on 03.11.2019 and Shri Naresh Kumar, Principal on 06.11.2019 who remained post at Government Senior Secondary School, Sihma prior to him i.e. Shri Kanwar Singh had given in writing that one iron locker and one generator was available with the school. In this context, Shri Rajender Singh, PGT Math had given a statement that he i.e. Shri Kanwar ^{Singh} ~~Pal~~ sold the said generator to Shri Balram Yadav, Village Akbarpur Ram (Nangalia) for Rs 12,500/- but record of such transaction was not found available in the school record.
3. That he i.e. Shri Kanwar Singh deposed before the enquiry committee that an amount of Rs 44,000/- was drawn from 'Parent Teachers Association' fund on 08.08.2019 and was utilized for dismantling of rooms although the department has already sanctioned the grant for dismantling of rooms. Thus, he i.e. Shri Kanwar

Singh had embezzled this grant i.e. Rs 44,000/- from 'Parent Teachers Association' fund and caused loss to the State Exchequer.

4. That he i.e. Shri Kanwar Singh had drawn an amount of Rs 1 Lac and 2 lacs on 01.06.2018 & 17.10.2018 respectively from Sanchayika Fund in violation of Sanchaika Rules and no record of expenditure of the said grants was found to be maintained by him i.e. Shri Kanwar Singh. Further, he i.e. Shri Kanwar Singh stated that this grant was utilized for construction work but neither any technical member was got associated by him nor any committee was constituted for construction. Apart from this, Smt Savita Rani, Part Time mentioned that the said cheques were encashed by her and amount was handed over to him i.e. Shri Kanwar Singh. Thus, an amount of Rs 60,000/- was also got embezzled by him i.e. Shri Kanwar Singh.

Dharnsu, Mahendergarh had made the complaint dated 22.10.2019 against him i.e. Shri Kanwar Singh alleging therein that he i.e. Shri Kanwar Singh the said principal had made misappropriation in utilizing the grant of Rs 17,87,000/-. Whereas, Jaibir (Employee ID No.: 201862) PGT History has filed the CWP No. 30312 of 2019 before the Hon'ble High Court in the nature of certiorari for quashing the impugned order dated 22.08.2019 (Annexure P-3 to Annexure P-17) and further directing the respondents to unblock the post which has been kept blocked and also further include the Guest Teachers in the Transfer Drive.

Whereas the above mentioned writ petition was disposed of on 18.10.2019 and the operative part of the order is reproduced as under:

"Prayer in the present writ petition is for quashing of impugned transfer orders dated 22.08.2019 (Annexure P-3 to P-17).

The impugned orders are dated 22.08.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioners are aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioners within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.

With aforesaid direction, the writ petition stands disposed of."

Whereas, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended

on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station voluntarily while on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization/Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.

Whereas, in compliance of the above directions of the Hon'ble High Court dated 18.10.2019 the petitioner was accorded an opportunity of personal hearing on 03.07.2020. During the hearing the

petitioner has submitted that during General Transfer Drive, 2019 the web-portal transferred him from Jhajjar to Hisar under 'anywhere category' and again in Grievance Redressal Drive he has been posted in Mewat, whereas he belongs to Rest of Haryana cadre. He also submitted GSSS Chappar being in zone 7 was not available to him as a preference. He requested to adjust him nearby due to family problems. The case of the petitioner is examined and it was found that consequent upon completion of his 5 years in present zone (Zone 7), transfer drive was activated compulsorily for him as per policy. He also exercised his option for filling preferences, but got station under 'anywhere category' due to low merit points/less choices. GSSS Chappar [3242] was not offered in drive as this post was marked as "to be kept vacant" under normalization policy, so was not available to anyone. In Grievance Redressal Drive, he got station in Mewat District as his 5th choice.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no substance in the representation of the petitioner and the same is liable to be rejected being devoid of any merits.

I order accordingly.
