Whereas Smt. Sunita Goyal, PGT (Economics), Govt. Senior Secondary School, Kardhan Distt. Ambala approached the Hon'ble High Court by way of filing a Civil Writ Petition i.e. No. 11103 of 2019- Sunita Goyal V/s State of Haryana & others claiming therein promotion from post of Primary Teacher (JBT) to Post of Social Studies Mistress (TGT –SS) w.e.f. 01.01.1996 under statutory provisions of Person with Disabilities Act (i.e. PWD Act), 1995. The writ petition came for hearing before the Hon'ble High Court on 06.02.2020 and the Hon'ble High Court pleased to dispose of this writ petition with following directions:-

“ At this stage, instant petition is disposed of by giving directions to respondent No. 1 to look into the representation dated 10.01.2019 and legal notice dated 12.02.2019 (Annexures P-7 & P-8) and pass appropriate order in accordance with law within a period of four months from the date of receipt of certified copy of this order. It is further clarified that, if a speaking order has already been passed on the legal notice dated 12.02.2019 (Annexure P-8), then only a short order be passed annexing the said detailed order.”

The certified copy of this order received in Directorate of Secondary Education Haryana on 21.05.2020 after expiry of lockdown period. Thereafter, the matter has been considered by the Directorate of Secondary Education Haryana and finding that the sought promotion from post of Primary Teacher to TGT (SS) belongs to this Directorate forward the copy of this order dated 06.02.2020.

After having this order, the grievance of the petitioner as unfolded in representation dated 10.01.2019 and legal notice dated 12.02.2019 has been considered. After due consideration the following facts came into light:-

1. The petitioner joined service on post of Primary Teacher on 17.04.1997, therefore not entitled to claim promotion to post of TGT (SS) w.e.f. 01.01.1996.
2. Prior to PWD Act, 2016, there was no provision to grant promotion to a person with disabilities under statutory rules. Only 10 % posts in promotion cadre has been kept reserved for employees belonging to scheduled caste category. To have promotion in master (TGT) cadre, a Primary Teacher must have an experience of 3 years in his/her credit. Moreover, at that time, the promotion was granted on basis of having requisite educational qualifications and seniority. On the basis of seniority, the name of the petitioner was duly considered and she was granted promotion to post of TGT (SS) vide order dated 27.09.2011. There is no illegality in this order and the petitioner has never impugned this promotion order during her services on post of TGT (SS). She impugned this order after having further promotion on post of PGT (Economics).

3. There is nothing on record or in the representation or legal notice which may prove that any junior under PWD Act has granted promotion earlier to her.
4. It is a settled law that an employee has a right to get his/her name considered for promotion, however, he/she has no locus standi to claim promotion from a fixed date unless and until any junior to him/her is granted promotion.
5. In P.S. Sadasivaswamy v. State of Tamil Nadu AIR 1975 SC 2271, the Hon'ble Apex Court has considered the case where the petition was filed after lapse of 14 years challenging the promotion. However, the Apex Court held that aggrieved person must approach the Court expeditiously for relief and it is not permissible to put forward stale claim. The Court observed as under:-

"2.....A person aggrieved by an order promoting a junior over his head should approach the Court at least within 6 months or at the most a year of such promotion."

Since the petitioner was satisfied with the promotion granted earlier to her w.e.f. 27.09.2011 and she never impugned this promotion within a period of limitation i.e. 3 years, accordingly, the present claim is also found barred under Law of Limitation.

Considering all the facts and circumstances, it has been found that there is no merit in the representation dated 10.01.2019 as well as legal notice dated 12.02.2019. No right of the petitioner has been infringed by the respondents, moreover, she was granted promotion as per rule applicable at that time i.e. in the year 2011. Hence, the relief claimed in the representation as well as legal notice is found untenable; accordingly, the same is declined/rejected.

Order accordingly.


