

In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

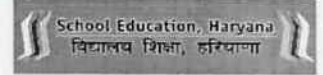

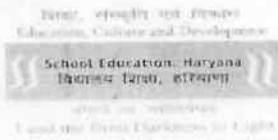

**Order No. 13/20-2020 HRME-I (3) Dated, Panchkula, 17-7-2020**

Whereas, the petitioners have filed the CWP No. 227 of 2020 titled as Mange Ram and another Vs State of Haryana, praying therein issuance of a writ in the nature of mandamus commanding the respondents to consider the case of petitioners and decide the legal notice dated 25.07.2019 (P-5) by passing a speaking order within a stipulated period, as the respondents have not decided legal notice even till date as the respondents as adopted the policy of pick and choose and the senior employees like petitioners have not regularized prior or on the date on which their juniors have been regularized as per seniority list and orders whereby the juniors of the petitioners have been regularized. The said writ petition came up for hearing on 8.1.2020 and the same was disposed of by the Hon'ble High Court by passing the following orders. The operative part of order dated 8.1.2020 is as under:-

**“Without commenting upon merits of the case, this petition at this stage is being disposed of by giving direction to respondent No. 2 to decide the legal notice dated 25.07.2019 (P-5), within a period of six months from the date of receipt of certified copy of this order. The respondent No. 2 shall pass a speaking order thereon after affording opportunity of hearing to the petitioners, failing which, respondent No. 2, shall be liable to pay cost of Rs.25,000/- each to the petitioners.**

**This condition of imposing cost is only to prevent the petitioners to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court**


It is pertinent to mention here that District Education Officers are competent authority for regularizing the services of part-time class-IV employees. Keeping in view the same and in compliance of the order of Hon'ble High Court, directions were issued to all District Education Officers of the State vide letter No. 13/91-2016 HRME-I (4) dated 10.9.2019 to re-examine the cases of regularization of part-time class-IV employees. If they are entitled for regularization, then, consider the claim of them accordingly and if they are not, then, reject their claim by passing the speaking order.

In pursuance of the letter No. 13/91-2016 HRME-I (4) dated 10.9.2019 District Education Officer, Charkhi Dadri has re-examined the case of the petitioners and rejected the claim of the petitioners by passing the speaking order dated 10.6.2020 which is annexed as **Annexure R-I** with this order.

Keeping in view of the above, the claim of the petitioners has been rightly rejected by the competent authority i.e. District Education Officer, Charkhi Dadri.

The claim of the petitioners stands rejected.
