This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.

The school shall follow the course of study as per syllabus prescribed by the affiliated board.

The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.

 That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.

Whereas, the petitioners have filed the CWP No. 227 of 2020 titled as Mange Ram and another Vs State of Haryana, praying therein issuance of a writ in the nature of mandamus commanding the respondents to consider the case of petitioners and decide the legal notice dated 25.07.2019 (P-5) by passing a speaking order within a stipulated period, as the respondents have not decided legal notice even till date as the respondents as adopted the policy of pick and choose and the senior employees like petitioners have not regularized prior or on the date on which their juniors have been regularized as per seniority list and orders whereby the juniors of the petitioners have been regularized. The said writ petition came up for hearing on 8.1.2020 and the same was disposed of by the Hon'ble High Court by passing the following orders. The operative part of order dated 8.1.2020 is as under:-

"Without commenting upon merits of the case, this petition at this stage is being disposed of by giving direction to respondent No. 2 to decide the legal notice dated 25.07.2019 (P-5), within a period of six months from the date of receipt of certified copy of this order. The respondent No. 2 shall pass a speaking order thereon after affording opportunity of hearing to the petitioners, failing which, respondent No. 2, shall be liable to pay cost of Rs.25,000/- each to the petitioners.



This condition of imposing cost is only to prevent the petitioners to run from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court

It is pertinent to mention here that District Education Officers are competent authority for regularizing the services of part-time class-IV employees. Keeping in view the same and in compliance of the order of Hon'ble High Court, directions were issued to all District Education Officers of the State vide letter No. 13/91-2016 HRME-I (4) dated 10.9.2019 to re-examine the cases of regularization of part-time class-IV employees. If they are entitled for regularization, then, consider the claim of them accordingly and if they are not, then, reject their claim by passing the speaking order.

In pursuance of the letter No. 13/91-2016 HRME-I (4) dated 10.9.2019 District Education Officer, Charkhi Dadri has re-examined the case of the petitioners and rejected the claim of the petitioners by passing the speaking order dated 10.6.2020 which is annexed as **Annexure R-I** with this order.

Keeping in view of the above, the claim of the petitioners has been rightly rejected by the competent authority i.e. District Education Officer, Charkhi Dadri.

The claim of the petitioners stands rejected.


