Whereas Randhir Singh & Others approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 28382 of 2013 – Randhir Singh & Others V/s State of Haryana & Others praying therein for issuance of a writ in the nature of certiorari/mandamus directing the respondents to remove the anomaly in pay scale of the post of Head Master, Govt. Middle (Elementary) School by stepping them in the grade pay of Rs. 4800/- (Instead of Rs. 4600/-) w.e.f. 01.01.2006 and further grant them 1st/ 2nd/3rd grade pay of Rs. 5400/-, Rs. 6000/-, Rs. 6400/- on completion of 10/20/30 years regular satisfactory service and further the pay of the petitioner be fixed in the revised pay band of Rs. 9300-34800 with grade pay of Rs. 4800/- w.e.f. 01.01.2006 and further fixed in the 1st ACP Grade of Rs. 5400/- on completion of 10 year regular satisfactory service as Head Master from due dates and grant them all consequential benefits i.e. Pay fixation, arrear of difference of salary alongwith interest @18% from 01.01.2006 till its realization.

The said petition came up for hearing before the Hon'ble High Court on 28.08.2019 and was disposed off with the following directions:-

*"[1] Short grievance of the petitioners is for grant of grade pay of 4800/- instead of 4600/- in the pay band of 9300/- - 34,800/- w.e.f. 01.01.2006 and further for grant of ACP as per rules admissible.*

*[2] Learned Sr. DAG has placed on record copy of decision dated 30.07.2018 on reconsideration of the claim of the petitioners. Relevant extract of the same is reproduced as under:-*

*"1. The functional pay structure of the post of Master (to which post the Petitioners were appointed originally/at the first instance) and that of Elementary School Head Master (to which post they were promoted on account of hierarchical promotion) was revised into PB-II Rs.9300-34800+4600 Grade Pay as on 1.1.2006. In view of the feeder post and promotional post having been placed into same functional pay structure as on 1.1.2006 the functional promotion of the petitioners taken place before 1.1.2006 ceased to be a financial up-gradation and the petitioners accordingly became entitled for consideration of 1st ACP Grade Pay benefit of Rs.9300-34800+4800 Grade Pay u/r 13 of the HCS (ACP) Rules, 2008 as on 1.1.2006.*

petitioner No. 1 to 3, 8 and 9 belong to DEEO Yamuna Nagar and the pay of said petitioners has been re-fixed as well as granted the ACP benefit as per HCS (ACP) Rules, 2008 vide order No. E-2/19/9405 Dated 06.12.2019. The pay of petitioner No. 4 and 6 has been re-fixed as well as granted the ACP benefit as per HCS (ACP) Rules, 2008 vide order No. E-1/20/1752 Dated 26.05.2020 as per information/report received DEEO Karnal. The petitioners at Sr. No. 5 and 12 working as ESHM had already been awarded their pay re-fixed and ACP benefit vide DEEO, Sonapat letter No. E-1/2017/1501 dated 18.08.2017. The petitioner at Sr. No. 7 has been granted 2<sup>nd</sup> ACP with vide order No. 05/35-2017 HRM-II (6) Dated 12.06.2017 and report received from DEEO Kaithal E-1/20/7534 Dated 29.06.2020. The petitioner at Sr. No. 10 has been granted ACP benefit alongwith re-fixation of pay vide DEEO Bhiwani letter No. E-2-2017/1537 Dated 20.07.2017. The petitioner at Sr. No. 11 has been retired and no data is available regarding such petitioner. A number of letters has written to the counsel of the petitioner regarding the detail of the petitioner No. 11 but no information has been received yet. The petitioner at Sr. No. 13 has been granted ACP benefit alongwith pay re-fixation vide order No. 5/55-2019 HRM-III (1) Dated 09.07.2019. The said report/information has been received from DEEO Faridabad vide letter No. E-1/2019/1212 Dated 20.11.2019.

Hence, in compliance of direction issued by the Hon'ble High Court dated 28.08.2019 and as per Finance Department U.O. No. 6/54/2018-4PR(FD) Dated 30.07.2018 the pay of above mentioned petitioners have been re-fixed in 1<sup>st</sup> ACP grade pay of Rs. 4800/- on 01.01.2006 as well as granted 2<sup>nd</sup> ACP grade pay of 5400/- on completion of 20 years regular satisfactory service and granted 3<sup>rd</sup> ACP grade pay of Rs. 6000/- on completion of 24 years regular satisfactory service under rules, 13 of HCS (ACP) Rules, 2008 except the Petitioner No. 11 due to non-availability of data of such petitioner.

Besides above, the case of the petitioners has been examined by the competent authority and it has been found that all the benefits of ACP scale has already been availed by the petitioners. Therefore, in view of the above background and factual position of the case, the claim of the petitioners has already been gratified/fulfilled.

Whereas Sh. Phul Singh Sharma and 78 others who retired from service prior to 01.01.2006 approached the Hon'ble High Court by way of filing a Civil Writ Petition i.e. **CWP No.13590 of 2019- Phul Singh Sharma & others Vs. State of Haryana & others** praying therein for issuance of a writ in the nature of mandamus directing the respondents to release pension to them in the revised pay scales having grade pay. The petitioners further prayed for pension on basis of last pay drawn instead of average of 10 months' pay. The Writ Petition came up for hearing before the Hon'ble Bench on 21.05.2019 wherein the Hon'ble Bench was pleased to dismiss the writ petition with liberty as prayed for. The order passed by the Hon'ble Bench is reproduced as under:-

***"Learned counsel for the petitioners submits at the outset that he be permitted to withdraw the petition so as to enable the petitioners to pursue the matter with the respondent-authorities, for the legal notice dated 23.01.2019 (Annexure P 4), they have been served with, is pending consideration.***

***Dismissed as withdrawn with the liberty prayed for.***

***We are sanguine that if indeed any such representation/ notice is under consideration of the respondent-authorities, the same shall be considered and dealt with in accordance with law within a period of eight weeks from the receipt of certified copy of this order."***

In compliance of this order, it has been observed that the petitioners have already got served a legal notice dated 23.01.2019 which has not been decided till date. After due perusal, it has been found that there are 79 petitioners in total who have retired from service prior to 01.01.2006, the date from which the Haryana Civil Services (Revised Pension) Rules dated 17.04.2009 has been implemented. The petitioners have prayed for two benefits in this legal notice. These two prayers are as under:-

1. The petitioners demanded pension in the revised grade pay;
2. They also demanded that their pension be re-fixed on basis of last pay drawn instead of average of 10 months' pay.

Regarding 1<sup>st</sup> prayer of the petitioners, it has been observed that the Finance Department Haryana vide its **Memo No. 2/23/2016-1Pension(FD) dated 27.05.2019** has already settled this issue by way of granting notional pay fixation benefit to all its pensioners. The operative part of this memo is reproduced as under:-

***"2. The revision of pension/family pension, on the basis notional pay of the pre-2016 Govt. employee, where pay scales have been upgraded/modified by the State Government from time to time, may also be revised w.e.f. 01.01.2016 in the modified/upgraded pay scale instead of corresponding pay scale."***



On basis of these instructions, the pension of the petitioners may already have been got re-fixed and their documents may have been submitted for its approval to the office of Principal Accountant General (A&E) Haryana, Chandigarh for revised pensionary benefits. If the petitioners have not got the revised pension benefits as per these instructions dated 27.05.2019, they may approach their last Drawing & Disbursing Officers (DDOs) to get the revised pension papers prepared and its submission to office of Principal Accountant General (A&E) Haryana, Chandigarh.

In case of 2<sup>nd</sup> relief where the petitioners demanded pension on basis of last pay drawn instead of 10 months' pay average is not found feasible since there is a specific cut-off date of application of Haryana Civil Services (Revised Pension) Rules 2009 notified on 17.04.2009. The Hon'ble High Court has not declared this cut-off date as ultra vires. Moreover, the cut-off date has already been declared intra vires by the Hon'ble Supreme Court of India in its judgment dated 11.08.2005 in **Civil Appeal- State of Punjab & others Vs. Amar Nath Goyal & others**, cited as (2005) 6 SCC 754. The operative para of this judgment is reproduced as under:-

***"37. In the instant case before us, the cut-off date has been fixed as 1.4.1995 on a very valid ground, namely, that of financial constraints. Consequently, we reject the contention that the fixing of the cut-off date was arbitrary, irrational or had no rational basis or that it offends Article 14.***

***38. The learned counsel for the employees have referred to Union of India v. Bidhubhushan Malik and Ors., [1984] 3 SCR 550, All India Judges Assn. and Ors. v. Union of India, (1993) 11 LLJ 776, S C, M.C. Dasai and Ors. v. Union of India, AIR 1981 All 283, M.J. Sivani and Ors. v. State of Karnataka and Ors., [1985] 3 SCR 329, Chairman, Railway Board and Ors. v. C.R. Rangaiahamaiah and Ors., AIR 1997 SC 3828 and Union of India and Anr. v. Pratibha Bonnerjea and Anr, AIR 1996 SC 693. Having perused these judgments, we find that the issue urged before us, which has been considered in the several judgments that we have referred to in detail, has not been adverted to. In our view, these judgments are of no assistance in resolving the issue before us.***

***39. In the result, we set aside the common judgment and order of the High Court of Punjab & Haryana in CWP No. 4995/97 and in connected matters decided thereby, in so far as they purport to grant the revised death-cum retirement gratuity to government employees who died or retired before the prescribed cut-off date of 1.4.1995. We also set aside judgment and orders of the High Court of Himachal Pradesh in CWP No. 462/03 (dated 24.6.2003) and in Civil Review No. 32/2003 (dated 11.9.2003)."***

From Haryana Civil Services (Revised Pension) Rules 2009 which notified on 17.04.2009, it has been made clear that the modified pension rules would be applicable w.e.f. 01.01.2006. Since all the petitioners have attained the age of superannuation prior to 01.01.2006, therefore, the revised pension rules 2009 cannot be made applicable in case of petitioners. The validity of cut-off date in pension cases has already been withheld in a number of judgments by the Hon'ble Apex Court (supra). Accordingly, it has been found that the petitioners cannot be granted benefits of pension on basis of last pay drawn instead of last 10 months' average pay. Hence, the 2<sup>nd</sup> relief claimed by the petitioners is found untenable under statutory provisions, accordingly, the claim for this relief is declined/rejected.

Order accordingly.

Whereas, Hon'ble Punjab & Haryana High Court at Chandigarh vide its order dated 04.03.2020 in CWP No. 6079 of 2020(O&M) titled as Sukhpreet Kaur and another vs. State of Haryana & others, directed the respondents to consider the claim of the Petitioners against the backdrop of a legal notice dated 16.12.2019 (Annexure P-7) by passing a speaking order within a period of two months. The Hon'ble High Court order is reproduced below:

*"Petitioners are aggrieved of the action of the respondent authorities in having denied to them the benefit of promotion to the post of T.G.T (Punjabi) on the ground that they do not possess the qualification of B.Ed.*

*Counsel has referred to the Haryana School Education (Group'C') State Service Rules, 2012 to contend that the petitioners possess the qualifications prescribed therein for promotion to the post of T.G.T(Punjabi) and the condition of possessing B.Ed. qualification is alien to the rules. Further urged that such aspect already stands settled by this Court in a bunch of writ petitions decided on 12.9.2018 in CWP-12143-2016 (Suresh Chander and others Vs. State of Haryana and others) and other connected matters at Annexure P-8 (colly). Counsel further referred to different promotion orders at Annexure P-9 (colly) whereby J.B.T Teachers have been promoted to the post of T.G.T in different subjects without insisting upon the qualification of B.Ed.*

*Petitioners seek parity of treatment.*

*CWP-6079-2020 (O&M)*

*In view of the above and without even ascertaining the correctness of the averments made in the petition, I deem it appropriate to dispose of the instant writ petition with a direction to respondent No.2 to consider the claim of the petitioners against the backdrop of a legal notice dated 16.12.2019 at Annexure P-7 by passing a speaking order expeditiously and in any case within a period of two months from the date of receipt of a certified copy of this order.*

*Disposed of."*

In pursuance of Hon'ble High Court order dated 04.03.2020, the Legal Notice Dated 16.12.2019 (Annexure P-7) of Petitioners has been considered. It has been averred in the legal notice that the Petitioners have been appointed as JBT Teacher in District Sirsa and possess the qualification of Matric with Hindi, Senior Secondary and B.A. with elective subject Punjabi with 50% marks and two year




diploma in Elementary Education (ETT) and hence eligible for the Promotion on the post of TGT Punjabi. In this regard, it is pertinent to mention here that Haryana School Education (Group- C) State Cadre Service Rule, 2012 has notified Service Rules regarding Promotion etc. In these Service Rules, it is clearly mentioned that for promotion to TGT Punjabi, a candidate has to possess the qualification of B.A. with Elective Subject Punjabi, with 50% marks in Punjabi subject, is a compulsory requirement. The Petitioner No. 1 Sukhpreet Kaur fulfils the criteria and hence is Promoted accordingly but in reference to Petitioner No. 2, it is pertinent to mention here that the Petitioner No.2 does not possess 50% marks in elective subject Punjabi which is a compulsory requirement for promotion to TGT Punjabi and it is worthwhile to mention here that the relaxation of 5% could also be not given to the Petitioner No. 2 as the Petitioner No. 2 does not belong to SC/BC/OBC/Differently Abled Candidate and hence could not be promoted.

Hence, the claim of the Petitioner No.1 has been accepted and Promoted whereas the claim of the Petitioner No.2 has been rejected as the Petitioner No.2 does not possess requisite qualification for the promotion to TGT Punjabi.

Accordingly, the claim of the Petitioner No.2 could not be accepted and hence rejected/decline.



In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education Rules, 2003, sanction is hereby accorded to grant permanent recognition to Nav Saraswati High School, Dhatrath, Jind by Managing Committee, Gramin Shiksha Samiti, Dhatrath, Jind for classes 9<sup>th</sup> to 10<sup>th</sup> under BOSE pattern with effect from 01.04.2020 under following terms and conditions:-

**TERMS & CONDITIONS:-**

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
