ORDER

In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education Rules, 2003, sanction is hereby accorded for permanent recognition to Adarsh Sr. Sec. School, Vill. Nandha (Charkhi Dadri) run by Managing Committee, Adarsh Education Society, Vill. Nandha, Tehsil Charkhi Dadri, Distt. Bhiwani for classes 11th to 12th in subjects of (Arts & Science Stream) under BOSE pattern with effect from 01.04.2020 under the following terms and conditions:-

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

ORDER No. 11/126-2019 PGT-III (9)

DATED, PANCHKULA, THE 7/8/2020

Whereas, Sh. Krishan Kumar (Emp ID No.: 210717) PGT/Lecturer (Sanskrit) has filed the CWP No. 31447 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of Certiorari for quashing the impugned transfer orders dated 22.08.2019 (Annexure P-4) and further prayed for staying the reliving order of the petitioner during the pendency of the present writ petition.

The present writ petition came up for hearing before the Hon'ble High Court on 31.10.2019 and the same was disposed of with the following directions to respondents:

"Prayer in the present writ petition is for quashing of impugned transfer order dated 22.08.2019 (Annexure P-4).

Petitioner has been transferred from Government High School, Kumbha, Block Hansi, District Hisar to Government Girls Senior Secondary School, Koth Kalan, Block Narnaund, District Hisar.

The impugned order is dated 22.08.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioner is aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioner within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.

The writ petition stands disposed of with the above direction."

Whereas, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the district in the State. He/she is free to give preferences in order of his/her suitability, and for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone

may seek transfer to some other station. He is asked to give as number of preferences as he/she could to avoid being transferred in "Anywhere in State Category".

As per the direction of Hon'ble High Court representation dated 27.02.2020 of the petitioner was examined where the petitioner had been alleged that he was transferred from G.H.S Kumbha, Hlsar (zone 6) in transfer drive 2019 before completion of his 5 years due to rationalization (post kept) to G.G.S.S.S Koth Kalan, Hisar (zone 7). Further, the petitioner alleged in his representation that now again after completion of transfer drive, said post of PGT Sanskrit has been re-opened in G.H.S Kumbha, Hisar due to workload.

Whereas, in regard to issue of the petitioners being declared as surplus from a station as a part of rationalization/Normalization conducted, it is integral that the process of rationalization/normalization be explained and it is submitted as under:

- a. That enrollment of students varies from time to time in schools and hence demand of teachers also varies correspondingly.
- b. That in pursuance to Teachers Transfer policy, the Government approved rationalization of posts of PGTs w.e.f. academic session 2019-20 and in furtherance of the same certain number of employees (PGTs) was declared to be surplus in number of schools after assessment of teacher student ratio in such schools. So as to attain an optimum teacher-student ratio, process of rationalization was implemented.
- c. That this process of rationalization is followed by process of normalization cum rationing. As the word rationing suggests the available teachers are allotted to the vacant posts to suit the best interest of students. The process of normalization is carried out due to deficiency of available teachers against the total vacant posts. For example, the state education department has 3000 posts against which only has 2000 PGTs. Such 2000 PGTs are transferred/posted to fill the posts where best interest of the students is served and the remaining posts are declared as blocked so that no teacher can opt for such post in the transfer drive
- d. That the teachers declared surplus from a station as a part of rationalization of posts shall compulsorily participate in the transfer drive. In case of their non-participation in transfer drive due to any reason there salary from such posts shall be stopped and the department shall be at liberty to post them at any station across the state in the schools having high deficiency of teachers even though such teachers have not completed a stay of 5 years in a particular school or zone.

After examining the representation of the petitioner, it has been found that he was rightly declared eligible for transfer as the post of PGT Sanskrit in Government High School Kumbha (1289), Block Hansi , District Hisar which was declared as "to be kept vacant" under normalization during General Transfer Drive, 2019 and is still marked as "Normalization kept vacant" meaning thereby, it is not re-opened yet and the contention of the petitioner is wrong and misleading.

Whereas the petitioner had opted to participate in the Transfer Drive, 2019 where the petitioner had obtained a score of 42.7178 and on the basis of his preferences, Sh. Krishan Kumar was allotted his 11th preference whereas 10th preference of the petitioner i.e. Government Senior Secondary School Mirch Pur [1463] , Hisar , Block Narnaund was allotted to PGT namely Surinder Singh who had secured 45.0712 points which is clearly higher than that of the petitioner. Thus, the petitioner has been transferred to Government Girls Senior Secondary School Koth Kalan [1493] , Hisar , Block Narnaund.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provision of the Teachers Transfer Policy, 2016 (as amended on 01.06.2017) and there is no substance in the representation of the petitioner and the same is liable to be dismissed, being devoid of merits.

I pass order accordingly.
