3. यह कि श्री राकेश कुमार, लिपिक के पास मिड-डे मील/ RMSA/प्राईवेट स्कूलज/ एल0ए0/ कम्प्यूटर आपरेटर/ आर0टी0आई0/ कोर्ट केसिज/ नियम-134-A आदि से सम्बंधित चार्ज है। निदेशालय के आदेश क्रमांक 4/78-2016 एच0आर0एम0ई0 (4) दिनांक 15.07.2016 द्वारा श्री राकेश कुमार, लिपिक का स्थानांतरण रा0उ0वि0 हयातपुर में लिपिक के पद पर होने के उपरान्त, कर्मचारी के द्वारा चार्ज दिनांक 29.07.2016 तक सौंपने हेतु की गई प्रार्थना के तहत खण्ड शिक्षा अधिकारी, सोहना के द्वारा दिनांक 20.07.2016 को बाद दोपहर इनको चार्ज सहित (अंडर चार्ज) कार्य भार से मुक्त कर दिया गया। लेकिन दिनांक 20.10.2016 लगभग तीन महीने तक भी श्री राकेश कुमार, लिपिक के द्वारा चार्ज नहीं दिया गया, जबकि उनके समय का मिड-डे मील वर्कर्स का वेतन लम्बित है।

4. दिनांक 23.12.2016 को श्री राकेश कुमार, लिपिक चार्ज देने के लिए कार्यालय में आया तो पूर्ण चार्ज न देकर, मिड-डे मील का आधा-अधूरा चार्ज लेने के लिए श्री अनिल, लिपिक को कहा। लेकिन श्री अनिल, लिपिक के द्वारा पूरा चार्ज देने के लिए कहा गया तो श्री राकेश कुमार, लिपिक ने अनर्गल आरोप लगाना एवं गालियां देना शुरू कर दिया, शोर-शराबा सुनकर खण्ड शिक्षा अधिकारी ने मौके पर आकर श्री राकेश कुमार, लिपिक को पूर्ण चार्ज देने के लिए कहा तो कर्मचारी द्वारा चार्ज देने से मना कर दिया और अपना रिकार्ड अलमारी में बन्द करके कार्यालय से चला गया।”

कर्मचारी द्वारा चार्जशीट का उत्तर दिनांक 9.10.2018 को दिया गया। कर्मचारी द्वारा उत्तर देने उपरान्त दिनांक 5.11.2019 को निजी सुनवाई का अवसर प्रदान किया गया।

कर्मचारी द्वारा दिये गये उत्तर और निजी सुनवाई के दौरान उस द्वारा प्रस्तुत किये गये दस्तावेजों व उत्तर से संतुष्ट न होने व कर्मचारी पर लगाए गए आरोप गंभीर प्रवृत्ति के हैं और उसका आचरण कार्यालय के सुचारु कामकाज के अनुकूल नहीं है। वह झगडालू तथा लापरवाह व्यक्ति है। कर्मचारी ने HCS Rules के तहत स्वयं को कार्यवाही का पात्र बना लिया है। मैं सक्षम अधिकारी होने के नाते श्री राकेश पंवार, लिपिक की दो वार्षिक वेतन वृद्धियां असंचित प्रभाव से रोकने के आदेश पारित करता हूँ।
