

If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, Sh. Narender Singh wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however,made clear to Sh. "............ Before the previous date of hearing on 16.11.2016, all the outstanding reliefs stood extended to three petitioners except Yash Pal Kundu. Thus, qua three of them, the contempt petition has become infructuous.
