On the recommendation of Haryana Staff Selection Commission, Panchkula conveyed vide their Memo No. HSSC/Confid./Recomm/Court Case/2019/730 dated 07.11.2019, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher **Punjabi** (HES-II) (Rest of Haryana cadre) in the Scheduled-1 of Revised Pay Matrix of functional Pay Level 8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time. He is directed to join at the place of posting as mentioned below:-

**Terms and conditions:-**

1. He/She is appointed purely on temporary basis.
2. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt his/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules-2016 as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidates are hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned along with photostate self-attested copies. District Education Officers are directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information/ facts which are detected later on, he/she would be liable for termination of service without any notice.
15. The appointment will be subject to the final outcome of CWP No. 18514 of 2016 & connected petitions pending for adjudication in the Hon'ble High Court and SLP No 25184-25214 of 2018 titled as

Haryana Staff Selection Commission etc V/S Priyanka & Others pending for adjudication in the Hon'ble Supreme Court of India.

16. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
17. They are directed to join their place of posting within 15 days and send the joining report (duly signed by DDO) at [dsepgt1@gmail.com](mailto:dsepgt1@gmail.com), failing which this offer of appointment letter will be deemed to have been withdrawn.
18. The said appointments are purely provisional subject to verification of character and antecedents of the candidate concerned, however, it should be got verified within a period of two months. This relaxation does not confer any right to a candidate to remain in job, if subsequently anything adverse is reported against him/her at later stage as mentioned in Government Instruction No. 52/18/2018-3GSIII dated 07.06.2020.

**ORDER**

NO. 13/19-2020 HRME-II (1)

DATED, PANCHKULA, THE 06/07/2020

Whereas the petitioners namely Smt. Kamla Devi & others had filed CWP No 34135 of 2019 titled as Kamla Devi and others versus State of Haryana & others, wherein the petitioners have prayed **“for issuance of a writ, order or direction especially in the nature of mandamus commanding the respondents to consider the case of the present petitioners and decide the legal notice dated 25.04.2019 (P-5) by passing a speaking order within a stipulated period, and further prayed that the present case is squarely covered under the order dated 04.09.2014 passed in CWP No 18296 of 2014 and order dated 10.01.2017 (P-6) passed in CWP No 14131 of 2015 titled as Mukesh Kumar and others V/s State of Haryana and others and order dated 19.07.2019 (P-7) passed in CWP No 19401 of 2019 titled as Kailash Chand and others V/s State of Haryana and others.”**

The case came up for hearing on 22.11.2019 before the Hon'ble High Court and the same was disposed of with the following order:-

**“Without commenting on the merits of the claim or the entitlement of the petitioners to the relief claimed, the writ petition is disposed of by directing respondent no 2 to consider and decide the claim as made in the legal notice, Annexure P-5 dated 25.04.2019 in accordance with the law after taking into account all aspects of the matter as expeditiously as possible, preferably within a period of three months from the date of receipt of certified copy of this order alongwith copy of legal notice.”**

In compliance of the abovesaid order, department has re-examined the case of the petitioners with the help of the committee constituted according to the guidelines dated 10.09.2019 of the Director Secondary Education in compliance of the order/direction dated 19.07.2019 passed in the related matter i.e. CWP No 16086 of 2019 titled as Pushpa Devi & others V/s State of Haryana & others. After re-examination of the matter, the constituted committee has found that petitioners were appointed against non-sanctioned posts and were listed at Seniority No 191, 195, 212 and 274 respectively, in the seniority list of 2003; prepared by District Education Officer, Sonapat and were regularized w.e.f. 25.08.2014, according to their

eligibility as well as District wise common seniority list made as per regularization policy of 2003.

However, no junior to the petitioners has been regularized in Sonapat District. It is also clarified here that example given by the petitioners in the present writ petition in which they have alleged that some of their juniors i.e. Nafe Singh & Nehru Singh were regularized prior to them do not belong to District Sonapat but belong to another District i.e. District Panipat.

It is also pertinent to mention here that the petitioners of the present writ petition have compared themselves with the petitioners of CWP No 14131 of 2015 titled as Mukesh Kumar & others V/s State of Haryana & others and CWP No 19401 of 2019 titled as Kailash Chand & others V/s State of Haryana & others who belong to another District i.e. District Hisar and Mahendergarh respectively. Therefore, such comparison of the petitioners is not tenable. Moreover, as per regularization policy dated 11.11.2003, ***the District Level common seniority list of part time Class-IV employees shall act only as a reference point for sponsoring the names of the senior most persons for regularization against the regular sanctioned Class-IV posts in the field offices/schools of the Education Department. The cadre of the Class-IV employees will not become a district cadre simply because such a district level common seniority list has been prepared.***

Therefore, as per the above facts the claim sought by the petitioners through legal notice dated 25.04.2019 is not tenable and has been rightly rejected by the competent authority i.e. District Education Officer, Sonapat vide its office order No E-5-20/5510-20 dated 13.03.2020.

Keeping in view of the aforementioned facts, the claim of the petitioners stands rejected.

I order accordingly.


