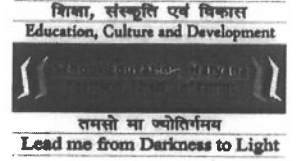



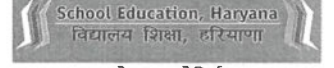

Whereas, Ms. Shalini W/o Sh. Sukhram, (Emp ID No.: 205223) PGT English has filed the CWP No. 27616 of 2019 before the Hon'ble High Court for issuance of a writ in the nature of Mandamus for quashing the impugned transfer order dated 22.08.2019 (Annexure P-10), vide which the respondent department has transferred the petitioner and further for issuing a writ in the nature of Mandamus directing the respondents to adjust the petitioner against the clear vacancy available at the station/places of choices in the district Panchkula given by the petitioner while participating in the transfer drive, 2019.

The above mentioned writ petition was disposed of on 13.11.2019 and the operative part of the order is reproduced as under:

***"Prayer in the writ petition is for the issuance of a writ of mandamus for directing the respondents to cancel and modify the transfer of the petitioner as made vide order Annexure P-10, dated 22.08.2019 from Govt. Girls Sr. Sec. School, Nathusari Kalan, Distt. Sirsa to Govt. Sr. Sec. School, Badhauri, Block Naraingarh, Distt. Ambala and to transfer/adjust the petitioner against clear vacancy available at the station/places of choices as given by the petitioner in District Panchkula while participating in the transfer drive, 2019 on account of the claim of the petitioner being that of couple case and in view of family circumstances.***

***Without commenting on the merits of the claim or the entitlement of the petitioner to the relief claimed, the writ petition is disposed of by granting liberty to the petitioner to file a fresh comprehensive representation. In case of receipt of representation, respondent No. 2 shall consider and decide the same in accordance with law within four weeks from the date of receipt of representation along with certified copy of this order."***

It is pertinent to mention here that, the Government of Haryana framed **Teachers Transfer Policy, 2016** dated 29.06.2016 and the same was amended on 01.06.2017. Thereupon, transfers were made under this amended policy of 2017 to ensure equitable, demand based distribution of

Teachers/Heads to protect academic interests of students and optimize job satisfaction amongst its employees in a fair and transparent manner. Under this policy, all government schools have been categorized into seven zones for the purpose of transfer of teachers and the teacher is eligible to opt any number of schools across the zones available to him, across the districts in the State. He is free to give preferences in order of his suitability. That for the purpose of Transfer Drive, the teachers who have already completed a period of 1 year of service in a particular zone may seek transfer to some other station on the other hand following categories of teachers have been asked to participate in transfer drive compulsorily:-

- a. A post of any cadre held by a teacher previously or presently in the school education department in a regular capacity for a period of 5 years or more on the qualifying date in present zone of posting, shall be taken as a deemed vacancy and such teacher shall compulsorily participate in the transfer drive.
- b. Teachers declared surplus from a station as a part of rationalization /Normalization shall also compulsorily in the transfer drive.
- c. Teachers who have been given temporary manual posting previously due to non-availability of online transfer drive or technical problem or compulsion of.


Apart from the above mentioned compulsory situations, a teacher may also voluntarily opt for the online transfer drive after a stipulated passage of time in a particular zone and the same has happened in the case of the petitioner.

In compliance of the Hon'ble High Court orders dated 13.11.2019, the case of the petitioner has been examined and it is found that she has voluntarily participated in the transfer drive. However, she could not get the opted stations due to her score for purpose of Transfer Policy, 2016 i.e. 47.7534 as per policy and the last preferred station was allotted to another PGT namely Mr. Sandeep Gupta, who obtained score of 48.5151 and thus she was transferred to the anywhere category. It is pertinent to mention here that a

teacher can opt as many stations as he/she want and the same are allotted to them as per the marks obtained by them as per the policy, as well as they have to compete with the other teachers to get a vacant post according to the preference list provided by them. The petitioner was transferred as per the policy with the merit points achieved by her. Moreover, the situation described by the petitioner is not covered by the policy, there is no provision in the policy to provide additional marks to the person whose mother or mother-in-law is suffering from the life threatening disease, but no points to that effect have been awarded as the Teachers Transfer Policy, 2016 does not cover such circumstances, however, the petitioner has been duly awarded 5 points considering that the husband of the petitioner is an employee of U.T. Chandigarh.

In view of the position explained above, it is clear that the petitioner has been rightly transferred as per the provisions of the Teachers Transfer Policy, 2016 as amended from time to time and there is no substance in the representation of the petitioner and the same is to be rejected, being devoid of merits.

I order accordingly.

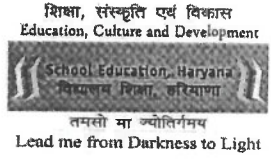





Whereas Vijai Singh & others have filed the Civil Writ Petition No.31065 of 2018 before the Hon'ble High Court of Punjab & Haryana Chandigarh, for issuance of a writ in the nature of mandamus directing the respondents to extend the benefit of re-fixation of pay of the petitioners after restoring the benefits of adhoc relief and DA cut as on 01.04.1979 in terms of the judgment dated 27.07.2000 (Annexure P-8) passed in CWP No. 16084 of 1997 titled as Dharampal Singh Vs. State of Haryana & others, as well as judgment dated 23.04.1990 (Annexure P-6) passed in CWP No. 5563-A of 1989, against which S.L.P.s filed by the respondent-State of Haryana in the Hon'ble Supreme Court of India has already dismissed on 07.12.1995 and 08.12.2015 and further the Finance Department has even issued letters dated 15.03.2017, 16.03.2017, 28.03.2017 & 25.01.2018 (Annexure P-10 to P-13) for implementation of the judgment of the Hon'ble Apex Court dated 08.12.2015 qua the petitioners of those matter and also grant all consequential benefits to the petitioners, in the interest of equity, justice and to avoid discrimination.

The facts of the present case are that the Government of Haryana had granted additional dearness allowances to its employees in the category of Class-II, Class-III and Class-IV w.e.f. 01.05.1973, 01.08.1973, 01.10.1973 and 01.01.1974, as per the Finance Department instruction dated 20.03.1974. A condition was imposed to the effect that "While making payments of additional dearness allowance part of the amount of Adhoc Relief as indicated in columns 5 and 7 of Annexure-I to this letter shall be adjusted."

Thereafter one CWP No. 13300 of 1990 was filed by some employees challenging the condition of adjustment of the ad-hoc relief which was allowed by the Ld. Single judge and the condition No. 3 of the letter dated 20.03.1974 was set aside. Then Government of Haryana has filed SLP No. 2578 of 1996 in CWP No. 13300 of 1990 which was dismissed on the ground of limitation and thereafter revision petition No. 2276 of 1998 was filed and the same was dismissed on the ground of delay as well as on merits.

Thereafter, CWP No. 16084 of 1997 was filed alleging that the juniors to the petitioners were drawing higher pay scale on account of getting the benefit granted to them on the basis of decision of CWP No. 13300 of 1990 hence, the action of the respondent is arbitrary and discriminatory. The claim of the petitioner in CWP No. 16084 of 1997 was that he is entitled to the same benefit as has already been granted to the respondent No. 5 regarding Additional Dearness Allowance as decided by Hon'ble High Court in CWP No. 13300 of 1990. Thereafter, other writ petitions have also been filed and the Hon'ble High Court ordered that the petitioner of CWP No. 16084 of 1997 and other connected petition be granted the same benefit as has been granted to the petitioners of CWP No. 13300 of 1990 with all consequential benefits. However, payment of arrears shall be restricted to 38 months immediately preceding the filing of these writ petitions.




The Government of Haryana has filed SLP which was converted into Civil Appeal No. 8661 of 2009 titled as State of Haryana & others vs. R.K. Gupta & others against the decision passed in CWP No. 4518 of 2000 titled as R.K. Gupta & others Vs. State of Haryana and others vide dated 11.08.2003. The said SLP was dismissed on 08.12.2015.

The Hon'ble High Court decided in the present CWP No. 31065 of 2018 titled as Vijai Singh & others Vs. State of Haryana & others vide order dated 07.12.2018 and operative part of the said order is as under:-

*"By virtue of the instant petition preferred under Article 226/227 of the Constitution of India, petitioners have sought issuance of a writ in the nature of mandamus, directing the respondents to extend the benefit of refixation of pay after restoring the benefits of adhoc relief and DA cut as on 01.04.1979 in terms of judgment dated 27.07.2000 passed in CWP No.16084 of 1997 (Annexure P-8) as well as judgment dated 23.04.1990 (P- 6) passed in CWP-5563-A of 1989 against which SLP's filed by respondent- State of Haryana has already dismissed on 07.12.1995 and 08.12.2015. Further the finance department has even issued letters on 15.03.2017, 16.03.2017, 28.03.2017 & 25.01.2018 (P-10 to P-13) for implementation of judgment dated 08.12.2015 passed by Hon'ble Apex Court qua the petitioners of those matters and also grant all consequential benefits to them.*

*Learned counsel for the petitioners contends that similar relief as has been sought by the petitioner through the instant petition, has already been accorded to the similarly situated persons. Thus, he further submits that petitioners feel satisfied in case a direction is issued to respondents to decide the legal notice dated 18.07.2018 (P-14) in the light of the judgments referred to above, within some stipulated period.*

*Without expressing any opinion on the merits of the case, instant petition is disposed of with a direction to respondents to consider the grievances unfolded by the petitioners in the legal notice dated 18.07.2018 (P-14) and to take a conscious decision by passing a speaking order as per the judgments referred to above in para no.1 of this order, within a period of three months from the date of receipt of a certified copy of this order. In case, petitioners still feel aggrieved by any of the orders passed by the aforesaid authority, they shall be at liberty to have recourse to the other remedies available under law as well as to approach this Court."*





After receipt the judgment dated 07.12.2018, the legal notice of the petitioner was examined according to which the factual position is as under:-

1. The above mentioned condition took away the benefits already granted to the petitioners by way of 1st component of adhoc interim relief of Rs. 15/- to 45/- and 2nd component of adhoc relief of Rs. 7/- to 15/- w.e.f. 01.04.1972 vide Government letter dated 27/29.6.1972, further adhoc interim relief of Rs. 7/- to 10/- w.e.f. 01.12.1972, vide letter dated 19.12.1972.
2. Initially one CWP No. 13300 of 1990 was filed by some employees challenging the condition of adjustment of the adhoc relief which was allowed by the Ld. Single judge and the condition No. 3 of the above stated letter was set aside. SLP(C) No. 2578 of 1996 in CWP No. 13300 of 1990 filed by the State of Haryana was dismissed on the ground of limitation and accordingly Revision Petition (C) No. 2246 of 1998 was also dismissed on the ground of delay as well as on merits.
3. Thereafter, CWP No. 16084 of 1997 was filed alleging that the juniors to the petitioner were drawing higher pay scale on account of getting the benefit granted to them on the basis of decision of CWP No. 13300 of 1990, so the action of the respondent is arbitrary and discriminatory. The petitioner of CWP No. 16084 of 1997 alleged that he is entitled to the same benefit as has been granted to the respondent No. 5 in the matter of grant of Additional Dearness Allowance as decided by Hon'ble High Court in CWP No. 13300 of 1990. Similar claim was also claimed by the other petitioners namely Deewan Chand & others in CWP No. 2757 of 1998 on the basis of the decision in CWP No. 5563 of 1989 decided on 23.08.1990 and the Hon'ble High Court allowed both the writ petitions on 27.07.2000 and ordered that the petitioner of CWP No. 16084 of 1997 and other connected petitions be granted the same benefits as has been granted to the petitioners of CWP No. 13300 of 1990 with all consequent benefits, however payment of arrears shall be restricted to 38 months immediately preceding the filing of these writ petitions. Against the decision rendered in CWP No. 4518 of 2000 which was decided on 11.08.2003, the State of Haryana preferred SLP(C) which was converted into Civil Appeal No. 8661 of 2009 and the same was dismissed on 08.12.2015.
4. Thereafter the office of Chief Secretary with the concurrence of Finance Department issued the instruction for implementations of the orders in CWP No. 16084 of 1997, CWP No. 2757 of 1998 & CWP No. 4518 of 2000 as upheld by the Hon'ble Supreme Court & decided to grant the benefit to the petitioners alone who filed the above stated writ petitions.
5. After going through the above stated facts and the orders referred by the petitioners, the matter is to be looked into context of judgment of Hon'ble Supreme Court in State of Haryana Vs. Om Parkash Sharma & others with connected appeals decided vide order dated 17.02.1993 as referred in the decision of Civil Appeal No. 8661 of 2009. Hon'ble Supreme Court in the above stated case distinguished the cases of the college Lecturers who were not allowed adhoc interim relief and the Government also adjusted/ recovered the amount from the College Lecturers. The Hon'ble High Court as well as the Hon'ble


Supreme Court allowed the writ petition of College Lecturers who were never granted interim adhoc relief, therefore, Hon'ble Court rightly held that the question does not arise for adjustment/ recovery of adhoc interim relief while granting the Additional Dearness Allowance qua them. As far as the cases of other Government employees are concerned, the Hon'ble Supreme Court as well as the Hon'ble High Court accepted the plea of the State Government and recorded findings that action of the State Government in either recovery or adjustment interim adhoc relief does not suffer any illegality, arbitrariness or discrimination. A perusal of the order dated 17.02.1993 passed in case of State of Haryana Vs. Om Parkash Sharma shows that the same decision justify of the action of the Government in adjusting/ recovering interim adhoc relief granted.

6. Similarly as per decision rendered by the Hon'ble Supreme Court reported as (2008) 10 SCC 115; 2013 (6) SLR 629; 2011 (4) SCC 374 decision of the Hon'ble High Court in LPA No. 740 of 2015 (O&M) by taking the plea that as stated above petitioners of CWP No. 40396 of 2018 are not entitled to any relief on merits as well as belated and stale claim cannot be accepted after a delay of more than 4 decades. Even though certain employee have been granted relief by the Hon'ble High Court in the year 2000 as upheld by the Hon'ble Supreme Court on 08.12.2015 as arrears of amount confined to only 38 months prior to filing of the different writ petitions which were filed in the year 1997, 1998 & 2000 respectively and getting a direction from the Hon'ble High Court to decide the legal notice does not provide a fresh cause of action of a time barred stale claim. The claim which the petitioners now claimed in the year 2018 by serving a legal notice, the actual cause of action arose in the year 1973-74, adhoc interim relief granted already deducted/ adjusted amount gives only a right to recovery and the limitation to recover the amount deducted/ adjusted is three years, which lapsed way back in the year 1976-1977. The petitioners cannot be extended the benefit of decision of Hon'ble Supreme Court dated 08.12.2015 as stated in the preceding on account of parity with other employees of the judgment passed by this Hon'ble High Court in the year 2000 & 2003 etc.
7. The Division Bench of Hon'ble High Court in LPA No. 740 of 2015 decided on July 15, 2015 held that the cause of action accrued to the appellant on 3.5.2006, the belated representation of legal notice served on his behalf in the year 2012 and could not have revived the cause of action.
8. However, it is pertinent to mention here that the employees/ retirees of the Transport Department have filed CWP No. 3941 of 2018 in the Hon'ble High Court for issuance of directions to decide the legal notice dated 15.12.2017 in view of judgment dated 11.08.2003 passed by Hon'ble High Court in CWP No. 16084 of 1997, CWP No. 2757 of 1998 and CWP No. 4518 of 2000, which allegedly has attained finality and has also been upheld by the Hon'ble Supreme Court vide order dated 08.12.2015. It has been further prayed for issuance of directions to restore the deduction made from payment of additional Dearness Allowances w.e.f. 01.05.1973 onward alongwith arrears and to quash the deduction/ cut order vide the offering parts of paragraph 3 & 4 of Annexure P-3 in respect of the adhoc relief allegedly paid in excess and to strike down the offending part of definition of the terms existing emoluments with regard to minus excess payment of

ad hoc relief as contained in Rule-3 (d) (II) of the Rules. The Hon'ble High Court while deciding the present writ petition no. 3941 of 2018 decided on 21.02.2018 directed to look into the grievance unfolded by the petitioners in legal notice and to take a conscious decision in accordance with law, Rule & Regulations, particularly in view of the judgment referred above, within a period of 4 months from the certified copy of the order. The said legal notice was also rejected by the Director State Transport being the similar situated case vide order No. 6396-6420 dated 24.09.2018.

9. In view of position explained above, the petitioner of CWP No. 31065 of 2018 is not entitled to claim parity on the basis of decision of Hon'ble Supreme Court dated 08.12.2015. Hence, petitioner claim is liable to be rejected.
