Whereas, Sh. Sonu Kumar and Another, filed C.W.P. No. 31822 of 2019 titled as Sonu Kumar and Others Vs State of Haryana and Others praying therein for issuance of a writ in the nature of Certiorari quashing the impugned promotion order dated 02.08.2018(AnnexureP-5), 9.08.2018(Annexure P-6) and 21.08.2018(AnnexureP-7), wherein petitioners were not promoted to the post of TGT English despite the fact that petitioners are fully eligible as per Haryana School Education (Group C) State Cadre Service Rules, 2012 (AnnexureP-1) dated 11.04.2012 and juniors to the petitioners have been promoted to the post of TGT English w.e.f. 17.07.2018, being illegal and arbitrary.

Further for the issuance of a writ in the nature of mandamus directing the respondents to promote the petitioners to the post of TGT English w.e.f. 17.07.2018 i.e. from the date all other candidates junior to the petitioners have been promoted to the post of TGT English with all other consequential benefits including seniority and fixation of pay.

Further it is also prayed that during the pendency of the present writ petition, 2 posts of TGT English in promotion quota in the respondent department, may kindly be reserved for the petitioners, subject to the final outcome of the writ petition.

The Hon'ble High Court vide order dated 19.11.2019 disposed of the said writ petition with the following orders:

***“At the outset, learned counsel for the petitioners states that the petitioners have served legal notice, Annexure P-12 dated 01.10.2019 in respect of the grievances which are the subject matter of the instant writ petition but the claim made in the legal notice has not been decided till date and that in the circumstances, the petitioners would be satisfied if at this stage the writ petition is disposed of by directing respondent No.2 to***

***consider and decide the claim made in the legal notice, Annexure P-12 dated 01.10.2019 in accordance with law as expeditiously as possible.***

***In view of the innocuous nature of prayer made by learned counsel for the petitioners, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim made in the legal notice, Annexure P-12 dated 01.10.2019 in accordance with law as expeditiously as possible, preferably within a period of three months from the date of receipt of certified copy of this order."***

In compliance of order dated 19.11.2019 of the Hon'ble High Court, legal notice dated 01.10.2019 of the petitioners has been considered. As such in pursuance of the memo dated 27.04.2018, all the petitioners who are possessing the qualification of Matric with Hindi and 2 years Diploma in Education as well as qualification of B.A and B.Ed. and as such are eligible for promotion from the post of JBT teachers to the post of TGT (English) approached the DEEO Rohtak to send their cases for promotion to the post of TGT (English) to the Directorate Elementary Education Haryana.

It is mentioned that vide memo no. 15/09-2018 dated 27.04.2018 office of Directorate of Elementary Education initiated the process of JBT/PRT/HT/C&V teachers to the post of TGT English, Science, Arts, Physical Education, Home Science, Music, Urdu, Sanskrit & Punjabi and as such through letter dated 27.04.2018 instructions were issued to the all DEEOs so as to invite cases for promotion from interested/eligible teachers and process the same as per the instructions and schedule. It is pertinent to mention here that petitioner no. 2 (Smt. Suman), never made any representation in the o/o DEEO Rohtak as such DEEO Rohtak never received her case. However, case of petitioner no. 1 (Sh. Sonu Kumar) has been received by the DDO Jhajjar and as such list of all the teachers for the

promotion to the post of TGT has been sent by the concerned DEEOs to the o/o DEE as on 25.05.2018 vide letter dated 24.05.2018.

As such vide order no. 17/221-2019 HRM-I(2) dated 26.02.2020,

The Petitioner No. 1 has been promoted from the post of JBT Teacher to TGT English w.e.f. 17.07.2018. Also considering the fact that petitioner no. 2 has failed to submit her promotion case by way of representation to the concerned DEEO before the last date of submission i.e. 24.05.2018.

Accordingly the claim of the Petitioner No. 2 have been rejected for promotion as per statutory Service Rules 2012. Resultantly, their names were not detailed in the order of promotion to post of TGT (English).

Considering all facts and circumstances of the case, it is found that the claim for promotion to post of TGT (English) of Petitioner No. 2 cannot be accepted being devoid of merits.



Whereas Sh. Ashish Kumar, age 38 years, approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.29320 of 2019- Ashish Kumar Vs. State of Haryana & others praying therein for issuance of a writ in the nature of certiorari to get quashed impugned order of transfer qua petitioner and further prayed for issuance of a writ in the nature of mandamus directing the respondents to adjust the petitioner back at Government Middle School Daliya (Rewari). The writ petition with C.M. No.18501-CWP-2019 came up for hearing before the Hon'ble Court on 11.12.2019. After hearing the Ld. Counsel for the petitioner, the Hon'ble Court pleased to dispose of the writ petition directing respondent No.2, viz, Director School Education Haryana to consider the representation of the petitioner dated 16.09.2019 on merits and decide the same in accordance with law and norms. The operative part of order dated 11.12.2019 is reproduced as below:-

***"In that view of the matter, this Court finds no grounds to entertain this writ petition and adjudicate upon the merits of the petitioner's grievances at this stage. It is for the authority concerned to apply its mind and take an appropriate decision upon the representation made by the petitioner.***

***The writ petition is accordingly disposed of directing the second respondent, viz, the Director, School Education, Haryana, to consider the petitioner's representation dated 16.09.2019 (Annexure P-4) on its own merits and in accordance with law and take an appropriate decision. This exercise shall be completed expeditiously and in any event, not later than two months from the date of receipt of a certified copy of this order."***

After having this order dated 11.12.2019, the grievance of the petitioner as unfolded in representation dated 16.09.2019 has been considered. After due consideration, it has been decided that the petitioner be granted an opportunity of personal hearing with liberty to put forth all documents in his favour. The petitioner appeared for personal hearing on 12.03.2020 and heard but the petitioner failed to submit concrete defense against the order of transfer.

However, it has been observed that the petitioner was appointed on the post of Physical Training Instructor under C&V Cadre (District Cadre) vide District Education Officer, Sonapat order No.E-2-2010/721-975 dated 06.05.2010. He joined his services at Government Girls Middle School Asadpur Nandnaur (3659), Sonapat. Thereafter, on basis of educational qualifications, the petitioner has been granted promotion in the hierarchy on post of TGT (Physical Education), a State Cadre post vide this Directorate order No.2/1-2018 HRM-II (3) dated 25.07.2018 with condition that the allotment of school and seniority shall be finalized after promotion of all eligible candidates to have promotion in TGT cadre. Thereafter, he was allocated Government Middle School Daliaki (4461), Rewari for joining vide this Directorate order dated 05.09.2018. However, it has specifically been defined in posting order dated 05.09.2018 after promotion that the present posting given hereby is a purely temporary arrangement. Subsequently, the teacher concerned shall have to seek permanent posting through online transfer drive coming soon. So, no request for manual adjustment shall be entertained. The petitioner has kept concealed this order from the Hon'ble High Court knowingly to have undue benefit, hence, he is not entitled to seek equity.

As per condition of appointment letter, the petitioner participated in the transfer drive and preferred various schools to have adjustment. He has been allocated Government Middle School Anandpur (2550), Rewari successfully from his own options. Hence, the petitioner is not found entitled to take a u-turn after

having adjustment at his opted school. The present representation dated 16.09.2019 is found barred under law of estoppel by conduct.


However, while making this representation, the petitioner has ignored this fact that he is no more an employee of District cadre post. After having promotion on the post of TGT (Physical Education), he is an employee of State cadre post under statutory provisions of Haryana School Education (Group-C) State Cadre Service Rules, 2012. The employer has a prerogative under Rule-12 (1) of these Service Rules, 2012 to assign posting to petitioner as TGT (Physical Education) elsewhere in Haryana. The first posting of the petitioner on the post of TGT (Physical Education) was also in District- Rewari and after transfer order dated 06.09.2019, he has still been allocated place of posting in the same District i.e. Rewari. There seems no injustice against petitioner in this transfer order. Hence, the transfer order is valid and legal one.

However, the law regarding transfer has already been settled down by the Hon'ble Supreme Court of India in a number of judgments. However, recently in Union of India & Ors. Vs. Muralidhara Menon & Anr. decided by Hon'ble Supreme Court of India on 04.08.2009, it has been observed as under:-

***"17. It is not a case where the service conditions of the first respondent is governed by any statute or statutory rules. Transfer as is well known is an incident of service. An employee has no right to be posted at a particular place. He, in law, cannot exercise his option to be posted in his home State unless there exists any statute or statutory rule governing the field. Some policy decision was required to be taken presumably because a large number of requests were being received from the concerned employees. It has not been contended that the said policy decision was illegal. Even if the said policy decision was illegal, first respondent cannot continue to remain posted in the State of Kerala. He may be asked to go back to his original posting, namely at some place which forms the part of Gujarat Charge."***

Keeping in view the above explained circumstances, it is concluded that there is no injustice with petitioner in this transfer. Moreover, he has been allocated school for posting on his own choice/option. Accordingly, the representation dated 16.09.2019 is found devoid of merits. Hence, the relief sought in this representation cannot be granted.



Whereas Smt. Neelam approached the Hon'ble Punjab & Haryana High Court by way of filing a Civil Writ Petition i.e. CWP No. 33224/2019 – Neelam V/s State of Haryana & Others praying therein inter-alia for issuance of a writ in the nature of certiorari for quashing the impugned orders dated 06.09.2019 (Annexure P-5) and dated 15.09.2019 (Annexure P-6) vide which the petitioner has been transferred by acting in an arbitrary, illegal, unjust and unfair manner and in total contravention of the Teachers Transfer Policy dated 29.06.2016 (P-1) and Amended Policy dated 05.06.2017 (P-2) as explained in detail in the present writ petition.

The said petition came up for hearing before the Hon'ble High Court on 22.11.2019 and was disposed of with the following directions:-

***[1] Prayer in the writ petition is for quashing of Orders (Annexure P5) dated 06.09.2019 and (Annexure P-6) dated 15.09.2019, whereby the petitioner who was working as TGT/Master (Social Studies) at Government High School, SatrodKalan was transferred to Government Middle School, Guniana, Block Nissing at Chirao, District Karnal.***

***[2] Learned counsel contends that the petitioner who is suffering from medical problems, besides has son, aged 08 years and daughter, aged 12 years and mother-in-law suffering from cancer had given 53 preferences in the transfer drive held by the Department during the period 31.08.2019 to 04.09.2019, but none of the preferences given by the petitioner were accepted and she was transferred to a station other than a station of her choice.***

***[3] Learned counsel contends that the petitioner submitted a representation (Annexure P-7) dated 07.09.2019 on Sugam Portal, praying for being given a posting at one of the 53 preferences, submitted by her but no decision has been taken in respect thereto, till date and the petitioner would be satisfied, if the writ petition is disposed of at this stage and respondents are directed to consider and decide the representation (Annexure P-7) dated 07.09.2019 sympathetically and in accordance with law, as expeditiously as possible.***


***[4] Without commenting upon the merits of the case and in view of the innocuous nature of the prayer, made by learned counsel for the petitioner, the writ petition is disposed***

***of by directing respondent No.2 to sympathetically consider and decide the claim of the petitioner, keeping in view the factual position regarding the health of the petitioner, her mother-in-law, as also of her having two small children, in accordance with law, as expeditiously as possible, preferably within a period of 02 weeks from the date of receipt of certified copy of the order”***

In compliance of this order dated 22.11.2019, the case of petitioner has been examined by the competent authority. It has been found that the petitioner has completed 6 years 7 months and 14 days in Zone 2. It has been found that the petitioner participated in transfer drive on 06-09-2019. The petitioner had opted schools in Zone 1,7,6,5,3 and 4 at her preferences. On 06.09.2019 the petitioner was transferred from GHS SatrodKalan, Hisar (1328) Zone 2 to GMS Guniana ,Karnal (1819) Zone 7. The petitioner has allotted in anywhere category.

Thereafter, the Petitioner participated in the grievance drive. The Petitioners had opted schools in the grievance drive on 15.09.2019. The Petitioner had opted 18 schools in the 2<sup>nd</sup> drive, out of which she has been successfully allocated in the preferred school i.e. Government Middle School Guniana, Karnal (1819), [Zone7] Nissing at Chirao.


At this juncture, it is pertinent to mention that the paramount object of transfer policy was to provide adequate teachers at every school for the welfare of children. For this purpose, the whole transfer system was made. In MIS Portal, the details have to be filled by the petitioner herself and the medical grounds which the petitioner has availed in the writ petition has to be mentioned in the MIS Portal. The marks regarding the medical are included in the transfer policy. The whole system of transfer is online and the transfer is made according to details provided by the petitioner.

 Vide order dated 22.11.2019 Hon'ble High Court directed to consider matter of petitioner on sympathy ground. In this regard, it is stated that the whole transfer policy was made after keeping each and every aspect of the teacher's circumstances. At this moment, it is not possible for the undersigned department to revoke back the transfer order merely on the sympathy ground as it would cause undue hardship for the under signed department and other employees.

At this juncture, it is also pertinent to mention that while drafting teacher transfer policy the medical and other family issues have been kept into consideration and provisions for extra marks are provided in the policy.

In view of the above facts, the case of petitioner has been examined by undersigned, being the competent authority and it has been found that the petitioner is not entitled for the above said claim because she has been successfully allotted/transfer in the one of her preferred option in the grievance drive. Also, no relief on sympathy ground is possible at this moment. Therefore, in view of the above background and factual position of the case, the claim of the petitioner is declined/rejected.
