- The officials will be relieved immediately and in any case within 3 days failing which he/she will be liable for disciplinary action.
- No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.
- The condition that official has not been joined previous transfer place of posting is implemented on Cancellation Order.
- The official will be update their profile in MIS Portal when he/she join/relieve from his present working station and also supply the information to the Directorate.
- Concerned DDO is also requested to update and approved MIS data of the official at your own level.

ORDER

No. 16/185-17 PGT-III(2)



Whereas, a complaint was received from DEO, Kaithal on 25.10.2017 against Sh. Sanjeev Kumar, PGT English, that he wrote obscene and vulgar language on the note book of the girl student of 10+2 class. The whole matter was investigated by an inquiry committee constituted at the school level wherein, they enquired the matter and concluded that it is a matter of sexual harassment of girl student by a teacher namely Sanjeev Kumar and allegations were proved against him. Further, an FIR No. 149 dated 24.10.2017 was registered under section 506 IPC and u/s 10 and u/s 12 of POCSO Act against Sh. Sanjeev Kumar to which he was charge sheeted under Rule-8 on 13.02.2018. A criminal case is also pending against him in the court of Additional Sessions Judge, Kaithal and remained in imprisonment (judicial custody) from 12.03.2018 to 23.05.2018 and in pursuance of that accused was suspended from 12.03.2018 (deemed date) as per Government order dated 31.01.2019. It is evident from the said FIR that accused is habitual of writing such offensive language on the note book of said victim girl. It is important to mention that there are serious allegations against Sh. Sanjeev Kumar as the act of accused amounts to use the responsible position of teacher to malign the image and reputation of educational institution. Therefore, in order to safeguard the prestige and goodwill of institution, strict action is required to be taken against accused to curb such mal practices and to uphold the prestige of noble and pious institution.

Keeping in view the facts & circumstances mentioned above, it is observed that this is a clear-cut case of moral turpitude as he played with the future of girl student in his school. No leniency or mercy needs to be shown to such a mischievous, unscrupulous & morally corrupt employee. Further, it would not be appropriate to hold inquiry at this moment in this case as it is not in the interest of students, school & educational fraternity at large, to keep Sh. Sanjeev Kumar, PGT (English) in service. The provisions of Article 311 (2) (b) of the Indian Constitution also provide that any person who is the member of civil or state services may be dismissed or removed without holding inquiry "*Where the authority empowered to dismiss or remove a person or to reduce him in rank is satisfied that for some reason, to be recorded by that authority in writing, it is not practicable to hold such inquiry*";

Therefore, the Governor of Haryana is pleased to order that it is not reasonably practicable to hold inquiry in this case. Accordingly, Sh. Sanjeev Kumar, PGT (English), GSSS, Kawatran (Kaithal) is dismissed from service with immediate effect invoking the powers provided under Article 311(2)(b) of constitution of India.

It is ordered accordingly.
