Whereas Sh. Ramesh Kumar (ID No.011763), age 48 years, PTI, Govt. High School, Mehchana (694), District- Gurugram approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.33204 of 2019- Ramesh Kumar Vs. State of Haryana & others praying therein for issuance of a writ in the nature of certiorari to get quashed order of transfer whereby he has been transferred from Govt. Middle School Chhilarki (5849) to Govt. High School, Mehchana (694), District- Gurugram in violation of provisions of Teachers Transfer Policy, 2016 as he has not completed the requisite period of 5 years of stay at Govt. Middle School Chhilarki. This writ petition came for hearing before the Hon'ble High Court on 16.11.2019 and the Hon'ble High Court pleased to issue directions as under:-

"At the very outset, learned counsel for the petitioner states that the petitioner has submitted a representation against his transfer from Govt. Middle School, Chhilarki, Block Pataudi, District Gurugram to Govt. High School, Mehchana, Block Farukh Nagar, District Gurugram, vide order Annexure P/6 dated 06.09.2019, on the sugam portal but the same has not been decided till date and that in the circumstances the petitioner would be satisfied if at this stage the writ petition is disposed of by directing respondent No.2 to consider and decide the aforementioned representation, in a time bound manner."

In view of innocuous nature of the prayer made by learned counsel for the petitioner, the writ petition is disposed of by directing respondent No.2 to consider and decide the representation referred to above, as expeditiously as possible preferably within four weeks from the date of receipt of certified copy of this order along with copy of representation submitted by the petitioner on sugam portal."

After due perusal, it has been observed that the petitioner was rendering service at Govt. Middle School Chhilarki (5849), District- Gurugram where the number of enrolled students in three classes (6th, 7th & 8th) decreased to 5, 7 and 3 students respectively. Having so less number of students, the post of PTI was

rationalized on basis of workload. Four other teachers are still working in this school. It has also been observed that he has been allocated first choice of his options for posting. Moreover, the employer has a prerogative under Rule-12 (1) of the Haryana School Education (Group C) State Cadre Service Rules, 2012 to appoint an employee elsewhere in Haryana. Since the petitioner is rendering service on post of PTI, a District Cadre post and allocated new posting in the same District, no injustice with him is made out.

Moreover Teacher Transfer Policy 2016 also provides for the transfer of a teacher on completion of five years in a particular school. For the sake of the convenience, the Clause 6 is reproduced hereby as under:

“6. Unless protected under a provision of this policy, every teacher completing 5 years stay/tenure in a particular school/zone of any district(s), whether independently in a district or cumulatively of more than one district, of the State shall be transferred”.

It is pertinent to mention here that although the teacher has right to stay for five years in a particular school/zone but this criteria does not provide absolute right to the teacher against transfer and is subjected to rationalization, teacher-student ratio and surplus of vacancy etc as the above mentioned clause itself starts with “unless protected”.

Also, it has been mentioned in the representation that as per Policy in para no.9 sub para (x) issued by the Government, minimum stay is 3 years for seeking transfer, but Petitioner has not completed even 2 years in the school, in this context it is pertinent to mention here that this clause is for the volunteer participation in Transfer Drive by the teacher. The para no.9 sub para (x) of the Transfer Policy is reproduced bellow:

(x) Minimum stay for seeking transfer shall be three years.


It is also pertinent to mention here that there is a policy of the Government regarding transfer i.e. Teachers Transfers Policy, 2016 (Amended as on 01.06.2017). The relevant part of the policy regarding the transfer is at Serial No. (xi) and (xii) is here under:

“(xi) In grave administrative exigency, the department shall be at liberty to post any teacher at any station across the state.

(xii) Teachers declared surplus from a station as part of the rationalization of posts shall compulsorily participate in the transfer drive. In case of their non-participation in transfer drive from any reason their salary from such posts shall be stopped and the department shall be at liberty to post them at any station across the state in the schools having high deficiency of teachers."

Thus the transfer of Petitioner is due to the rationalization of the post and nothing has been done beyond the Transfer Policy 2016. He has rightly been directed to opt school for his adjustment under this online process of posting. There seems no injustice with him in this transfer order as he has been allocated posting at his first choice in District- Gurugram. The present transfer has been done due to rationalization as per the Teacher Transfer Policy. The representation has been found devoid of merits, accordingly, the relief sought therein cannot be granted.



Whereas Smt. Pushpa Khurana & 2 others approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.31739 of 2019- Pushpa Khurana & others Vs. State of Haryana & another praying therein for issuance of a writ in the nature of certiorari to get quashed impugned order of transfer dated 06.09.2019 where they have been transferred. The petitioners further prayed for issuance of a writ in the nature of mandamus directing the respondents to re-shuffle transfer drive after unblocking all the sanctioned posts of teachers as per RTE Act, 2009 and provide another opportunity to petitioners for fresh option. This writ petition came for hearing before the Hon'ble High Court on 02.11.2019 and the Hon'ble High Court pleased to issue directions as under:-

"Prayer in the present writ petition is for quashing of impugned transfer orders dated 06.09.2019 (Annexure P-2 colly).

The impugned orders are dated 06.09.2019, thus, it would not be appropriate for this Court to break cycle of transfers. In case, petitioners are aggrieved, shall be at liberty to make representation or upload objections, if any, on MIS portal. In case such objections are taken or already submitted, respondents are directed to dispose of the same after affording opportunity of hearing to petitioners within a period of one month from the date of receipt of certified copy of this Court by passing a reasonable speaking order in accordance with transfer policy.

With aforesaid direction, the writ petition stands disposed of."

After having certified copy of this order, the petitioners have been granted opportunity of personal hearing on 27.02.2020. They appeared in person and heard.

The petitioners have prayed the Hon'ble High Court to issue directions to unblock the sanction posts of Hindi Teacher whereas the true fact is that on implementation of Right to Education Act 2009, the posts of Elementary School Level Teachers e.g. Middle School Headmaster, Masters (TGTs), C&V Teachers etc. have been rationalized on the basis of workload. The petitioners have concealed this fact that their workload has been reduced from five classes (i.e. 6th-10th) to three classes (i.e. 6th-8th), resultantly, the sanctioned posts have also been got reduced. A specific order of rationalization of posts has already been notified by the Department after having advice from Finance Department Haryana vide its memo No.4/33-2011 SE (4) dated 14.03.2012. In this order, due to reduction of workload, the number of posts of Hindi Teacher has been reduced from 4907 to 2115. At present, the number of working Hindi Teachers is surplus. The Govt. of Haryana, being a welfare and democratic Govt. has accommodated the surplus Hindi Teachers against post of TGT Sanskrit. The petitioners have concealed this fact, accordingly, not entitled to any equitable relief claimed in the representation.

It is also pertinent to mention here that there is a policy of the Government regarding transfer i.e. Teachers Transfers Policy, 2016 (Amended as on 01.06.2017). The relevant part of the policy regarding the transfer is at Serial No. (xi) and (xii) is here under:


***“(xi) In grave administrative exigency, the department shall be at liberty to post any teacher at any station across the state.
(xii) Teachers declared surplus from a station as part of the rationalization of posts shall compulsorily participate in the transfer drive. In case of their non-participation in transfer drive from any reason their salary from such posts shall be stopped and the department shall be at liberty to post them at any station across the state in the schools having high deficiency of teachers.”***

It has also been considered that the Classical & Vernacular Cadre of teachers has already been declared a diminishing cadre by way of notifying new Service Rules, 2012. Further, under Rule-9(5) of these Service Rules 2012, all vacant posts of C&V Cadre teachers have already been got converted in TGT Cadre, accordingly, the teachers rendering service under this cadre have only limited choice of posting i.e. a school where identical teacher of C&V cadre has been rendering service. A kind consideration of transfer order dated 06.09.2019 would reveal itself that the petitioners have been transferred against another Hindi Teacher as the petitioners have been rendering service on post of Hindi Teacher. The Petitioners have concealed this fact from the Hon'ble High Court, accordingly, not found entitled to have any equitable relief.

It has also been observed that under Rule-12(1), the Govt. of Haryana has a prerogative to appoint an employee (teacher) elsewhere in Haryana. Moreover, being a District Cadre employee, the petitioners have been allocated new schools in the same district i.e. Palwal on their choice in the transfer drive. The petitioners failed to rebut this fact. Accordingly, their submissions against the impugned transfer order have been found devoid of merits.

Accordingly, it has been found that the petitioners have concealed true facts regarding the reasons of their transfer i.e. administrative grounds. They have rightly been transferred and allocated new schools on their choice. There seems no injustice with them in this transfer order. The representation made by the petitioners has been found devoid of merits, accordingly, the relief sought therein cannot be granted.

Whereas Sh. Vijay Kumar (ID No.086299), age 56 years, TGT Physical Education, Govt. High School, Bisoha (2624) Block Nahar, District- Rewari approached the Hon'ble High Court by way of filing a civil writ petition i.e. No.34362 of 2019- Vijay Kumar Vs. State of Haryana & others praying therein for issuance of a writ in the nature of certiorari to get quashed order of transfer whereby he has been transferred from Govt. Middle School Bahala Block Nahar (2625) (Zone -6) to Govt. High School, Bisoha Block Nahar (2624) (Zone- 5), District- Rewari, in violation of provisions of Teachers Transfer Policy, 2016 and to direct the petitioner back to his earlier place of posting. This writ petition came for hearing before the Hon'ble High Court on 26.11.2019 and the Hon'ble High Court pleased to issue directions as under:-

“At the outset, learned counsel for the petitioner states that the petitioner has filed representation Annexure P-4 dated 16.09.2019 against impugned transfer order Annexure P-3 dated 06.09.2019 but the representation has not been decided till date and that in the circumstances, petitioner would be satisfied, if the writ petition is disposed of by directing respondent No.2 to consider and decide the representation Annexure P-4 dated 16.09.2019 in accordance with law as expeditiously as possible.

Without commenting upon the merits of the case and in view of the innocuous nature of the prayer made by learned counsel for the petitioner, the writ petition is disposed of by directing respondent No.2 to consider and decide the representation Annexure P-4 dated 16.09.2019 in accordance with law.”

After due perusal, the representation of the Petitioner is considered and it has been found that the petitioner was transferred according to the Teacher Transfer Policy 2016. The post of the petitioner was rationalized on the basis of workload in the school. It has also been observed that he has been allocated first choice of his options for posting. Moreover, the employer has a prerogative under Rule-12 (1) of the Haryana

School Education (Group C) State Cadre Service Rules, 2012 to appoint an employee elsewhere in Haryana.


